RE: House Bill 1399

Chairperson Longmuir and Members of the Committee,

This is my written testimony in favor of House Bill 1399 and ask the committee submits a DO PASS vote. I am the State's Attorney for Ward County and have been a prosecutor for 27 years.

This bill seeks to amend NDCC 31-01-16, Compensation and milage and travel expenses of witnesses.

Legislative history on the statute. According to WestLaw, this section of statute was last amended in 2019. Prior to 2019 the statute provided that the Attorney General shall pay all witness fess and expenses for criminal cases in District Court. The amendment in 2019 capped the amount the Attorney General paid to \$25,000 per county per biennium.

31-01-16 mandates all witnesses be paid \$25/day necessarily in attendance for District Court, and also that all milage and travel expenses are paid. This \$25 witness fee is for all appearances a witness may be subpoenaed to appear. That could include preliminary hearings, motion hearings, bond hearings, sentencings, or other matters, as well as trials.

Legislature sets the amount that is paid for mileage as well as per diem for meal reimbursement.

I am attaching PDF spreadsheets for the actual expenditures Ward County had for witness fees and expenses for 2023 and 2024. As you can see, \$25,000 per biennium was not sufficient for even the first year.

I'm certain you have heard from other law enforcement stake holders that crime has not gone down. You also have been told the costs have not gone down. Costs for mileage, meals, lodging and other travel such as flights have all increased.

The first change the NDSAA is seeking for your consideration is to increase the biennium amount to \$30,000 per county per biennium. This would be an increase of \$265,000 per biennium, or \$132,500 per year.

The second amendment the NDSAA is seeking, is for legislature to gives counties (State's Attorneys) the specific authority to enter into agreements with each other to use another County's

unused reimbursement funds, this agreement would be in writing and approved by the the Attorney General. This change is specifically requested because the current statute does not have this provision. A few years back I had sought to be able to use funds from another county, the AG at that time opined we could not enter into such an agreement because there was no specific statute authority allowing it.

There was discussion amongst the NDSAA regarding this change. One suggestion had been to revamp the system to be based upon population or caseload formula. Ultimately the group agreed upon the above changes rather than a formula-based reimbursement plan.

One reason for this, is due to smaller counties being placed at risk. Currently every county has the same amount available. If a small county ends up with a big case, they have the full amount available to them. If that changed to a formula-based reimbursement, a smaller county could end up being short and stuck with a significant bill. Even bigger counties have that issue currently, as you can see for Ward County in one biennium. Also, by having a set amount for the reimbursement for each county, for budget purposes that amount is definite, rather than fluid each biennium. For budgeting purposes, by state Legislature and Counties, that makes it easier.

Example – currently Ward County has used up all the funds available for reimbursement. During the 2025 budget cycle I was aware of this and knew I had to budget for witness fees at least up to when the new biennium would start. Knowing that I had our trial calendars pulled, as well as looked at open cases that would likely be set for trial during that time.

One case I knew was scheduled for this year, before the new biennium is a 3-week murder trial. This trial also involves a change of venue. Ward County will be paying witnesses mileage to another city, as well as witness fees and per diem meals, that ordinarily would only receive the witness fee. For that one case I budgeted \$40,000.00 for witness expenses. – what I didn't factor in was hotel rooms, I'm hoping there isn't a blizzard, so I don't end up paying additional expenses. Change of venue is not the norm for most cases. But it isn't unheard of either. We had another murder case where the court granted a change of venue in 2024. The witness costs for that trial were over \$17,000. Having the ability to ask another county for unused witness reimbursement funds would aid in deflecting these mandated costs.

We live in a time when people are transient. Witnesses move, defendants move. It isn't unusual for a defendant to have cases in multiple counties. Cases take a long time to go through the system to finally get to trial. Bigger cases, such as murder cases easily take two years from the time of arrest. These are cases that have significant government and society interest, not just for one specific county. That is why having the ability to share unused reimbursement funds is warranted rather than individual counties having to bear the costs when they go over. As you can see from my attachments, all costs still will not be covered, but it will help.

I am currently serving as the Mountrail County State's Attorney, and have been in that position since November 1, 1985. During that time, I have tried several felony cases to juries, and also felony cases before a judge. In each of those cases, it is imperative that any witness(es) to the crime be present to give their testimony regarding the events that occurred.

HB 1399 is a well-thought out plan that would allow Counties in the State of North Dakota to cooperate amongst themselves to insure that monies appropriated according to the provisions of N.D.C.C. §31-01-16 are available for use within a biennium, even when a county has already "used up" their allocation.

As we know, crime has no season and criminal felony jury trials cannot be predicted with any certainty. HB 1399 allows for flexibility, while remaining true to the intent of N.D.C.C. §31-01-16.

Thank you for your time, and again I would request a **DO PASS** recommendation from this Committee on HB 1399.


Chairman Klemin, Vice-Chair Vetter, and Members of the House Judiciary:

The North Dakota State's Attorneys' Association (NDSAA) is submitting this letter asking for a **DO PASS** on House Bill 1399. This Bill was sponsored by Chairman Klemin at the request of our Association.

Currently, each of our counties is allotted \$25,000.00 from the Attorney General for witness reimbursement. In larger counties, this budget is expended very quickly while some smaller counties may never use even a dollar of their budget. Our proposal would, first, increase the allotted amount to \$30,000.00 as this allotment has not been increased in a number of years. Second, it would allow our counties to enter into an agreement with each other to share unused funds with the approval of the Attorney General. For larger counties (like Ward County) that use up their budget every year, this would allow them to work with the counties that aren't using their budget to move their appropriation over. Additionally, for smaller counties, the benefit is that while they may not annually use much of their allotment, should a large case arise, they may need to access these funds and allowing them the opportunity to share with another county is in the best interests of all our citizens.

We appreciate your time and consideration and ask that you issue a **DO PASS** on House Bill 1399.

Mr. Chairman and Members of the House Political Subdivisions Committee. I am Lawrence R. Klemin, Representative for District 47 in Bismarck. I am here to testify in support of House Bill No. 1399. This bill relates to the compensation, mileage and travel expenses for prosecution witnesses in the counties.

The Attorney General maintains a fund to pay for prosecution witness expenses. The law currently sets the amount for these expenses at \$25,000 per county per biennium. Counties pay the expenses and then request reimbursement from the Attorney General. The bill proposes to increase that amount to \$30,000 per county. There is a fiscal note prepared by the Office of the Attorney General that shows the total amount at \$265,000 per biennium with the increase to \$5,000 per county.

The amount that a county spends on prosecution witness expenses varies from county to county. Some counties with larger populations spend more than the allocated amount than counties with smaller populations. The bill allows a county that needs more money for these expenses to enter into an agreement with another county to obtain its uncommitted funds, subject to the approval of the Attorney General.

Roza Larson, State's Attorney for Ward County, is available to tell you more about the county prosecution witness expenses and how the reimbursement process works.

I urge you to recommend "do pass" on House Bill No. 1399.
