- 8 Executive branch agencies and the judicial branch may not submit a legislative bill for
- 9 introduction to the legislative assembly-until the first legislative filing deadline for legislators. The
- 10 legislative council shall provide notice of the deadline to executive branch agencies and the
- 11 judicial branch in December of each even-numbered year.
