My name is Austen Schauer, District 13, West Fargo.

House Bill 1408 is a major change in North Dakota government.

HB 1408 calls for annual sessions beginning in 2027.

This bill represents a proactive approach to modernizing our legislative process while preserving the integrity of our existing framework.

### Here are the objectives of this bill.

1. HB 1408 would enhance fiscal and economic responsiveness by our legislature in terms of decision making.

More frequent legislative sessions will allow us to better manage the state budget, respond to economic shifts in realtime, and provide necessary adjustments without delays.

### 2. HB 1408 maintains the 80-Day Legislative Limit.

This bill does not increase the total number of legislative days. Instead, it strategically distributes the existing 80 days over two years, ensuring efficiency without extending government operations.

### 3. HB 1408 responds to term limits.

This will increase the effectiveness of policy decisions and reduce rushed legislation.

# 5. HB 1408 will help attract high-quality legislative candidates.

By implementing annual sessions, we provide greater flexibility and accessibility for individuals who wish to serve while still actively employed.

Instead of four months every two years, it would be two-plus months each year.

**HB 1408** is more than a change in our meeting schedule. It's a strategic step toward more **effective governance**.

It ensures North Dakota remains competitive, responsive, and well-prepared to meet the evolving needs of our citizens and economy.

By granting legislative management the flexibility to determine the structure of annual sessions, this bill enhances adaptability and efficiency in lawmaking.

### Testimony in Support HB 1408 — with Recommendations

Chairman and members of the committee,

My name is Ben Kappel, a lifelong North Dakotan, real estate professional, and someone who hopes to serve this great state in elected office one day. I'm writing in **general support of House Bill 1408**, which proposes an annual legislative session structure. I believe this bill moves us in the right direction by encouraging a more responsive, agile legislature that can address emerging challenges in real time, rather than waiting two years for the next opportunity.

That said, I offer this testimony not only in support, but with a few **critical concerns and constructive recommendations**.

### **Balance Responsiveness with Responsibility**

While annual sessions may improve responsiveness, they must not lead to **legislative bloat**. North Dakota is a **majority-Republican state**, and our party stands for **limited government**. That principle should not be abandoned simply because we're meeting more frequently.

There must be intentional guardrails to ensure we are not doubling the number of bills introduced simply because we meet twice as often. **More time should not mean more legislation**, especially when much of it is duplicative or unlikely to pass.

### **Stop the Endless Reintroduction of Failed Bills**

One major concern is the **recycling of legislation**. Annual sessions could unintentionally become an avenue for special interests — often from out of state — to **resurrect failed or unpopular bills**, hoping that the public isn't watching as closely the second or third time around.

Take, for example, the repeated proposals to change **time zones or daylight saving time**. These bills come back year after year, despite widespread public confusion and concern. Do we need to stress our constituents annually with the same controversial topics that have already been decided?

We must consider incorporating **a cooling-off period or reintroduction limits** for bills that have failed decisively, especially if they carry no significant new data or public demand.

### **Reduce Public Stress and Protect Trust**

When the legislature is in session, the public pays attention — and feels the stress. Our residents worry about how proposed laws will affect their schools, jobs, healthcare, and personal lives. We owe them a process that is streamlined, thoughtful, and respectful of their peace of mind.

Increased frequency should not mean **increased anxiety**, and that's something we, as future and current public servants, need to take seriously.

In closing, I believe HB 1408 has great potential — but only **if paired with reforms** that protect transparency, reduce redundancy, and uphold our conservative values of small, effective government. Let's make North Dakota's legislature more agile, **not more bloated**. And above all, let's honor the trust of the people we serve.

### Key Provisions of House Bill 1408:

- Maintains the 80-day legislative limit, this bill does not increase total session days but instead distributes them more effectively over two years.
- Shifts the legislature to annual sessions starting in 2027.
- Limits each year's session to 70 calendar days, with adjournment likely by early March.
- Provides flexibility in structuring sessions under the jurisdiction of legislative management per the amendment passed out with my testimony.
- Results in a fiscal note reduction for the biennium.

#### Broader Positive Impacts of House Bill 1408:

- Enhances fiscal and economic responsiveness by allowing more timely decision-making.
- Addresses the challenges of term limits by helping legislators gain experience more efficiently, ensuring continuity of governance.
- Strengthens the legislative branch to ensure it remains an equal branch of government, which would further preserve institutional knowledge and improve policymaking.
- Improves interim committee effectiveness through enhanced research, analysis, and public engagement, leading to more well-developed and thoroughly vetted policies.
- Attracts high-quality legislative candidates by making public service more accessible. Annual sessions would allow more North Dakotans, especially those unable to commit to four months at a time to serve, fostering a more experienced, diverse, and representative legislature.

Madam Chair Roers and members of the committee, House Bill 1408 strengthens our legislative process, improves decision-making, and ensures long-term efficiency in government. I urge you to support this effort to build a more effective and accountable legislature for the people of North Dakota.

When legislative assembly meets. 10 The legislative assembly shall meet at the seat of government in the month of 11 December following the election of theits members thereof for organizational and 12 orientation purposes and shall thereafter recess until the time provided in-13 subsection 2. 14 The legislative assembly shall reconvene at twelve noonannually for a number of days 15 to be determined by the legislative assembly, but the number of days must be 16 scheduled within a seventy calendar day period each year, subject to subsection 3. 17 <u>Each year, the legislative assembly shall convene on the first TuesdayMonday</u> 18 after the third day in January of the year following the organizational session as-19 provided in subsection 1 or at twelve noon on a date selected by the legislative-20 management but not earlier than January second nor later than January eleventh

- of the year following the organizational session and, following. At the close of business of the regular session, the legislative assembly shall adjournrecess subject to subsection 3.
- b. The first week of each year the legislative assembly is convened, it shall convene on Monday, Tuesday, Wednesday, Thursday, and Friday. Thereafter, the legislative assembly shall primarily convene on Monday, Tuesday, Wednesday, and Thursday. The legislative assembly shall convene on Friday only as determined by the legislative management with prior notice to the legislative assembly. A standing committee of the legislative assembly may meet on a Friday with prior notice to the presiding officer of the chamber.
- 3. Notwithstanding a motion to adjourn sine die, the legislative assembly shall reconvene as determined by the legislative management. The number of natural days used may not exceed the number of natural days available under the constitution which have not been previously used by that legislative assembly in regular session under subsection 2.
- 4. The legislative management shall determine the structure and logistics of the legislative session.

SECTION 2. EFFECTIVE DATE. This Act becomes effective on January 1, 2027.

**SECTION 1. AMENDMENT.** Section 54-03-02 of the North Dakota Century Code is amended and reenacted as follows:

#### 54-03-02. When legislative assembly meets.

- The legislative assembly shall meet at the seat of government in the month of
   December following the election of theits members thereof for organizational and

- The legislative assembly shall reconvene at twelve noon on the first Tuesday after the third day in January of the year following the organizational session as provided in subsection 1 or at twelve noon on a date selected by the legislative management but not earlier than January second nor reconvene annually at a date and time determined by the legislative management, but not later than January eleventh of the each year

following the organizational session and, following the close of business of the regular session, shall adjourn, subject to subsection 3.

- 3. Notwithstanding a motion to adjourn sine die, the legislative assembly shall reconvene as determined by the legislative management. The number of natural days used may not exceed the number of natural days available under the constitution which have not been previously used by that legislative assembly in regular session under subsection 2.
- 4. The legislative management shall determine the structure and logistics of the legislative session.

SECTION 2. EFFECTIVE DATE. This Act becomes effective on January 1, 2027.

Mr. Chairman and Members of the Committee,

I would like to start by disclosing, I am currently a North Dakota state government employee, but I am speaking as a North Dakota citizen in regard to this testimony.

Thank you for the opportunity to offer neutral testimony on the proposed amendment to Section 54-03-02 of the North Dakota Century Code, relating to annually reconvened sessions of the Legislative Assembly.

As you consider this bill, I urge the committee to ensure that any change in the legislative schedule continues to reflect the foundational principle of limited, responsible government—a value central to the North Dakota Republican Party platform and widely supported by the citizens of this state.

My concerns surround the amount of bills being filed, and the return of failed legislation biennium after biennium.

There needs to be assurance that meeting every year will not just double the amount of bills seen in a biennium. In this session there were 620 bills filed by the House and 400 filed by the Senate. I am concerned the legislature will now file around 1000 bills every year and have a limited amount of time to review and amend them. This will lead to sloppy legislation and legislatures making uninformed decisions.

Another concern I have is consistency of the similar legislation returning biennium after biennium. An easy example of this is time-zone legislation. The public takes time to inform and testify to the legislature, and a piece of legislation does not pass, only to have similar legislation be proposed the next biennium. I am concerned that failed legislation will return year after year which would just cause more of a burden to the public.

To align with the principles of limited government, fiscal responsibility, and legislative accountability, I respectfully ask the committee to consider amendments or internal rules that preserve deliberation and prevent legislative bloat under this new calendar.

Chairman Wanzek and members of the Senate Appropriations Committee, For the record, my name is Landon Bahl, and I have the honor of representing the citizens of District 17 in the North Dakota House of Representatives.

I stand before you today to introduce House Bill 1408, which proposes transitioning the North Dakota Legislature to annual sessions beginning in 2027. This bill takes a proactive approach to modernizing our legislative process while preserving the integrity of our existing framework.

### Key Provisions of House Bill 1408:

- Results in a fiscal note reduction for the biennium. I am not sure how many bonus points this should give me, but today your job on this bill should be simple with no appropriation needed. However, I will continue to discuss the policy part of this bill as I know some of you may be interested in learning more about this approach.
- Maintains the 80-day legislative limit, this bill does not increase total session days but instead distributes them more effectively over two years, we are not changing the constitution.
- Shifts the legislature to annual sessions starting in 2027.
- Limits each year's session to 70 calendar days, with adjournment likely by early March.
- Provides flexibility in structuring sessions under the jurisdiction of legislative management per the amendment passed out with my testimony.

### Broader Positive Impacts of House Bill 1408:

- Enhances fiscal and economic responsiveness by allowing more timely decision-making.
- Addresses the challenges of term limits by helping legislators gain experience more efficiently, ensuring continuity of governance.
- Strengthens the legislative branch to ensure it remains an equal branch of government, which would further preserve institutional knowledge and improve policymaking.
- Improves interim committee effectiveness through enhanced research, analysis, and public engagement, leading to more well-developed and thoroughly vetted policies.
- Attracts high-quality legislative candidates by making public service more accessible. Annual sessions
  would allow more North Dakotans, especially those unable to commit to four months at a time to serve,
  fostering a more experienced, diverse, and representative legislature.
  - To further underscore the importance of the statement I just made and how important it is to get well qualified and diverse individuals in the legislature, here are a few facts about our legislative assembly makeup today:
    - 60% of the legislative assembly can be classified into as little as three groups in terms of occupation, the first one in this grouping being farmer and ranchers, the second one being self employed and the largest in this group being retirees.

House Bill is another annual sessions bill however it may be the right one at the right time. The citizens voted for term limits and we need to do our best to adjust how we do business because the impacts of term limits are in sight. We cannot sit here and wait for those impacts to begin before we take action. If this assembly does not take action, we truly are going to impact the citizens of North Dakota, and how we do business in a negative way, there is no doubt about that. You do not need to take this from me, rather look at the study performed last interim, reach out to legislative council and ask their expert thoughts, or if you are a veteran in this assembly, ask yourself. A few very interesting or, some may say alarming facts about the future of our assemblies are as follows:

- In the 70<sup>th</sup> legislative assembly, there will be a maximum of 48.94% freshmen legislators.
- In the 71<sup>st</sup> legislative assembly, there will be a minimum of 36.88% freshmen legislators, and with the potential for a maximum of 51.06% freshmen legislators in the 71<sup>st</sup> legislative assembly. This maximum would then remain the maximum for every session moving forward.

I recognize that change, especially change initiated in the House, can face resistance. That's why we brought in Senate Majority Leader Jim Mehlhaff from South Dakota to share his experience with annual sessions during the Senate Policy Committee hearing. His testimony was compelling. South Dakota has long operated with annual sessions, and they've done so with efficiency and success. I encourage each of you to view that video testimony before taking committee action on HB 1408.

Chairman Wanzek and members of the committee, House Bill 1408 strengthens our legislative process, improves decision-making, and ensures long-term efficiency in government. I urge you to support this effort to build a more effective and accountable legislature for the people of North Dakota.

The legislative management shall promulgate legislative rules to accommodate annual legislative sessions, which must be adopted as the temporary rules of the seventieth legislative assembly during the organizational session, subject to any further amendments proposed during the organizational session for adoption of the permanent rules.

SECTION 2. EFFECTIVE DATE. This Act becomes effective on August 1, 2026.

SECTION 3. EXPIRATION DATE. Subsection 5 of section 1 of this Act is effective through December 31, 2026, and after that date is ineffective.
