- 6 **FUNDING.** There is appropriated out of any moneys in the general fund in the state treasury,

Industry, Business and Labor Committee (Rep. Warrey, Chairman) recommends AMENDMENTS (25.0565.02001) and when so amended, recommends DO PASS and BE REREFERRED to the Appropriations Committee (10 YEAS, 4 NAYS, 0 ABSENT AND NOT VOTING). HB 1438 was placed on the Sixth order on the calendar.

I am Jane Mathew, and I have lived in Fargo for 37 years. I currently serve on the board for the Fargo Theater. I remember the first time I ever went to the Fargo Theater. We were invited by our neighbor, Dr. Blaine Amidon and his wife, Virginia, to go to a Silent Movie Night with them. I was overwhelmed the minute I walked in the door. The architectural style of this theater was like none other I had ever been in. I immediately fell in love with it.

Years later, I got involved with the Fargo Film Festival starting by just working the merchandise table. I enjoyed seeing the enthusiasm of real movie buffs who waited all year for the next festival. I was invited to be on a jury and from then on, I have been actively involved with the FFF and the theater. Movies that I had to review were coming in from all over the world. Film producers and directors made it a point to come to Fargo just to attend the festival. Since my first involvement with the festival, I have taken the opportunity to visit film festivals in other towns. The FFF rises above all others.

I continue to serve as a frequent volunteer usher at the theater, and I love it. I like to usher up in the balcony. I see many people coming upstairs just to catch a glimpse of what this piece of history really looks like from a bird's eye view. It's not just Fargoans coming to the Fargo Theater. The wonderful conversations and small world moments that I have experienced while ushering are many. People from all over the country come to see comedians, musical artists, plays, lectures and many more events held at the theater. This means they need a place to stay, rent a car, eat meals at local restaurants and more.

The Fargo Theater isn't just a building. It's a piece of Fargo history and an icon for downtown Fargo. It is a building located in Fargo, but it is recognized all across the state of North Dakota and the country. It can be seen in tourism ads encouraging visitors to check out what ND has to offer. As older buildings go, they always are in need of repair and some of those repairs are huge. Being a not-for-profit, resources have to be used wisely. Emily and her staff are very conscientious financially. The community is a great supporter of the theater, but more needs to be done. With the help of funding from the passing of this bill HB1438 and the opportunity to support a matching grant, families and friends can continue to enjoy the Fargo Theater for years to come.

In recent years I have seen great movies from Classic Movie Series movies such as Cassablanca to the Sound of Music. I have used it to host and have participated in Downtown Community Partnership events, agriculture roundtables, patriotic events and to hear keynote talks from some of America's best speakers.

I have seen performances ranging from comedian Charlie Berens, to singers Clint Black, and the Blenders, to Black Jacket Symphony – Led Zeppelin. It truly has something for everyone and brings in people from within 150 miles or more to North Dakota, helping to fill our hotels and restaurants.

The marquee of the Fargo Theatre is said to be the most photographed place in the metro and those images have **brought coast to coast positive recognition to North Dakota** in print, TV and social media.

I have served on the Fargo Film Festival committee which is held every March since 2001. The festival has accepted submissions from independent filmmakers from more than 35 states and 20 countries making it a go-to destination. One of this year's featured guests will be Molly Ringwall, famous iconic films such as "Sixteen Candles", "Pretty in Pink" and "The Breakfast Club." Other multi-generational activities include their kid's movie series which provides kids and their families with affordable fun.

The Theatre is nine years older than the North Dakota State Capitol. Much like the capitol, it is amazing, but it needs refurbishment (plumbing, HVAC, lighting, projectors, seats, etc.) from its original environment in order to best serve the people of North Dakota. Please consider providing funds which can be used to help leverage private donations in order to help keep it as a *pearl on the prairie* and a source of pride for all North Dakotans.

Good afternoon, Chairman Warry, members of the committee, my name is Emily Beck. I'm a lifelong North Dakota resident and for the last 13 years, I've had the pleasure of serving as Executive Director of the Fargo Theatre.

Nestled in the heart of downtown Fargo, the Fargo Theatre has been lighting up Broadway and igniting imaginations for nearly 99 years. This historic landmark is more than just a local icon; it is a thriving hub of arts and entertainment and a cornerstone of our city's cultural and economic vitality. Every year, the Fargo Theatre welcomes approximately 80,000 guests through its doors, drawing visitors from across North Dakota and beyond.

The Fargo Theatre is a critical economic driver for downtown Fargo. Studies show that for every dollar spent on an arts ticket, an additional \$3-\$4 is spent in the surrounding community—on dining, shopping, parking, and lodging. With an estimated economic impact of over \$5 million annually, the Fargo Theatre directly contributes to the vibrancy and growth of Fargo's downtown businesses, from locally owned restaurants to boutique retailers.

When the Theatre first opened in 1926 as a silent cinema and Vaudeville house, it quickly became a gathering place where residents could connect, celebrate, and create memories. Nearly a century later, the Fargo Theatre has maintained this legacy while expanding its role to meet the diverse needs of our modern community.

Incorporated as a nonprofit in 1983, the Fargo Theatre underwent a major renovation in 1998, restoring its iconic art deco architecture and fixtures. Every year, we welcome thousands of students for field trips, where history comes alive on the big screen. Our marquee, named the "most photographed location in Fargo" by Forum Communications, serves as a beacon for our city, appearing in tourism commercials, celebrity selfies, and even ESPN Game Day broadcasts.

In celebration of the Fargo Theatre's upcoming centennial, we are conducting a capital campaign to fund projects that are critical to the organization's ability to serve the community. These projects fit into two primary areas of focus: preservation of the historic facility and production technology improvements. Specific expenses include large-scale HVAC and plumbing projects, seating replacement, and upgrading the Theatre's 30-year-old audio, lighting, staging infrastructure.

The Fargo Theatre is more than a venue—it's a vital part of our community's cultural and economic ecosystem. The opportunity presented by House Bill No. 1438 will ensure that this historic landmark can continue to evolve and thrive as we approach our centennial. Testimony for HB 1438 Historic Preservation Grant for the Fargo Theatre

Chairman Warrey and members of the House IBL Committee,

My name is Rep. Karla Rose Hanson. Today, along with my two colleagues who represent District 44, I am bringing to you House Bill 1438. This bill would provide an appropriation to the ND Historical Society for a matching grant to restore the historic Fargo Theatre.

The Fargo Theatre is a treasure. It was placed on the National Register for Historic Places by the US Department of the Interior, <u>AND</u> it is one of the hottest attractions in Fargo.

The theater is an iconic representation of Fargo's vibrant downtown. Visitors don't miss the chance to take photos in front of this beautiful theater and its classic marquee. In fact, it's one of the most photographed landmarks in North Dakota. The interior of the theater is a stunning example of art deco style.

The Fargo Theatre is a busy venue for new-release movies and live events such as concerts, ballet productions and comedy shows. A major highlight every year is the Fargo Film Festival, a 5-day event featuring more than 100 films and 40+ visiting filmmakers. The theater also hosts 8 specialty film festivals each year, plus dozens of private events for businesses and non-profits and dozens of field trips for students. Each year, the Fargo Theatre attracts about 80,000 visitors in total.

Next year, the Fargo Theatre will celebrate its 100th birthday. To mark this milestone, a capital campaign is being planned to refurbish this historic building and update its production equipment. The Fargo Theatre, which is a non-profit organization, plans to raise \$5.5 million for this project. This appropriation request of \$1.1 million represents 20% of that goal and requires a 1:1 match from private donors. This is a one-time appropriation, not an ongoing expense.

This matching grant to the Fargo Theatre will serve as a catalyst for private donations to maximize the impact of the capital campaign. The state's investment in preserving this architectural gem will ensure it continues to be a treasure in our state for years to come, continuing to spark community pride, economic activity and arts programming.

The North Dakota Historical Society budget is being heard in the E&E section of House Appropriations now. My ask of this committee is to give HB 1438 a do-pass recommendation so it can be forwarded to our section and be considered in the context of the other requests from the Historical Society, including other potential historical preservation grants.

I have invited Emily Beck, the executive director of the Fargo Theatre, to testify today to go into detail about this historic landmark, the need to refurbish the building and update its production equipment, the events it hosts, and the exciting future possibilities with the state's assistance of its 100th birthday capital campaign.

In closing, please give HB 1438 a do-pass recommendation and re-referral to the E&E section of Appropriations for additional consideration. Thank you!
