Chairman Warrey and members of the House Industry, Business and Labor Committee,

I am Shiloh K. Perry and I represent Big Dog Beverages LLC. My colleague and I are here to express our support for House Bill No.1466.

House Bill No.1466 adds several amendments to sections 5-01-01 through 5-01-02 of North Dakota century code in reference to domestic and manufacturing distilleries operating within the state of North Dakota. The purpose of this bill is to clearly define a manufacturing distillery and ensure such distilleries the ability to continue operations whilst also remaining compliant with North Dakota state laws.

Section 1 outlines various terms that are relevant to this particular industry. This testimony will primarily focus on the following terms; domestic distillery, manufacturing distillery, and distilled spirits. The current century code caps both domestic and manufacturing distilleries at 25,000 gallons of distilled spirits per calendar year and fails to outline what should happen once that ceiling is hit. House Bill No.1466 addresses these issues by amending the definitions of domestic distilleries to producing 25,000 gallons or less, and manufacturing distilleries to producing at least 25,000 gallons of distilled spirits, each within a calendar year. These amendments are exceedingly important to ensure myself and others are able to operate within the state in the coming years.

Distilleries have been known to have a great impact on the economy and employment rates in many other states. We are no different. Through this testimony I will showcase each of these points of impact in order to express the importance of passing House Bill No.1466.

While on the surface it seems a stretch that one small business could have such a significant impact, this is however the reality. Our growing distillery alone impacts over 40 jobs, this is not accounting for multiples of the positions themselves or the other distilleries within the state. With expansion on our near horizon, we can expect those 40 positions to very well become 120 just from our single distillery. Without amending the ceiling and definitions outlined in this bill, we will be forced to relocate to a different state in order to continue operations, taking those jobs with us. As we are not the only distillery in the state, without the amendments House Bill No.1466 proposes this will become a reality for the entire industry operating in the state.

Distilleries have been known to contribute greatly to state economies. In 2022 alone distilleries in Iowa contributed \$27 million in state taxes compared to \$10 million in federal taxes. While North Dakota has significantly less distilleries than Iowa, this type of impact is still very achievable in the near future. If we were to base the potential impact of the distillery industry on the current impact of the ethanol industry (an industry with a similar economic base), which generates \$1.7 billion per year in revenue and \$8.5 million in state and local tax revenue, the data would suggest that with proper support and legislation, the distillery industry can reach these heights of contribution to the state. Our own distillery will be surpassing 25,000 gallons of production by the end of this calendar year. With the infrastructure House Bill No.1466 provides, we hope to be able to contribute to North Dakota's economy for many years to come.

With these thoughts in mind I hope you will support House Bill No. 1466. This bill will have a direct effect on the economy and employment rate of this state, with a significant potential growth in impact for the years to come. Thank you very much for your time and the opportunity to testify on behalf of the distillery industry in this state.

Chairman Barta and members of the Senate Industry and Business Committee,

I am Shiloh K. Perry and I represent Big Dog Beverages LLC. My colleague and I are here to express our support for House Bill No.1466.

House Bill No.1466 adds several amendments to sections 5-01-01 through 5-01-02 of North Dakota century code in reference to domestic and manufacturing distilleries operating within the state of North Dakota. The purpose of this bill is to clearly define a manufacturing distillery and adjust how we account for our yearly production.

This bill has gone through many changes since its inception. The most recent one is in my opinion one of the most important, the changing of production value from wine gallons to proof gallons. I'm hoping in this testimony to showcase just how important this change is as well as the imminent need for this bill to pass. The current century code caps both domestic and manufacturing distilleries at 25,000 gallons (wine gallons) of distilled spirits per calendar year. As there is already one operating distillery in this state over that cap, the need for House Bill No.1466 to pass is imminent.

To begin with I'd like to focus on the importance of counting production in proof gallons. Currently all production is accounted for in wine gallons. This has become a problem due to the rising popularity of ready-to-drink canned cocktails. Henceforth in this document, I will be referring to all ready-to-drink canned cocktails as RTDs. According to The

Rise And Future Of The Ready-To-Drink Beverage Industry by Forbes Magazine, the RTD industry was the only category of alcohol beverages to see any significant growth in 2023. To ensure continued success in the distillery industry many well known distillers such as Jack Daniels and Jim Beam are also flocking to the RTD market. Prior to RTDs, most distilleries would produce bottles and those bottles being accounted for as wine gallons wouldn't have made much of a dent in the total amount of product they could produce a year. Under current century code, counting only one production run of our 12 fl oz. RTD would account for almost 5,000 gallons of product. Based on the current century code we could only do this production roughly four more times. How are we expected to keep up with demand for our product if we are capped to four RTD production runs a year? The amendment added allows for the same run of RTDs to only be counted as roughly 700 gallons of what would be our allotted 40,000. Obviously this will make a big difference as far as how much our distillery and the others in the state can produce while still remaining compliant to ND state century code. As RTD's are only on the rise in popularity it is more important than ever to change distillery production from wine gallons to proof gallons. As a representative of the distillery industry in this state I am confident this amendment will have the full backing of our community as a whole.

The larger issue this bill addresses on the whole would be the lack of clear cut definitions to the classification of distilleries and the privileges allotted to them. As I stated previously, under the current century code both domestic distilleries and manufacturing distilleries are capped at 25,000 gallons without any clue as to what would happen as the distilleries of this state hit that cap. Again we currently already have a distillery over that cap. House Bill No.1466 aims to allow all parties to continue operations while also increasing the efficiency of reporting production to the state. Without the changes this bill introduces we will see a definite closure of distilleries operating in this state. The theory behind alcohol law is that if it is not expressly written it is not allowed. Under that line of thinking, the small business I work for that is owned and operated in this state will have to close upon hitting that cap and the distillery currently over that cap should

close its doors and cease operations today. Thus the change to this section of century code is in dire need.

With these thoughts in mind I hope you will support House Bill No. 1466. The effects of this bill will have immediate results across the distillery industry as a whole. Thank you very much for your time and the opportunity to testify on behalf of craft distillers in this state.



A manufacturing distillery may sell spirits produced by that distillery at off sale, in retail lots, and not for resale, and may sell or direct ship its spirits to persons inside or outside the state in a manner consistent with the laws of the place of the sale or delivery in total quantities not in excess of twenty-five thousandone hundred fifty thousand gallons [94635567812151416] liters] in a calendar year.
 - a. Direct sales within this state are limited to two and thirty-eight hundredths gallons [9 liters] or less per month per person for personal use and not for resale. The packaging must conform with the labeling requirements in section 5-01-16. A licensee may dispense free samples of the spirits offered for sale. Subject to local ordinance, sales at off sale may be made on Sundays between twelve noon and twelve midnight.
 - b. A manufacturing distillery may hold events inside its premises and at its satellite location. The tax commissioner may issue event permits for not more than forty event days per calendar year to a manufacturing distillery to allow the manufacturing distillery, subject to local ordinance, to give free samples of its product and to sell its product by the glass or in closed containers at on-premises events on the premises, off the premises, and at its satellite location.
 - c. A manufacturing distillery may not engage in any wholesaling activities. Except as provided by section 5-01-19.1, all sales and deliveries of spirits to any other retail licensed premises in this state may be made only through a licensed North Dakota liquor wholesaler. However, a manufacturing distillery may sell distilled spirits to a domestic winery if the distilled spirits were produced from products provided to the manufacturing distillery by the domestic winery.
