## Testimony in Support of HB 1469 House Political Subdivisions Committee February 7, 2025

Chair Longmuir and Members of the House Political Subdivisions Committee:

My name is Carol Sawicki, and I am a board member and representative of the League of Women Voters of North Dakota. Thank you for the opportunity to submit testimony in support of HB 1469.

HB 1469 amends sections of the Century Code to require individuals holding public office, not just individuals running for office, to file annual statements of interest, and all statements of interest (either filed while a candidate or while holding office) will be published on the Secretary of State's website.

In addition, 1469 will require statements of interest to include a list of financial interests related to selling goods or services to political subdivisions, state agencies and departments, as well as ownership interest in an employer, business, or trust. The statements must also include the same financial interests of the spouse of the candidate or office holder.

The League of Women Voters promotes policies that shine a light on the influence of money in elections and that make campaign finance systems more transparent. LWVND believes that HB 1469 further promotes financial transparency and requests that the Committee give the bill a Do Pass recommendation.

#### **TESTIMONY PRESENTED BY**

#### **MICHAEL HOWE, SECRETARY OF STATE**

Chairman Longmuir and members of the committee, for the record my name is Michael Howe, North Dakota Secretary of State. We are in support of HB 1469. This legislation provides updates to public official statement of interest forms. Our office worked with Representative Bosch and the North Dakota Ethics Commission to propose language that provides the right balance of transparency without burdensome requirements for statement of interest filers.

This bill requires greater frequency of filing for those required to submit statements of interest under NDCC 16.1-09 to city, county and state filing officers, and expands reporting requirements. For the committee's knowledge, here is a guick summary of individuals who are required to submit statements of interest under the current code.

- Candidates for:
  - Congressional, legislative, judicial or statewide office (filed with Secretary of State)
  - o Garrison Conservancy, Soil Conservation, or county offices (filed with county auditor)
  - o City offices in cities with greater than 5,000 (filed with city auditor)
  - School Board offices in school districts with greater than 5,000 (filed with school business manager)
- Every person appointed by the Governor to a state agency, board, bureau, commission, department, or occupational or professional licensing board (filed with Secretary of State)

Currently, statements of interest include information for an individual and their spouse regarding employment, business or trust interests, investments, fiduciary relationships that may exist, and associations or institutions the individual may have a link to. Statements of interest are filed by candidates when running for office, or roughly every four years if they remain in office. For Governor appointed offices and boards, they are filed at the time of appointment.

Section 1 creates a new section in NDCC 16.1-09-02, requiring anyone who must file a statement of interest to do so annually while holding office with the appropriate filing officer by January 15 of each year. This frequency

creates greater transparency as individuals may have changing employment, investments, or relationships that could impact them in their role throughout their service. We are asking for an amendment in subsection 4 of this section to exclude federal office holders from an annual state filing requirement as they already have requirements for financial filings under federal law. You'll find our proposed amendments attached to the back of this testimony.

Section 2 adds a new category of reporting for goods or services sold to state government or political subdivisions in an amount of \$5,000 or greater from an employer, business, or trust in which the filer or spouse has ownership interest of 10% or greater in. This is intended to capture and disclose any business of substance that may be happening between the filer, or their spouse, and a government body.

Section 3 requires publishing of statements of interest by the Secretary of State on a website. Page 3, lines 14-15, as it currently reads would require all statements be published online on the Secretary of State's website. However, we are NOT the filing office for all statements of interest as our office does not receive filings from counties, cities, or schools. Due to this we are requesting an amendment to this section to amend this language so that only statements filed with the Secretary of State are required to be published to our website.

Chairman Longmuir, members of the committee, I believe this bill provides transparency in a way that is manageable by not creating new, unrealistic reporting expectations. It allows for public officials to disclose their interests to the public in a transparent manner. And, it provides insights into how those interests may change over time. I ask for your support of HB 1469.

#### FILING REQUIREMENTS FOR STATEMENT OF INTERESTS

- Every candidate for elective office shall file a Statement of Interests with the appropriate filing officer with whom the candidate filed his/her Certificate of Endorsement (SFN 17196) or Petition/Certificate of Nomination (SFN 02704).
  - a. Candidates for President and Vice President of the United States shall file with the Secretary of State either a Statement of Interests as required by Chapter 16.1-09 of the North Dakota Century <u>Code</u> or a copy of the personal disclosure statement required by the Federal Election Commission.
  - b. Candidates for US Senate and US House of Representatives shall with the Secretary of <u>State</u> or a copy of the
    personal disclosure statement required by the Federal Election Commission.
  - c. Candidates for statewide, legislative, or judicial office shall file with the Secretary of State.
  - d. Candidates for Garrison Conservancy, Soil Conservation, or county offices shall file with the County Auditor in their county of residency.
  - e. Candidates for city offices shall file with the City Auditor.
  - f. Candidates for school district offices shall file with the School Business Manager of the school district.

The Statement of Interest must be filed at the same time a Petition/Certificate of Nomination or Certificate of Endorsement is filed.

Candidates filing a Statement of Interests for the primary election need not re-file for the general election.

- Every person appointed by the Governor to a state agency, board, bureau, commission, department, or occupation or professional licensing board must file a Statement of Interests with the Secretary of State no later than the announcement of the appointment.
- When to File: Every candidate for elective office must file a Statement of Interests with the appropriate filing officer at the same time as filing his/her Certificate of Endorsement (SFN 17196) or Petition/Certificate of Nomination (SFN 02704) and Affidavit of Candidacy (SFN 02703). Appointees of the Governor shall file a Statement of Interests no later than the announcement of the appointment.

If you need more space, attach additional sheets in the same format and clearly identify which of the three items (B, C, or D) the additional sheet continues. Attach the additional sheets to this form. Use an "X" to indicate the "interest" relationship for (a) yourself or (b) your spouse. You are not required to list dollar amounts or the nature of the work performed in Items B, C, or D.

#### 16.1-09-02. Statement of interests to be filed.

- 1. Every candidate for elective office shall sign and file the statement of interests as required by this chapter. In a year when a president and vice president of the United States are to be chosen, presidential and vice presidential candidates shall file with the secretary of state either a statement of interests as required by this chapter or a copy of the personal disclosure statement that is required by the federal election commission. Candidates for elective office who are required to file such the statements shall do sofile the statements with the filing officer for that election at the time of filing a certificate of nomination, a certificate of endorsement, a petition of nomination, or a certificate of write-in candidacy, pursuant to chapter 16.1-11, 16.1-12, or 40-21, as is appropriate.
- 2. An individual who has filed a statement as the result of candidacy in a primary election need not refile before running in the following general election. A write-in candidate who is not required to file a certificate of write-in candidacy shall file the statement of interests after the candidate's election at the time of filing the required oath of office. Every individual who is appointed by the governor to a state agency, board, bureau, commission, department, or occupational or professional licensing board shall file a

    - 4. The identity by name of all business offices, business directorships, and fiduciary relationships the person making the statement, and that person's spouse, have held in the preceding calendar year.

# North Dakota Ethics Commission House Bill 1469 Testimony presented by Rebecca Binstock, Executive Director Before the House Political Subdivisions Committee February 7, 2025

Good morning, Mr. Chairman and Committee members, my name is Rebecca Binstock. I serve as the Executive Director of the North Dakota Ethics Commission.

North Dakota citizens created the Ethics Commission in 2018 by passing an initiated measure which created Article XIV of the North Dakota Constitution. The Ethics Commission, an independent constitutional entity, consists of five commissioners:

- Chair Dave Anderson (Bismarck)
- Vice-Chair Ward Koeser (Williston)
- Dr. Cynthia Lindquist (Grand Forks)
- Ron Goodman (Oakes)
- Murray Sagsveen (Bismarck)

#### **HB 1469**

Establishing the Ethics Commission to support "open, ethical, and accountable government" is the cornerstone of Article XIV of the North Dakota Constitution. The Commission is testifying in support of HB 1469 because it increases open, ethical, and accountable government by providing North Dakota citizens access to current information about their leaders. With HB 1469, North Dakota joins forty-seven (47) other states which have annual reporting of public official's interests.

Under current law, statements of interest are filed with the Secretary of State when an individual is a candidate for elected office and when individuals are appointed by the governor to a state agency, board, bureau, commission, department, or occupational or



professional licensing board. An individual does not update the statement of interest until and unless the individual runs for reelection or is re-appointed.

HB 1469 increases transparency of our state government by requiring public officials to update their statements of interest annually. This requirement ensures public officials are keeping this information up-to-date while they are in office, not just during election season or at the time of appointment. By requiring an annual update, HB 1469 promotes an informed electorate and promotes a culture of transparency, accountability, and informed decision making by our public officials.

The bill provides further transparency by requiring statements of interest received by the Secretary of State to be published online. Currently, to access statements of interest, North Dakotans are required to make an open record request. Paper forms then need to be retrieved and scanned to provide them to requestors in an electronic format.

Section 16.1-09-02 was first enacted in 1981 and has not been substantively amended since that time. However, with increasing (nearly instant) accessibility to information, the citizens of North Dakota's expectation of transparency in government has undoubtedly evolved since 1981. This bill meets those expectations.

HB 1469 also aligns North Dakota's financial disclosure requirements with de facto national standards. With passage of HB 1469, North Dakota will become the 48<sup>th</sup> state to have annual filing of statements of interest or similar financial disclosure statements. Michigan is the most recent state to move to annual filings, with its new law in effect as of 2024. Based upon the Commission's research, only one state – Idaho - does not have financial disclosure requirements for public officials or state employees.

The Ethics Commission wholeheartedly backs HB 1469 as it moves through the legislative process and requests a Do Pass recommendation by the committee. Mr. Chairman, that concludes my testimony, and I will gladly stand for any questions you may have.

For the record, my name is Kory Peterson. I am appearing before you today on behalf of the North Dakota League of Cities, in opposition to HB 1469. Prior to working with the North Dakota League of Cities, I was the Mayor of Horace for 8 years, from June 2016 to July 2024.

The League of Cities has reviewed this bill and while the League is supportive of transparency in government, it has concerns regarding implementation of the requirements along with the logistics surrounding this bill.

While the goal of this bill is to have a yearly statement of interest submitted yearly by elected officials, this will be a departure from current filings. These logistics will involve the auditor or office clerk from the city collecting and submitting these forms to the secretary of state's office. This will be another responsibility bestowed on the auditor or office clerk on a yearly basis.

The concern would be of any online filing. If the person in the office is not comfortable submitting the information online, will there be another acceptable avenue for these forms to be submitted to the secretary of state's office?

We are trying to encourage more participation in local political races within the state. There is concern with more paperwork involved with being an elected official, there may be less participation in local government.

With 344 cities in the state under 1000 in population, the League feels that very few of the forms will change from year to year and believes this may involve spending more money on something that really isn't as big a problem as perceived.

The League appreciates the efforts of wanting to create more transparency in government but feels this bill is not the correct path and recommends a Do NOT Pass on this bill.

# North Dakota Ethics Commission House Bill 1469 Testimony presented by Rebecca Binstock, Executive Director Before the Senate State and Local Government Committee March 21, 2025

Good morning, Madam Chair and Committee members, my name is Rebecca Binstock. I serve as the Executive Director of the North Dakota Ethics Commission.

North Dakota citizens created the Ethics Commission in 2018 by passing an initiated measure which created Article XIV of the North Dakota Constitution. The Ethics Commission, an independent constitutional entity, consists of five commissioners:

- Chair Dave Anderson (Bismarck)
- Vice-Chair Ward Koeser (Williston)
- Dr. Cynthia Lindquist (Grand Forks)
- Ron Goodman (Oakes)
- Murray Sagsveen (Bismarck)

#### **HB 1469**

Establishing the Ethics Commission to support "open, ethical, and accountable government" is the cornerstone of Article XIV of the North Dakota Constitution. The Commission is testifying in support of HB 1469 because it increases open, ethical, and accountable government by providing North Dakota citizens access to current information about their leaders. With HB 1469, North Dakota joins forty-seven (47) other states which have annual reporting of public official's interests.

Under current law, statements of interest are filed with the Secretary of State when an individual is a candidate for elected office and when individuals are appointed by the governor to a state agency, board, bureau, commission, department, or occupational or



professional licensing board. An individual does not update the statement of interest until and unless the individual runs for reelection or is re-appointed.

HB 1469 increases transparency of our state government by requiring public officials to update their statements of interest annually. This requirement ensures public officials are keeping this information up-to-date while they are in office, not just during election season or at the time of appointment. By requiring an annual update, HB 1469 promotes an informed electorate and promotes a culture of transparency, accountability, and informed decision making by our public officials.

The bill provides further transparency by requiring statements of interest received by the Secretary of State to be published online. Currently, to access statements of interest, North Dakotans are required to make an open record request. Paper forms then need to be retrieved and scanned to provide them to requestors in an electronic format.

Section 16.1-09-02 was first enacted in 1981 and has not been substantively amended since that time. However, with increasing (nearly instant) accessibility to information, the citizens of North Dakota's expectation of transparency in government has undoubtedly evolved since 1981. This bill meets those expectations.

HB 1469 also aligns North Dakota's financial disclosure requirements with de facto national standards. With passage of HB 1469, North Dakota will become the 48<sup>th</sup> state to have annual filing of statements of interest or similar financial disclosure statements. Michigan is the most recent state to move to annual filings, with its new law in effect as of 2024. Based upon the Commission's research, only one state – Idaho – does not have financial disclosure requirements for public officials or state employees.

The Ethics Commission wholeheartedly backs HB 1469 as it moves through the legislative process and requests a Do Pass recommendation by the committee. Madam Chair, that concludes my testimony, and I will gladly stand for any questions you may have.

Chair Roers and members of the committee, for the record my name is Michael Howe, North Dakota Secretary of State. We are in support of HB 1469. This legislation provides updates to public official statement of interest forms. Our office worked with Representative Bosch and the North Dakota Ethics Commission to propose language that provides the right balance of transparency without burdensome requirements for statement of interest filers. For your reference, the current statement of interest form you all complete is included at the end of my testimony.

This bill requires greater frequency of filing for those required to submit statements of interest under NDCC 16.1-09 to city, county and state filing officers, and expands reporting requirements. For the committee's knowledge, here is a quick summary of individuals who are required to submit statements of interest under the current code.

- Candidates for:
  - o Congressional, legislative, judicial or statewide office (filed with Secretary of State)
  - Garrison Conservancy, Soil Conservation, or county offices (filed with county auditor)
  - o City offices in cities with greater than 5,000 (filed with city auditor)
  - School Board offices in school districts with greater than 5,000 (filed with school business manager)
- Every person appointed by the Governor to a state agency, board, bureau, commission, department, or occupational or professional licensing board (filed with Secretary of State)

Currently, statements of interest include information for an individual and their spouse regarding employment, business or trust interests, investments, fiduciary relationships that may exist, and associations or institutions the individual may have a link to. Statements of interest are filed by candidates when running for office, or roughly every four years if they remain in office. For Governor appointed offices and boards, they are filed at the time of appointment.

Section 1 creates a new section in NDCC 16.1-09-02, requiring anyone who must file a statement of interest to do so annually while holding office with the appropriate filing officer by January 31 of each year. This frequency creates greater transparency as individuals may have changing employment, investments, or relationships that could impact them in their role throughout their service.

Section 2 adds a category of reporting for goods or services sold to state government or political subdivisions in an amount of \$5,000 or greater from an employer, business, or trust in which the filer or spouse has ownership interest of 10% or greater in. This is intended to capture and disclose any business of substance that may be happening between the filer, or their spouse, and the government body in which the office holder or appointee is representing.

Section 3 requires publishing of statements of interest filed with the Secretary of State on our website. This would not include statements of interest for which we are NOT the filing office such as counties, cities, or schools.

Chair Roers, members of the committee, I believe this bill provides transparency in a way that is manageable by not creating new, unrealistic reporting expectations. It allows for public officials to disclose their interests to the public in a transparent manner. And, it provides insights into how those interests may change over time. I ask for your support of HB 1469.

Candidates for President and Vice President of the United States shall file with the Secretary of State either a Statement of Interests as required by Chapter 16.1-09 of the North Dakota Century <u>Code</u> or a copy of the personal disclosure statement required by the Federal Election Commission.
  - Candidates for US Senate and US House of Representatives shall with the Secretary of <u>State</u> or a copy of the personal disclosure statement required by the Federal Election Commission.
  - c. Candidates for statewide, legislative, or judicial office shall file with the Secretary of State.
  - d. Candidates for Garrison Conservancy, Soil Conservation, or county offices shall file with the County Auditor in their county of residency.
  - e. Candidates for city offices shall file with the City Auditor.
  - Candidates for school district offices shall file with the School Business Manager of the school district.

The Statement of Interest must be filed at the same time a Petition/Certificate of Nomination or Certificate of Endorsement is filed.

Candidates filing a Statement of Interests for the primary election need not re-file for the general election.

- Every person appointed by the Governor to a state agency, board, bureau, commission, department, or occupation or professional licensing board must file a Statement of Interests with the Secretary of State no later than the announcement of the appointment.
- When to File: Every candidate for elective office must file a Statement of Interests with the appropriate filing officer at the same time as filing his/her Certificate of Endorsement (SFN 17196) or Petition/Certificate of Nomination (SFN 02704) and Affidavit of Candidacy (SFN 02703). Appointees of the Governor shall file a Statement of Interests no later than the announcement of the appointment.

- 1. Every candidate for elective office shall sign and file the statement of interests as required by this chapter. In a year when a president and vice president of the United States are to be chosen, presidential and vice presidential candidates shall file with the secretary of state either a statement of interests as required by this chapter or a copy of the personal disclosure statement that is required by the federal election commission. Candidates for elective office who are required to file suchthe statements shall do sofile the statements with the filing officer for that election at the time of filing a certificate of nomination, a certificate of endorsement, a petition of nomination, or a certificate of write-in candidacy, pursuant to chapter 16.1-11, 16.1-12, or 40-21, as is appropriate.
- 2. An individual who has filed a statement as the result of candidacy in a primary election need not refile before running in the following general election. A write-in candidate who is not required to file a certificate of write-in candidacy shall file the statement of

- interests after the candidate's election at the time of filing the required oath of office.

  Every individual who is appointed by the governor to a state agency, board, bureau, commission, department, or occupational or professional licensing board shall file a statement of interests as required by this chapter with the secretary of state simultaneously with announcement of the appointment.
  - 3. A filing officer may not include a candidate's name on the ballot if an error is discovered on the statement and the candidate is unable to or refuses to make the necessary correction before the sixty-fourth day before the election.
  - 4. While holding office, an individual required to file the statement of interests under this section, except candidates elected to hold federal office, shall submit an annual statement of interests to the appropriate filing officer by January thirty-first. A filing officer shall collect fees for late filings pursuant to section 16.1-08.1-06.1.
  - **SECTION 2. AMENDMENT.** Section 16.1-09-03 of the North Dakota Century Code is amended and reenacted as follows:

#### 16.1-09-03. Contents of statement of interests.

The statement of interests required to be filed under this chapter applies to the candidate or appointee and that person's spouse and must include:

- The name of the business or employer and an identification of the principal source of income, defined in the state income tax return as "principal occupation", of both the candidate or appointee and that person's spouse.
- 2. The name of each business or trust, not the principal source of income, in which the person making the statement, and that person's spouse, have a financial interest.
- 3. A list of the associations or institutions with which the person making the statement, and that person's spouse, are closely associated, or for which they serve as a director or officer, and which may be affected by legislative action, in the case of a statement submitted by a legislative candidate, or action by the candidate or appointee in that person's capacity as an officeholder.
- 4. The identity by name of all business offices, business directorships, and fiduciary relationships the person making the statement, and that person's spouse, have held in the preceding calendar year.

1 A list of political subdivisions and any agency or department of the state to which the 2 person providing the statement, or the person's spouse, sold goods or services of 3 more than five thousand dollars in the preceding calendar year from: 4 An employer identified under subsection 1 in which the person or the person's 5 spouse has an ownership interest of ten percent or more; or 6 <u>b.</u> A business or trust identified in subsection 2 in which the person or the person's 7 spouse has an ownership interest of ten percent or more and the business or 8 trust is directly related to the official duties of the office the person is seeking or 9 holding. 10 SECTION 3. AMENDMENT. Section 16.1-09-05 of the North Dakota Century Code is 11 amended and reenacted as follows: 12 16.1-09-05. Powers and duties of the secretary of state and county and city auditors. 13 The secretary of state, or the county or city auditor, when appropriate shall: 14 1. Accept and file any statement submitted pursuant to this chapter. 15 2. Make statements filed available for public inspection and copying during regular office 16 hours. A reasonable fee may be charged to cover the cost of copying. Proceeds from 17 any fees charged must be deposited in the general fund of the appropriate 18 governmental entity. 19 Publish all statements filed with the secretary of state under this chapter on a website 3. 20 maintained by the secretary of state. 21 <u>4.</u> Preserve statements filed under this chapter for the term of office to which the person 22 making disclosure is elected or appointed or until a new statement is filed and 23 preserve. Preserve statements filed pursuant tounder this chapter by those candidates 24 who are not elected or appointed for a period of one year after the date of receipt.
