Dear Colleague,

Please be advised that in July 2023, my legislation establishing the Ireland Trade Commission in the Department of State was passed and Signed by the Governor of the State of New Jersey.

On the day of the signing of the Ireland Trade Commission Legislation into law by Governor Murphy it was an honor and privilege to present a copy of the bill to Ireland's Minister of State at the Department of Foreign Affairs, Sean Fleming.

Minister of State Fleming, upon the receipt of a copy of the legislation, said,

"The establishment of the new Trade Commission is a sign of the desire to strengthen those links. The Irish Government is very supportive of the new Trade Commission, I look forward to working with its members to explore trade opportunities and academic exchanges between our young people."

In 2022, I arranged for a delegation of the America Irish State Legislators from New Jersey to visit Ireland. The American Irish State Legislative Caucus is open to everyone those who have Irish heritage and those are supporters of Ireland

The caucus members asked how we could help build the links between Ireland and New Jersey as well as support the peace process and the Good Friday Agreement, this legislation was the result of those discussions. The New Jersey Ireland Trade Commission will help communities in our State through the creation of educational, economic, and people to people links. Ireland is the nineth (9<sup>th</sup>) largest investor in the US, the Ireland Trade Commission is intended to build on the two-way relationship.

# Re: NJ Ireland Trade Commission Legislation in the Department of State

As a result of the Brexit agreement following the United Kingdom's exit from the European Union, Ireland is the largest English-speaking country with direct access to the EU market of 450 million people, there are also 950 US companies based in Ireland using it as a gateway to the EU.

The legislation can be adopted as it is or amended to the respective needs of each state. The key elements of the commission legislation include:

- There is no cost to the taxpayer in the State as the Commission raises the funds to do its work, to visit Ireland and host visiting Irish Delegations.
- Twenty-three (23) people are appointed to the Ireland Trade Commission in New Jersey by the Governor, and legislative leaders in New Jersey.
- Members are appointed by the Chambers of Commerce in the State and by Department of Higher Education.
- Appointments to the commission could also include retired members of the State or Federal Legislatures so that institutional knowledge is retained. Leaders of the business community in the State with an interest in Ireland could also be appointed to the commission.

Dear Colleagues:

The Ireland Trade Commission legislation was drafted by a member of the New Jersey American Irish State Legislators Caucus following their trip to Ireland in 2022. The members of the Caucus asked after their visit to Belfast how they could help support the peace process and the Good Friday Agreement and this legislation was the result of those discussions. With this Commission States are helping communities in Ireland but also helping communities in their own State through the creation of educational, economic, governmental, and person to person links.

As a result of the Brexit agreement following the United Kingdom's exit from the European Union, Northern Ireland uniquely now has access to both the UK market of 67 million people and the European Union (EU) market of 450 million people. The Republic of Ireland also has direct access to the EU market. There are 950 US companies based in Ireland using it as a gateway to the EU. Ireland is also the 9th largest investor in the US. The Ireland Trade Commission is intended to build on this two-way relationship.

The legislation can be adopted as drafted or amended to suit the needs of your state. For example, States could adopt a version which provides any or all of the following features:

- There could be no cost to the taxpayer in each State as the Commission could be charged with raising the funds to do its work to visit Ireland and host visiting Irish Delegations
- People may be appointed by the Governor, the Senate President, Speaker/ Majority Leader, and Minority Leader.
- Members can be appointed by the Chambers of Commerce in the State or an equivalent organization and by the Universities or their representative Associations.
- The remaining open places on the Commission could be drawn from the retired members of the State or federal legislative delegations so that institutional knowledge is retained. Leaders of the business community in the State with an interest in Ireland could be appointed to the commission.

- The membership of the Commission ideally would be bipartisan like the membership of the American Irish State Legislator Caucus.
- The members can range from 9 as is the case with West Virginia or up to 23 as is the case with New Jersey.

We value our relationship with our Irish friends and look forward to deepening our shared connections. Our objective in adopting legislation to create the Irish Trade Commission is to enhance those mutually beneficial opportunities.

I'm before you to introduce House Bill 1568, which is co-sponsored by three of four bipartisan co-chairs of the North Dakota American Irish Legislators Caucus, and others interested in the creation of a North Dakota Ireland Trade Commission.

This bill aims to establish a new chapter in title 54 of the North Dakota Century Code, focusing on enhancing bilateral trade and investment between North Dakota and Ireland. The commission will promote business and academic exchanges, encourage mutual economic support, and address issues of mutual benefit. The commission will consist of two appointed members from our state Senate, and two from the House of Representatives, the Executive Director of the North Dakota Trade Office, another person knowledgeable about, and interested in, international trade, and the Agriculture Commissioner or his designee.

The bill outlines the administration, meeting schedules, and reimbursement policies for commission members, and mandates an annual report to legislative management detailing the commission's activities, benefits, and recommendations for supporting trade between North Dakota and Ireland.

Irish Senate Leader, Mark Daly, may have more recent figures when he testifies today, but my information is that 19 U.S. states have passed a similar commission with three more that were scheduled to pass one by the end of 2024, and around 14 on tap to consider a commission this year.

This would be our state's first trade commission, and for that honor, Ireland is a proper pick. It would allow us to partner with a country that has always been our friend and supporter. There are other reasons to have Ireland be our prototype, pilot project, or test drive.

Our American Irish Legislative Caucus has bound us together directly for some years now. North Dakota members were invited to Ireland as official guests to celebrate the 50<sup>th</sup> anniversary of the Good Friday Peace Agreement in 2023, a document which was promoted, negotiated, and supported by American George Mitchell among others, and helped bring peace between Northern Ireland and the Republic.

But our countries' longstanding inter-relationship extends back much further. Between the Irish famine in the mid-1800s and 1920, 3.7 million Irish emigrated to America, bringing families that multiplied to every state until by 1900 there were more Irish in America than in Ireland.

The Irish then and now can be disproportionately found in U.S. government, politics, and public services like law enforcement.

Twenty-two American Presidents have claimed Irish roots (although only 15 have proved it). The current President owns a golf course and hotel in Doonbeg, County Claire, Ireland.

If North Dakota is going to expand its international trade, we couldn't have a better partner. Ireland shares our language, our democratic values, has a highly educated population and workforce, and shares many of our cultural and artistic passions.

It has a prominent agricultural economy, but also currently hosts nearly 1,000 American businesses operating in Ireland, with many large corporations establishing their European headquarters in Ireland due to favorable tax conditions and a skilled workforce. These companies span various sectors, including technology, pharmaceuticals, and finance. And what a trading partner Ireland makes. You get a 3-for-one special: access to the Republic of Ireland, access to Northern Ireland, a British partner, and access to the European Union, of which Ireland is a member.

Even beyond the benefits of traditional trade opportunities, this commission could open expanded mutual tourism, since Ireland is one of the countries most visited by Americans. It could create a plethora of academic exchange opportunities.

There's really no downside to this bill, only potential. And maybe a little Irish magic. Please give HB 1568 a "do pass" (and see what gold there might be at the end of this rainbow).

If you saw that the Irish Taoiseach Micheal Martin was at the White House last week and there appeared in headlines to be a bit of a "dust-up" as the Irish say, when talking about trade imbalances and other issues, never fear. President Trump also said the same day he "loves the Irish" and "We're always going to have that special friendship." The President added, "The bond between our nations is as old as our country itself." And in a separate breakfast for the Irish leader hosted by Vice-President J.D. Vance last Wednesday, Vance described the US-Ireland relationship as "one of the great alliances and great friendships between nations."

So, if North Dakota is going to expand its international trade, we couldn't have a better partner. Ireland shares our language, our democratic values, has a highly educated population and workforce, and shares many of our cultural and artistic passions.

It has a prominent agricultural economy, but also currently hosts nearly 1,000 American businesses operating in Ireland, with many large corporations establishing their European headquarters in Ireland due to favorable tax conditions and a skilled workforce. Even beyond the benefits of traditional trade opportunities, this commission could open expanded mutual tourism, since Ireland is one of the countries most visited by Americans. It could create a plethora of academic exchange opportunities.

There's really no downside to this bill, only potential. And maybe a little Irish magic. Please give HB 1568 a "do pass" (and let's see what gold there might be at the end of this rainbow).

# HB 1568 Testimony Senator Kathy Hogan Senate Industry Business and Labor March 17, 2025

Chairman Barta and members of the Industry and Business Committee, for the record, my name is Kathy Hogan, and I represent District 21 which is central Fargo and a portion of West Fargo. I am testifying in support of this bill.

The United States and North Dakota have a proud history of many collaborations. Beginning in the 1800s, the Catholic Church began asking for both Priests and Sisters from Ireland to help settle our state. In the Fargo Diocese, three of the first six Bishops were Irish and the Irish Presentation Sisters of the Blessed Virgin Mary settled in Fargo in 1882 beginning a long history of opening over 25 schools and 10 hospitals in eastern North Dakota. The Irish settled all over ND, but primarily in the northwest corner places like Kenmare and Donnybrook.

This bill is modeled after similar trade agreements in at least 19 other states. The ND American Irish Caucus had 13-members last session and as the Senate Caucus leader I invite all of you with Irish Heritage to consider joining the Caucus which meets regularly at both NCSL and CSG meetings.

It has been my privilege to travel to Ireland several times and immediately fell in love with the land, the people and customs. Ireland is among the world's leading exporters of computer software. The principal imports include machinery and transport equipment, chemicals, petroleum and petroleum products, food products, and textiles.

Thank you for considering this bill and I am more than willing to answer any questions.
