# Testimony in Support of House Bill 1595 1/31/2025

Dear Chairperson and Members of the House Human Services Committee,

I am writing to express my strong support of House Bill 1595, because every woman facing an unplanned pregnancy deserves truth, dignity, and real medical care—not deception and misinformation.

Pregnancy is one of the most vulnerable moments in a person's life. Imagine a young woman—perhaps a teenager, perhaps a mother already struggling to provide for the children she has—walking into a pregnancy resource center, trusting that the people there will give her honest, professional guidance. Instead, she is met with false medical claims, pressure, and deliberate withholding of information. She may be led to believe she has more time to make a decision than she actually does. She may be told outright falsehoods about abortion, adoption, or even the risks of childbirth. She may be shamed for even asking about her full range of options.

This is not health care. This is not help. And yet, these centers—many of which receive our taxpayer dollars—continue to operate in the shadows, unchecked, unregulated, and unaccountable.

House Bill 1595 ensures that pregnancy resource centers receiving public funding are held to the same basic standards we expect from any legitimate medical provider. It does not shut down these centers. It does not force them to provide services they disagree with. It simply asks them to be honest, professional, and medically responsible.

- If a center claims to offer medical services, a licensed medical professional should be present.
- If ultrasounds are performed, they should be conducted and explained by trained professionals, not unlicensed volunteers.
- If counseling is offered, it should be based on medical facts—not ideology.

This bill is not about politics. It is about protecting women from harm.

I urge this committee to put patients before politics. Women in North Dakota deserve to walk into a pregnancy resource center knowing that they will be met with truth, respect, and real medical care. We owe them transparency, honesty, and safety.

House Bill 1595 ensures just that. I respectfully urge a Do Pass recommendation.

Honorable Members of the Human Services Committee, my name is Dr. Erica Hofland. I am a practicing Obstetrician Gynecologist in Dickinson and I am writing asking for your support for HB 1595.

House Bill 1595 helps ensure the state of North Dakota supports health care delivery in a way that is medically accurate and comprehensive. When a pregnant individual seeks out medical care they may not be aware that they could be given different or less information depending upon where they present for care. This unfortunately is the case in many pregnancy resource clinics. Websites, reception areas, and providers themselves associated with pregnancy resource clinics will not advertise what information they withhold. Patients have a right to full, comprehensive medical information about their health and options to manage their health conditions including pregnancy. Patients should feel confident and trust they have access to this full spectrum of care on their first encounter. Financially supporting institutions that do not provide comprehensive care is unethical and also a poor utilization of limited health care dollars. Patients will need to seek out additional appointments and evaluations to manage their concerns, wasting not only their time but the funds that have been appropriated to these clinics. HB 1595 will hold clinics to the medical standard of care and also ensures the state is financially responsible with its resources.

#### Good day, House Human Services Committee Members,

I am here today to testify in opposition to HB 1595, a bill that seeks to impose unnecessary and burdensome regulations on pregnancy resource centers in our state.

The work that these centers do is invaluable to our local communities. Many women facing unexpected pregnancies rely on these resources for critical support, helping them care for their children from conception through the early years of life. These centers offer free pregnancy tests, parenting classes, material assistance, and counseling. In some cases, they have even raised funds to provide new mothers with transportation, such as a working vehicle, so they can care for their child and their family.

A crucial distinction to recognize is that pregnancy resource centers do not claim to be healthcare facilities. They do not provide medical treatment, nor do they advertise themselves as medical centers. Rather, they exist to offer emotional, practical, and material support to women in need. The argument that these centers should be required to provide information about abortion is both misguided and irrelevant, given that North Dakota's law—though currently in litigation—prohibits abortion. Why should we force organizations to promote a procedure that is illegal under state law?

Furthermore, pregnancy centers are a vital asset to North Dakota families. In Burleigh County alone, *one in every six children* starts their life with support from the local pregnancy center. These organizations step in where government assistance often falls short, ensuring that women have access to the care and resources they need. Placing additional regulations on them would only hinder their ability to serve those in crisis.

Instead of overburdening these centers with unnecessary red tape, we should be supporting their efforts to uplift women and families in our communities. I urge this committee to recognize the essential role pregnancy resource centers play and to vote **Do Not Pass** on HB 1595.

#### **Testimony Opposing House Bill 1595**

Dear Chairman Ruby and honorable members of the House Human Services Committee,

My name is Mark Jorritsma and I am the Executive Director of North Dakota Family Alliance Legislative Action. I am testifying on behalf of our organization in opposition to House Bill 1595 and respectfully request that you render a "DO NOT PASS" on this bill.

Pregnant mothers and families often need help for a variety of reasons, from low incomes and lack of childcare training, to the emotional trauma inflicted by those around them who don't support their pregnancy. We as a state must stand ready to help with these needs. In this state, we try to provide that help — with a significant share of it coming through the funding of pregnancy resource centers (PRCs).

PRCs that accept funding from the state must be responsible and accountable in their use of the money, as any agency or entity receiving government funding must be. However, a balance must always be struck between accountability and unreasonable scrutiny. The state must also ensure that unduly burdensome funding requirements do not undermine the very ability of an entity to provide the services requested by the state.

Looking at HB 1595, it contains requests for duplicative information, requires information that is not relevant to any funding it might receive from the state, asks the PRC to violate its core purpose, and more. For example, it wants the PRC to use its resources to provide information that is already publicly available on its Form 990 tax exemption filings. Further, a PRC is not a health care facility and does not need staff with the qualifications on-site as outlined in Subdivision 1(1)(f), even though they often have the individuals offsite and available. Third, if the definition of "Comprehensive Counseling" in Subdivision 1(1)(b) is combined with the requirements in Subdivision 1(3)(e), the bill would require PRCs to give client referrals to abortion clinics, something which violates the very mission and integrity of a PRC.

Aside from these specific issues with the bill, PRC services are free, and therefore they cannot be part of the HIPAA program, as they do not deal with insurance. Regardless, PRCs do typically

follow the guidelines. Finally, there is a great need for state funding in rural communities who desperately need access to state funds, but don't have the staffing/bandwidth to comply with everything in HB 1595.

These are but a few of the many problems with HB 1595. It is nothing more than an attempt to silence and restrict North Dakota citizens from helping pregnant mothers, their pre-born children, and fathers via the services provided by PRCs. For all these reasons, North Dakota Family Alliance Legislative Action requests that you render a "DO NOT PASS" on Senate Bill 1595.

Chair Ruby and members of the House Human Services Committee

My name is Dr Ana Tobiasz. I am an obstetrician/gynecologist and maternal fetal medicine physician practicing in the state since 2017. My specialty is in caring for high risk pregnancies. I strongly urge a DO PASS on HB 1595.

I have personally cared for many pregnant women who were given incorrect medical information from pregnancy resource centers in this state. This commonly includes incorrect ultrasound information. These centers offer free ultrasounds and provide the patient with a due date and gestational age. Unfortunately, the individuals performing these ultrasound exams are oftentimes volunteers with no formal training in performing obstetric ultrasound or are individuals who are inadequately trained and have no supervision. It is also well known that they oftentimes falsely inflate an individual's gestational age in order to dissuade them from having an abortion. There is no way for anyone outside of the facility to review their imaging for accuracy.

Patients who receive an incorrect gestational age and due date for their pregnancy are now subject to a multitude of concerns. Many of the decisions that are later made in the management of the pregnancy, center around having a correct gestational age and due date. This can result in poor outcomes if the due date is incorrect, such as incorrectly delaying delivery too long, which puts patients at risk for outcomes such as stillbirth and maternal complications such as preeclampsia. This can also lead to unnecessary interventions if the due date is incorrect, such as a diagnosis of fetal growth restriction. This diagnosis then commits a patient to increased ultrasound surveillance to reduce the risk of stillbirth. Oftentimes this degree of testing is unnecessarily done because of incorrect pregnancy dating that was established at one of our local pregnancy resource centers. This testing is costly and time consuming for patients.

I have also seen our local pregnancy resource centers miss serious diagnoses such as an ectopic pregnancy. This is an emergent diagnosis that requires appropriate evaluation and treatment to prevent maternal blood loss and death. Delaying establishing prenatal care can result in other adverse effects, such as delaying adjusting medications that may be teratogenic (can cause birth defects).

When individuals seek care at a pregnancy resource center, they are unaware of the lack of training the individuals have who volunteer or work there. They trust that the information being provided to them is factual and accurate. This oftentimes will result in patients delaying seeking appropriate obstetric care from an accredited medical facility or practice.

If the state insists on utilizing taxpayer dollars to fund these centers, there should be minimum standards and oversight from appropriately trained individuals as there is for every other medical practice and facility that is providing medical care or diagnostic testing. Pregnant individuals in this state deserve to receive evidenced based, high quality information from health care professionals who are appropriately trained and practicing within their scope.

As a woman diagnosed with cancer at 22, I was told that having children in my future may not be a possibility unless medical intervention was an option. My husband and I began trying to have a child when I turned 30, and quickly discovered without the help of any type of reproductive medicine, it wouldn't be possible.

After 9 rounds of Intra Uterine Insemination (IUI), two rounds of In Vitro Fertilization (IVF), about 40 eggs and a tremendous amount of money and tears, we were able to have our son.

None of this was taken lightly. The children we lost while attempting to have one was detrimental to our mental health, our physical health and extremely straining on our marriage. We would do it again in a heartbeat for our son.

This bill is not about families getting the chance to have a child. This bill is about religion, something that reproductive medicine is not. If HB1373 is approved with the current language, IVF treatment will be unavailable to families and women that already carry the burden of infertility. As someone who firsthand lost over 40 eggs because they did not grow after being fertilized, should I be condemned as the language is currently written? If a woman has a miscarriage due to circumstances outside of her control, should she? This is how HB1373 will treat women. How can our state consider itself "Legendary" if we don't protect the people that will carry on the legacy? How can our state continue to turn down women's healthcare when they are the ones who bring new life to our state?

I urge you to vote in opposition of HB1373. Protect our providers, protect our women, protect the families and couples that have the hope that one day they will be able to be parents.
