Chairman Headland and Members of the Committee,

For the record, my name is Andy Armacost, and I serve as the President of the University of North Dakota.

I am writing in opposition to HCR 3012. As you will hear in testimony from UND School of Medicine and Health Sciences (SMHS) Dean Marjorie Jenkins, the impact of this resolution on the operations of the state's only medical school will be significant. This would represent a \$14.7 million biennial cut to the bottom line of the school.

We have appreciated the decades-long commitment of the citizens of North Dakota to their health and the impact of their support on SMHS's ability to deliver physicians and health care providers across the state.

I would urge this resolution to go forward only if there is a consideration or a commitment to offset the loss of funding using other appropriations to make the school whole. The mill has been a steady and reliable fund that has kept pace with inflation and has had a tremendous impact.

In closing, I would contend that if there is one area where a state-wide mill is appropriate, it is to ensure all our citizens have access to high-quality health providers and to keep the incredible flow of physicians from the School of Medicine and Health Sciences to the communities across our state.

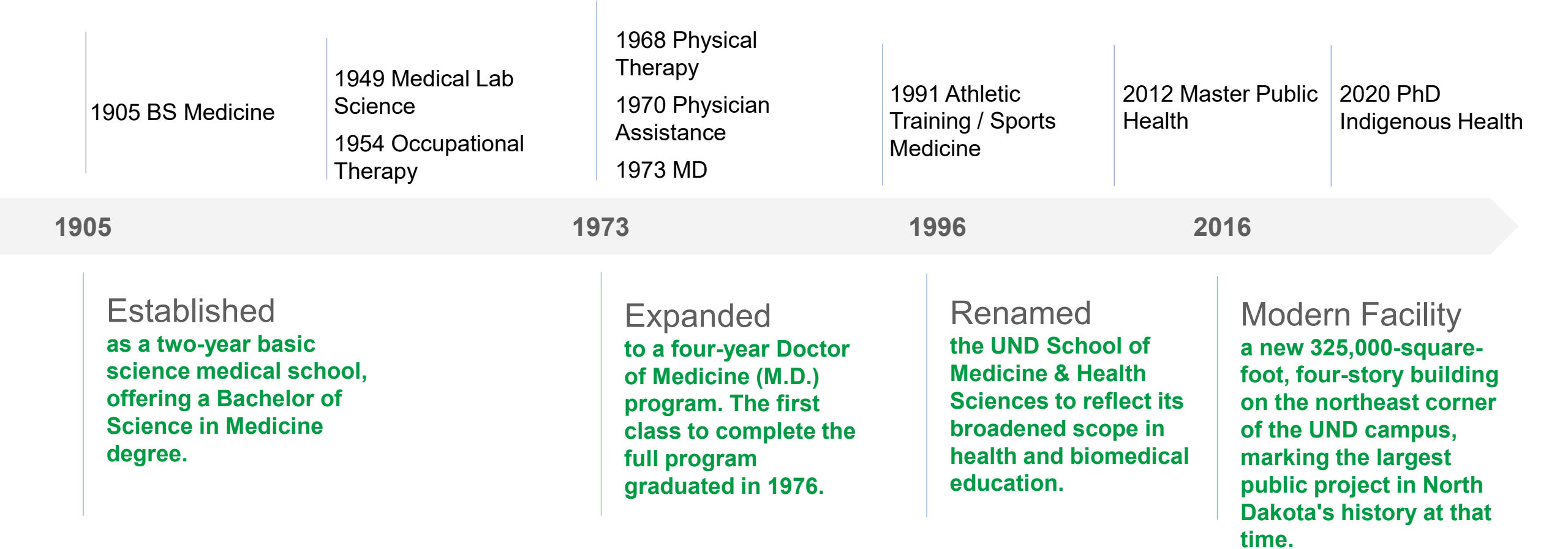

# 1948: NDCC Section 10 of Article X

## Section 10.

1. Upon the adoption of this amendment to the Constitution of the State of North Dakota there shall be annually levied by the state of North Dakota one mill upon all of the taxable property within the state of North Dakota which, when collected, shall be covered into the state treasury of the state of North Dakota and placed to the credit of the North Dakota state medical center at the university of North Dakota; said fund shall be expended as the legislature shall direct for **the development and maintenance necessary to the efficient operation** of the said North Dakota state medical center.
2. This amendment shall be self-executing, but legislation may be enacted to facilitate its operation.

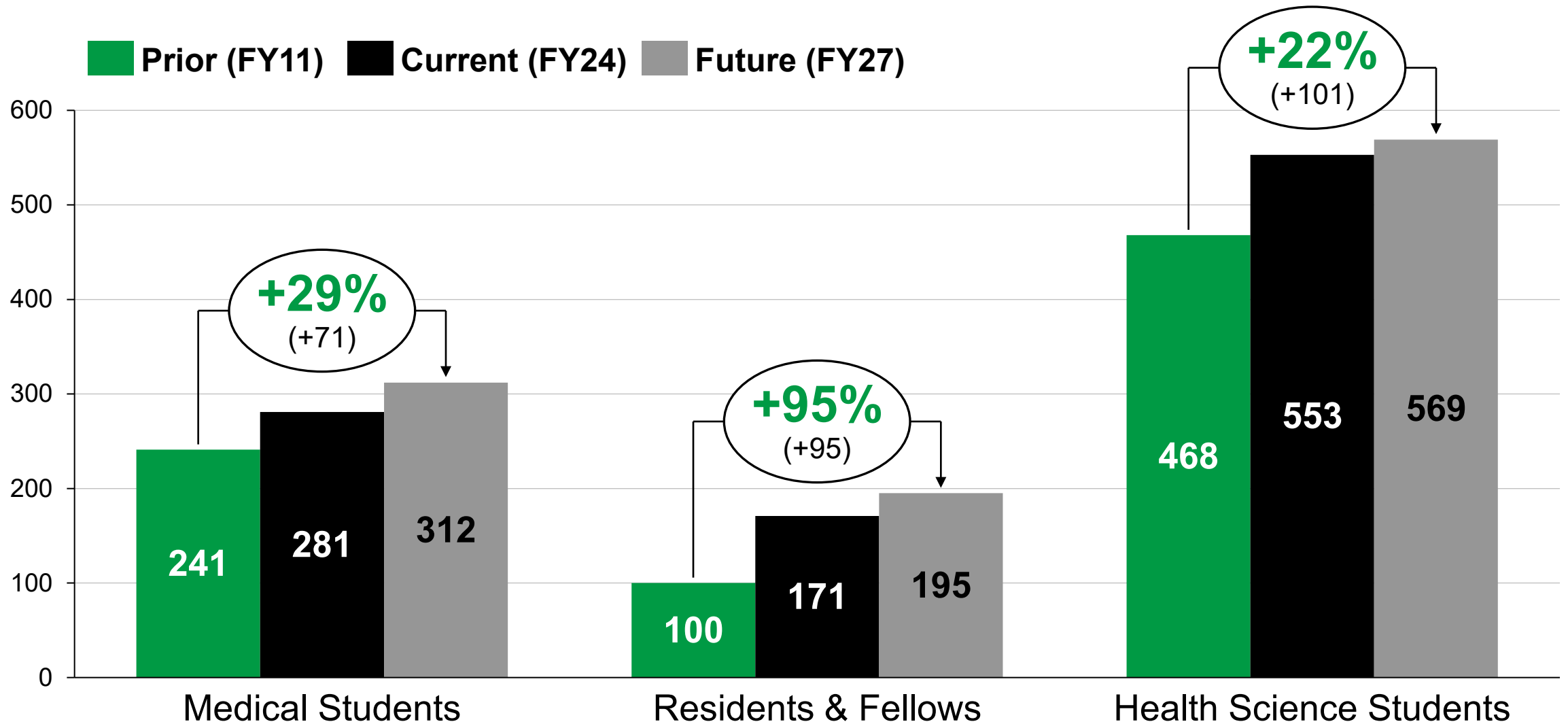

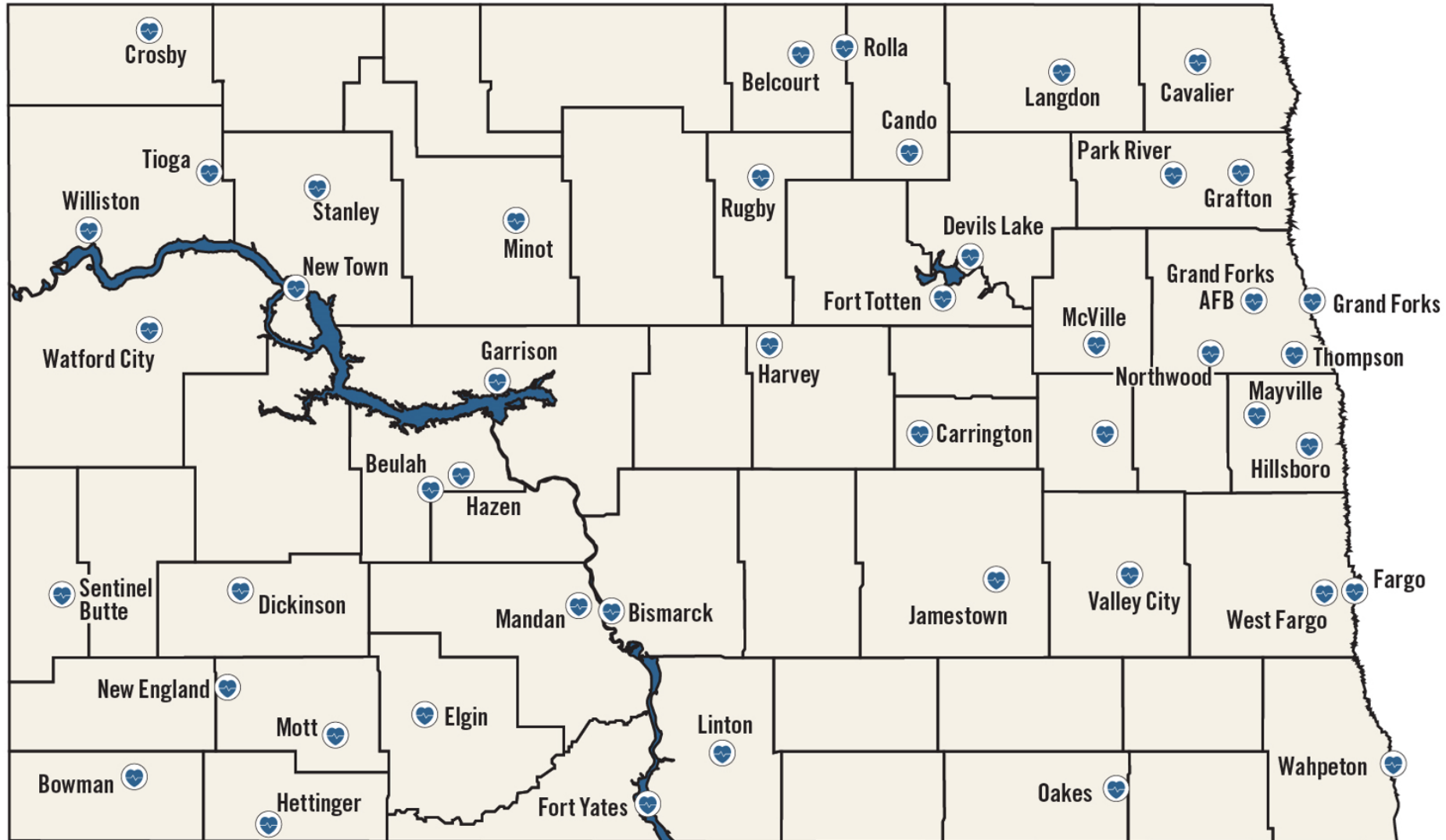


# Large Footprint Lean Operations



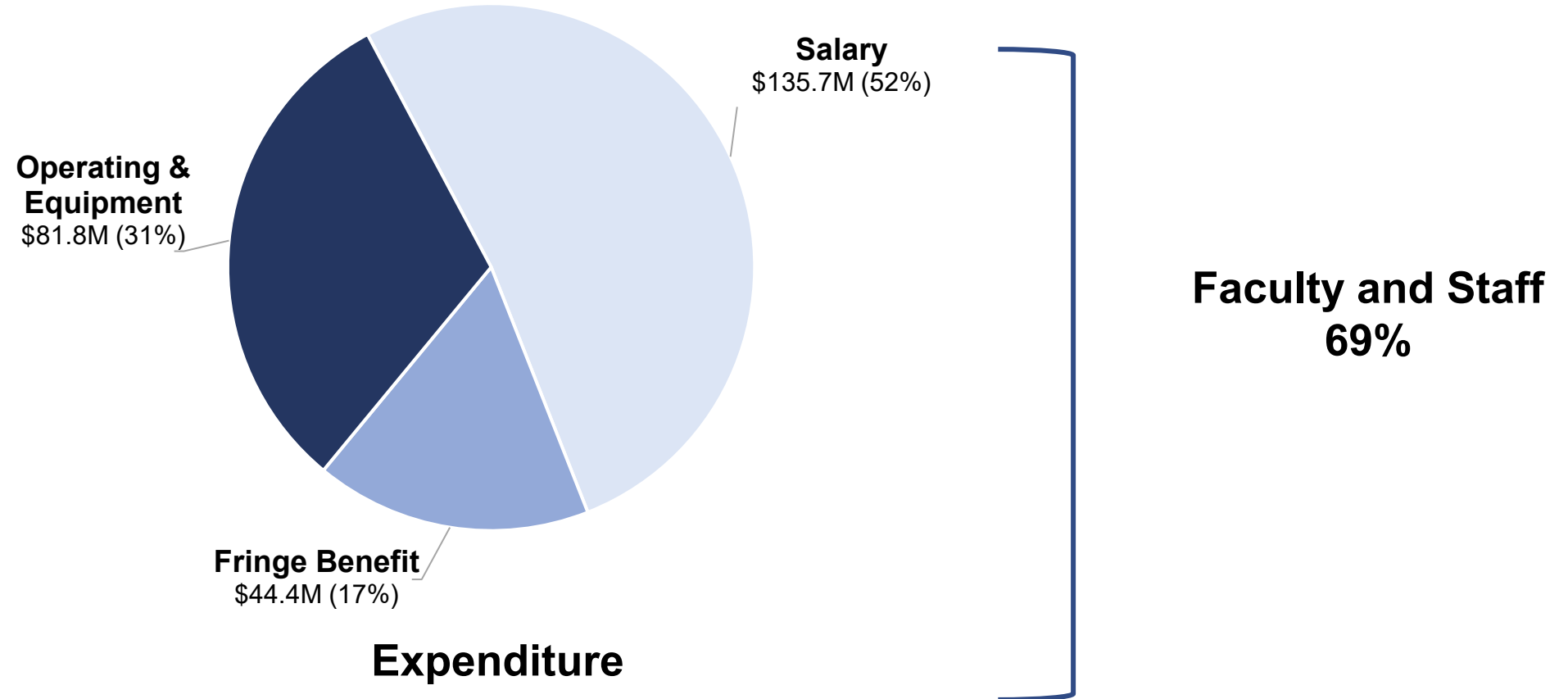


# SMHS Students Across North Dakota



# 2025-27 Biennium Budget

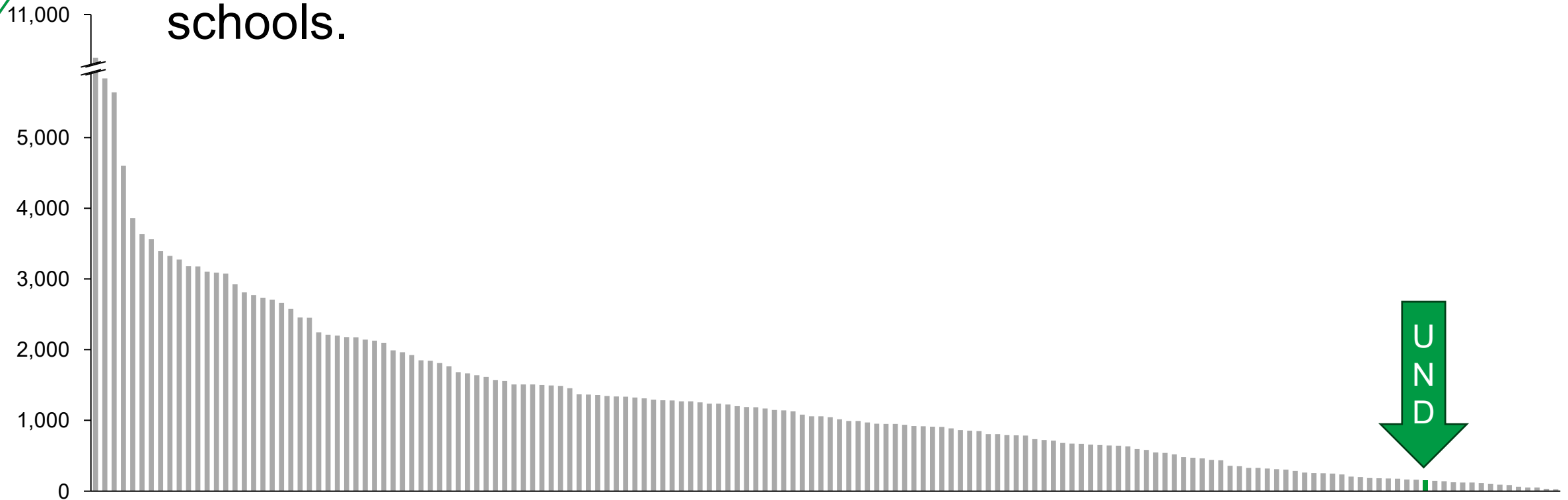

# Faculty for MD program 2024-25 (School)

- In 2024-25, the UND SMHS reported a faculty count of 158 to the AAMC, resulting in a ranking of 144th out of 159 member schools.

# Student per Faculty Ratio 2024-25 (School)

- In 2024-25, UND SMHS's Student-to-Faculty ratio (1.80) ranked 22nd among 158 medical schools, exceeding the national average of 0.47. This may reflect UND SMHS's lean and efficient model.
- We may be small, but we deliver results.



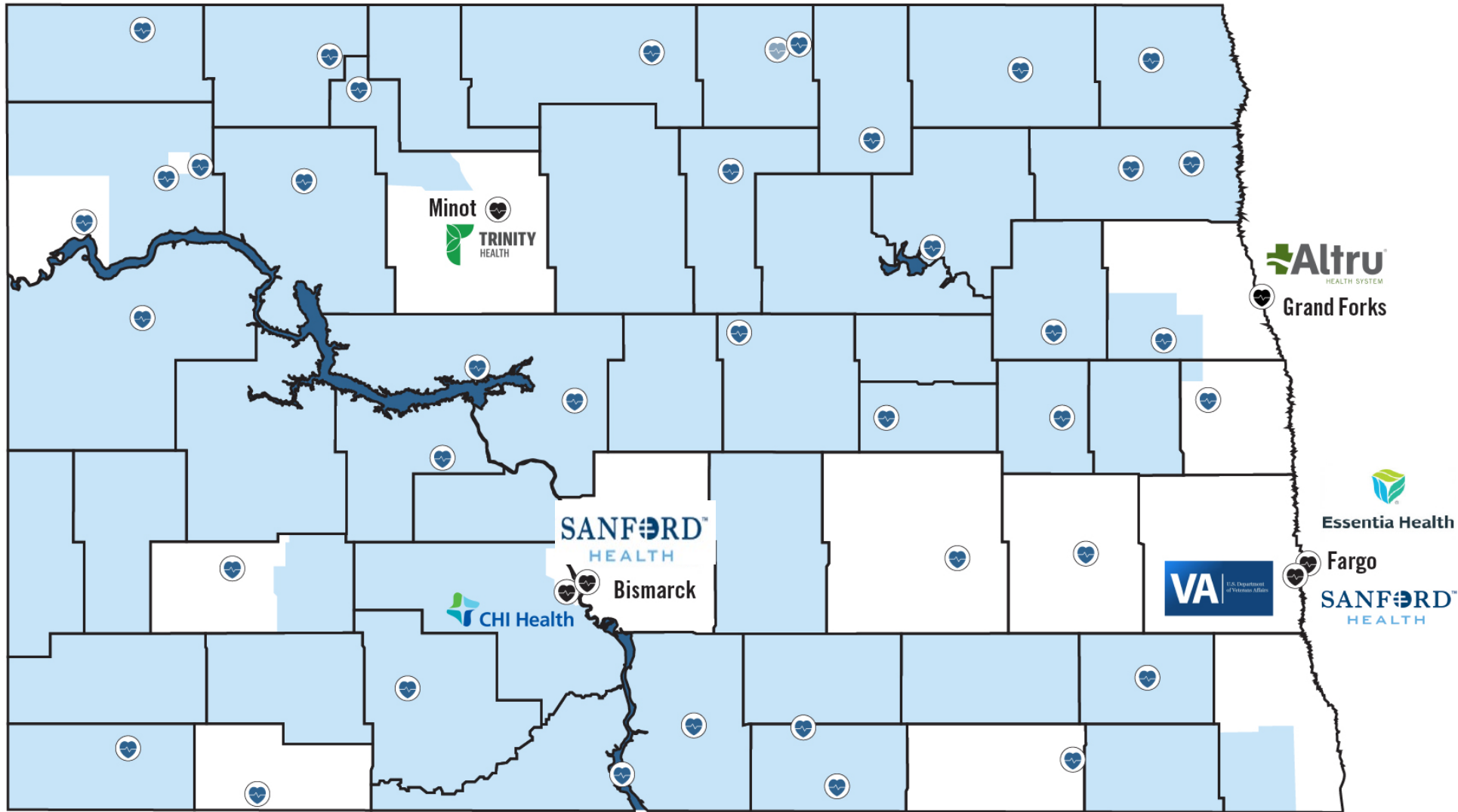

# Repeal of the One Mill Levy

- HCR 3012 and SCR 4023 propose repealing this amendment.
- If the Legislature approves, the Governor signs, and voters concur in the 2026 General Election, UND SMHS would lose more than **\$14.7M** in next biennial funding (approximately 5% of its operating budget).

Chairman Headland and Committee Members, I'm Donna Thronson and I serve as Communications Director of the North Dakota Medical Association. The North Dakota Medical Association is the professional membership organization for North Dakota physicians, residents, and medical students. NDMA opposes SCR 4023.

NDMA appreciates the intention of this resolution. Addressing property taxes is a major concern for the people of North Dakota, the Governor, and the legislature. However, this mill levy has an extremely small effect on individual tax bills but provides a stable and much-needed funding source for the state's only medical school. Not knowing how or if the funds will be replaced could leave your school of medicine with a funding shortfall. This situation is serious when the school's funding relies on educating North Dakota's future and present healthcare workforce.

In 1948, the people of North Dakota voted to approve an amendment to the North Dakota Constitution to provide SMHS with dollars raised using a single mill levy to help finance their operations. NDMA assumes that it is the intention of the bill's sponsors not to defund the medical school, but rather to shift the source of funding from property taxes

to the general fund. However, state budgets are tight, and receiving a large increase in funding will be difficult. The fiscal impact or reduction in collections in the 2027-2029 biennium is estimated to be \$14,738,688 if approved by qualified electors in the 2026 general election.
