- 5 **SECTION 1. AMENDMENT.** Section 4.1-72-05 of the North Dakota Century Code is amended and reenacted as follows:
- 7 4.1-72-05. Animal Premises identification program Administration.
 - The North Dakota stockmen's association shall serve as the state's a state administrator and allocator for that portion of any federally sponsored animal premises identification program which pertains to cattle, horses, and mules.
 - SECTION 2. AMENDMENT. Subsection 1 of section 4.1-72-06 of the North Dakota Century

 Code is amended and reenacted as follows:
 - 1. Except as provided in subsection 2, any information created, collected, or maintained by the state veterinarian or the North Dakota stockmen's association, or an authorized administrator with respect to the administration of any federally sponsored program pertaining to livestock as permitted by section 4.1-72-05 is confidential and not subject to the open records requirements of section 44-04-18.
 - **SECTION 3. AMENDMENT.** Subdivision f of subsection 2 of section 36-01-36 of the North Dakota Century Code is amended and reenacted as follows:
 - f. The disclosure is to provide the North Dakota stockmen's association-<u>or an</u>

 <u>authorized administrator</u> with information <u>pursuant tounder</u> section 4.1-72-05.

REPORT OF STANDING COMMITTEE SB 2087

Agriculture and Veterans Affairs Committee (Sen. Luick, Chairman) recommends AMENDMENTS (25.8121.01001) and when so amended, recommends DO PASS (6 YEAS, 0 NAYS, 0 ABSENT AND NOT VOTING). SB 2087 was placed on the Sixth order on the calendar. This bill does not affect workforce development.

I am opposed to SB 2087.

Only the North Dakota state veterinarian and ND State Board of Animal Health should serve as administrators and allocators of a premise identification program to prevent a breach of confidentiality.

The phrase, "authorized administrator," should be stricken from the bill because the bill in no way defines what an authorized administrator is. How, and by whom, will an administrator be authorized? What is the criteria for authorizing an administrator? It is far too broad and undefined and provides an avenue for a possible bad actor to obtain confidential records.

Chairman Luick and members of the Senate Agriculture and Veterans Affairs, I am Dr. Ethan Andress, North Dakota State Veterinarian. I am here on behalf of Agriculture Commissioner Doug Goehring, and the State Board of Animal Health (BOAH). I will testify on SB 2087.

SB 2087 is intended to clarify the responsibilities of the State Board of Animal Health as it relates to animal identification, and the Stockmen's Association's authority for premises identification for cattle, horses, and mules.

NDCC Chapter 4.1-72-05 addresses the options for producers to obtain a Premises Identification Number (PIN) through USDA APHIS's Premises Management database, especially as it relates to funding. Currently, state animal health officials, federal agencies and the Stockmen's Association can use the federal allocator to request PIN numbers for producers. At this time, there is no federal funding provided to states for this purpose.

Animal identification is covered under two statutes NDCC 36-01-08 which grants the Commissioner authority to collect fees (at cost) for brucellosis and identification tags, and NDCC 36-01-32, which gives the BOAH authority to "develop and maintain animal tracking databases to assist with tracking animal movements for animal health purposes only."

While there is understanding between state partners regarding the existing language, I would encourage the passage of SB 2087 to clarify and avoid potential confusion over "animal identification" authority moving forward.

To the Honorable Chairman and the members of the committee, we submit these remarks on behalf of DRC.

Mr Chairman,

We feel that as this bill is written it will be sufficient if passed with the change of the word animal being changed to premises. However we would like to bring up an issue about consolidation of power of the Stockman's Association and a possible solution.

The North Dakota Stockmen's Association should not be the only administrator or be the only one's privy to this information. We feel that giving one non governmental entity too much power blurs the line between state and private interests. The deletion of an authorized administrator should be reconsidered to ensure that government oversight is maintained. As stated in a previous hearing there was no definition of authorized individual. We would like to suggest the following people have access provided they request access to the ag commissioner and he grants it in writing.

SECTION 2. AMENDMENT. Subsection 1 of section 4.1-72-06 of the North Dakota Century Code is amended and reenacted as follows: 1. Except as provided in subsection 2, any information created, collected, or maintained by the state veterinarian or the North Dakota stockmen's association, or an authorized administrator with written permission from the agriculture commissioner, with respect to the administration of any federally sponsored program pertaining to livestock as permitted by section 4.1-72-05 is confidential and not subject to the open records requirements of section 44-04-18.
