However, there are always going to be situations in which there could be no winning outcome. And often in those scenarios there are families who are grieving that may want to put the blame somewhere, whether it is fair or not to do so.

The job of being a first responder is intensely stressful, the secondary trauma can often result in PTSD for those who work it, and the added stress that any mishap could result in personal liability is at least one thing we can remove from the equation. The bill doesn't protect for situations where our first responders are clearly at fault but does give peace of mind for the folks doing some of the most difficult work in this state. And that's why I support this.

Ensuring legal protections for 988 and 211 employees aligns with best practices seen in other essential public services, such as emergency medical response and law enforcement. Just as these professionals receive legal protections while carrying out their duties, 988 responders should have similar safeguards to continue their critical work without undue legal vulnerabilities.

Liability protections for 988 and 211 services would safeguard these essential helplines, their operators, and, most importantly, the individuals who rely on them during their most vulnerable moments.

Last year alone, FirstLink fielded tens of thousands of interactions, underscoring the essential role these helplines play in our crisis response system. However, without proper liability protections, these services remain vulnerable to financial and legal risks that could threaten their effectiveness and accessibility.

Crisis call specialists are required to make split-second, high-pressure decisions while offering critical support. Their work is governed by rigorous national accreditation standards—Inform USA and the American Association of Suicidology (AAS)—as well as the Vibrant Network Agreement, which aligns with best practices set by the Substance Abuse and Mental Health Services Administration (SAMHSA). Despite their adherence to research-backed methodologies, every crisis presents unique challenges, and adverse outcomes can still occur. The risk of legal action not only jeopardizes FirstLink's financial stability but may also deter individuals from seeking the support they need due to concerns about unintended consequences.

By enacting liability protections, we can strengthen public trust in these vital services and ensure their sustainability. Call specialists will feel secure in their roles, allowing them to provide compassionate, professional assistance without fear of legal repercussions. Additionally, these protections will aid in the recruitment and retention of highly qualified individuals, reinforcing the resilience of our crisis intervention infrastructure.

Similar legal protections already exist for emergency medical personnel and law enforcement officers. It is both fair and necessary to extend these same safeguards to 988 and 211 responders, enabling them to continue their life-saving work without undue legal exposure.

Providing liability coverage for those who offer crisis support is not only a sound policy decision—it is a moral obligation. By supporting SB 2145, we can protect these critical services, safeguard the professionals who staff them, and ensure continued assistance for individuals in their most vulnerable moments.

My name is Jeremy Brown, and I am the Director of Data Quality at FirstLink. I am testifying in support of SB 2145, which provides immunity to employees of the 988 Suicide & Crisis Lifeline, 211 Information & Referral Helpline, and the 911 system.

988 and 211 are both answered locally in North Dakota by FirstLink. These phone lines are available 24 hours a day, 365 days a year to provide supportive listening, access to local resources, deescalation of crisis, and safety planning during instances of suicide, substance use, self-harm, or other potentially life-threatening situations. Without liability protection, the crucial support provided by our team of well-intended, well-trained, compassionate individuals remain vulnerable to legal and financial risks that could limit their ability to offer help to those in need.

At FirstLink, beyond the numerous accreditations our agency holds and over 50 years of experience assisting individuals facing a crisis, our agency has a meaningful relationship with Vibrant Emotional Health, the agency which oversees the national 988 Suicide & Crisis Lifeline network. As part of the 988 Lifeline network, FirstLink must adhere to the Vibrant Network Agreement, which provides procedures and protocols for navigating crisis situations of all types, with the goal to deescalate, safety plan, and resolve by phone. To meet the requirements of this agreement, our staff are supported through a lengthy and rigorous training curriculum including nationally accredited training programs for suicide intervention. This combination of training and guiding procedures enables our staff to provide life-saving support utilizing their skills, judgement, and resources. However, every crisis is unique, and adverse outcomes can still occur.

Providing liability protections would ensure our Call Specialists feel confident in their ability to provide compassionate, professional support without fear of legal repercussions. This would naturally help FirstLink, and 911 dispatch centers across the state, attract and retain qualified, passionate individuals for these roles, strengthening our crisis response and intervention system in North Dakota.


