Please support North Dakota Senate Bil 2155 – Relating to Gratis Antelope Licenses

My name is Jeff Benda, a proud North Dakota resident, outdoor writer, wild game chef, and avid outdoorsman. I am writing to voice my full support for Senate Bill 2155, which seeks to restore fairness and opportunity in pronghorn antelope tag allocations in our state.

North Dakota's pronghorn antelope is a treasure of our Great Plains, a species that has inspired generations of hunters like me to connect with the land. Yet, under the current allocation system, the odds of drawing a tag are heavily skewed. The practice of reserving the first 50 tags in each unit for landowners, coupled with a disproportionate distribution of remaining tags, leaves the majority of public hunters—our children, grandchildren, nephews, nieces, co-workers, and friends—at a significant disadvantage. In some units, over 90% of the tags go to landowners. This imbalance limits access for the broader hunting community and threatens the traditions that define North Dakota's outdoor heritage.

By eliminating the preferential allocation of the first 50 tags to landowners and establishing a straight 50/50 split, this bill would return some fairness back to the lottery process.

Consider this - In 2024, over 1,000 North Dakota residents with 8 or more bonus points were not able to get drawn for a pronghorn antelope tag. That means a North Dakotan has a better chance to get drawn for an antelope tag in dozens of hunting units in Wyoming vs. their home state!

Why should landowners who live out in western North Dakota where the antelope roam have the only opportunity to hunt antelope? Why are we excluding the diesel mechanic, public school teacher, nurse, or even the hard-working young farmer who lives east of Bismarck?

SB 2155 makes it both equitable and essential to maintain the integrity of our hunting culture. Being able to hunt out wildlife is the birthright of every North Dakotan – every American! Hunting is more than a pastime; it is a way to teach responsibility, patience, and respect for the natural world. But if the opportunities to hunt pronghorn antelope continue to diminish for the average resident, we risk losing a vital part of our state's identity.

I have been fortunate to draw a pronghorn tag and experience the thrill of pursuing this incredible animal on North Dakota's open landscapes. Now, I dream of the day when my 9-year-old daughter can have the same chance. But under the current system, the odds are stacked against her. Senate Bill 2155 is a step toward a future where every young hunter can share in the opportunities that shaped the lives of those who came before them.

Hunter and conservationist Randy Newberg once said, "Hunting is not just something we do; it's who we are." This bill reflects that truth. It's not just about increasing the odds of drawing a tag; it's about preserving the values of fairness, access, and shared responsibility for our wildlife.

I urge you to pass Senate Bill 2155 and ensure that the pronghorn antelope remains a symbol of opportunity and connection for all North Dakotans. Together, we can uphold the principles of conservation and equity that make our state's hunting heritage truly great.

Testimony Opposing SB2155

Chairman Patten and Energy and Natural Recourses Committee

My name is Jeremy Maher, and I am a farm and ranch owner in Sioux County, ND. I am here today to oppose SB2155.

This bill proposes reducing the number of gratis tags available to landowners to a strict 50% of the number of buck tags issued. In Unit 6A, this would mean over half of the landowners who applied for a tag in 2024 would not have received one—25% more than last year. For those of us who live and work on the land, this is a significant and unnecessary burden.

If antelope populations were to increase, this issue could resolve itself because the number of tags available would exceed the demand for gratis applications—just as we currently see with deer. However, until that happens, this bill penalizes landowners, making it even harder for us to access the species we help support through responsible land management.

This legislation directly contradicts ongoing efforts by Game and Fish, as well as other groups, to foster positive relationships between landowners and hunters. What incentive is there for a landowner to allow others to hunt on their property when they cannot hunt the species themselves? SB2155 creates division rather than collaboration and will result in fewer open gates for hunters.

I urge you to reject SB2155 to protect the interests of landowners and the collaborative spirit necessary for effective wildlife management.

Im giving testimony, opposing, SB2155.

I will use my 2024, antelope application, as example for my opposition.

Im a farm/ranch owner in Sioux Co, which is in antelope unit 6A. This is a big unit of approx. 3700 sq. miles. So there are a lot of landowners in this unit.

In 2024, I applied for the gratis license but did not get drawn. There were 100 tags, in that unit, and over 100 landowners applied. With the present setup, G&F gives 50% gratis tags. When there are more gratis apps than tags they allow another 50% of the number off apps over the original 50% mark but the landowners have to go into a lottery against each other. So they gave 75 gratis tags of the 100 available. Since there was more landowners, than tags, we had to go into a lottery against each other. Hence the reason I did not get drawn.

SB2155 will make it even harder for landowners to get a license. This bill wants to reduce the number to a straight 50% of the number of buck tags. So in 6A, over half of the landowners, that applied, would not have gotten a tag. (25% more than in 2024)

I believe the G&F use the same system for deer but its not an issue there as there are a lot more tags offered, so the amount of landowners applying never get to 50%.

Antelope numbers are a lot lower but making a comeback. I would have to say that landowners have more to do with this than anyone.

If antelope numbers go up this whole issue goes away when 50% of the tag number is more than the number of gratis applications. (as it is with deer already)

FYI- The Standing Rock Reservation is also inside this unit. In 2024 the SR G&F put out over 200 tags for the reservation. The Standing Rock reservation is inside boundaries of 6A but only makes up 1/3 of the 6A unit. These 200 + tags are not considered in the ND G&F system.

I realize it is not easy for, non-landowners, to get an antelope tag when numbers are low. For example, my children, have been applying for over 6 years and still have never drawn a tag. I wouldn't even be on the same playing field, as them, as they have 6 years of preference points built up and I will be starting from scratch. At least with the gratis tag we are allowed to at least enjoy one tag on our land.

You hear all the time that G&F, and other groups, are trying to improve landowner-hunter relationships. This bill will do the opposite. What incentive is there for a landowner, who hunts, to let others hunt a species, on his land, that he is not able to hunt himself.

Passing this bill will close gates.

North Dakota Bowhunters Association

The North Dakota Bowhunters Association certainly supports the Landowner – free of charge (gratis) program. In the case of Pronghorn, its simply time for an update.

The current language being used to provide the Pronghorn landowner opportunity is very outdated. When Pronghorn numbers were high, landowners, non-landowners, and Archers, all enjoyed hunting for one of these fine animals. Drawing a tag was relatively easy and animals were plentiful. Since about 2009, Pronghorn numbers have been much lower and the numbers we have now seem to be staying consistent. For the non-landowner, drawing a Pronghorn tag these days is next to a once in a lifetime opportunity. In most hunting units, Landowner tags simply outnumber and use up all of the available allotment, leaving very few, if any, for the average sportsman. It could take 10 to 15 years for a non-landowner to draw a Pronghorn tag in North Dakota.

SB 2155 is aimed at updating and providing an equal opportunity to both the landowner as well as the sportsman. Right now is a good time to make a change and we encourage you to agree.

- 1 A BILL for an Act to amend and reenact subsection 5 of section 20.1-03-11 of the North Dakota
- 2 Century Code, relating to gratis antelope licenses.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Subsection 5 of section 20.1-03-11 of the North Dakota
 Century Code is amended and reenacted as follows:
 - A resident that is an individual, corporation, limited liability company, limited 5. liability partnership, limited partnership, partnership, trust, or life estate, and has executed a lease for at least one hundred fifty acres [60.70 hectares] of land that the resident actively farms or ranches; or a resident that is an individual, corporation, limited liability company, limited liability partnership, limited partnership, partnership, trust, or life estate, and holds title to at least one hundred fifty acres [60.70 hectares] of land, is eligible to submit one application for a license to hunt antelope without charge upon filing a signed application describing that land. The land must be within a unit open for the hunting of antelope. The license must include a legal description of the eligible land described in the completed application and may be used to hunt antelope only upon that land. Upon request, a lessee shall provide proof that the land described in the completed application is leased for agricultural purposes. If not otherwise specified in an agricultural lease, the landowner is entitled to receive the license. An individual licensed under this subsection must be a resident.

- b. If the eligible applicant is a corporation, limited liability company, limited liability
 partnership, limited partnership, partnership, trust, or life estate, only one license
 may be issued, and the license must be issued in the name of an individual
 shareholder, member, partner, beneficiary, or holder of a life estate.
 - c. A resident who is eligible for a license under this subsection may transfer that eligibility for the license to a spouse or legal dependent residing customarily with the resident, but no more than one license may be issued under this subsection for any qualifying land. A resident transferring eligibility under this subsection may not receive a license under this subsection for the season for which eligibility was transferred. If not otherwise specified in an agricultural lease, the landowner is entitled to receive the license.
 - d. The number of licenses issued without charge under this subsection may not exceed the total numberone-half of buckthe number of licenses of any pronghorn license type prescribed for each district or unit in the governor's proclamation. If the number of eligible persons who apply for licenses issued without charge under this subsection exceeds the number of licenses prescribed for the district or unit in the governor's proclamation less any licenses that are otherwise designated to be issued with a charge under this subsection, the licenses to be issued without charge must be issued by lottery as prescribed in the governor's proclamation. If the number of licenses prescribed for the district or unit in the governor's proclamation exceeds fifty and if the number of applications for these licenses exceeds the number of licenses prescribed for the district or unit in the governor's proclamation, then one-half of the licenses exceeding fifty must be issued by lottery as prescribed in the governor's proclamation and may not be issued to landowners without charge.

Dear Chair Patten and Members of the Committee:

I am here to present SB 2155 for your favorable consideration.

Purpose of the Bill - This bill seeks to amend state law to ensure a more equitable distribution of pronghorn hunting licenses between landowner (gratis) hunters and non-landowner hunters.

Current Law and Issues—Under the current system, the first 50 of any pronghorn license type in each unit are reserved exclusively for gratis hunters, with the remaining licenses split evenly. This has resulted in some units only allocating 5% of the licenses to nonlandowners, making it a decade-long wait for someone who doesn't own land to be selected for a license.

Proposed Changes - This bill would establish a consistent 50/50 allocation of buck pronghorn licenses between landowner and non-landowner hunters.

Anticipated Impact—As there is a smaller pool of gratis hunters applying for licenses, they will still have a much higher likelihood of drawing a license relative to non-landowner hunters, but this change will result in a more even distribution. Additional testimony from supporters of the bill will highlight other data about how this will impact North Dakota hunters.

Amendment - Included is an amendment to clarify that this bill does not eliminate the lottery system for licenses. I support this amendment and believe it provides important clarification.

Thank you for considering this legislation. I respectfully ask for a "Do-Pass" recommendation. I am available to provide additional information or answer any questions.

My name is Kent Reierson from Williston, ND. I am writing in support of SB2155. This legislation would improve the fairness of antelope tag allocation. This is simply a matter of correcting an inequitable situation that has developed due to decreasing antelope numbers and tags. Hopefully, numbers will continue to increase as they have for the past several years due to the milder winters. This Bill will create slightly more equal access to a public resource. When antelope numbers were higher and there were more tags this allocation was not such an issue. While the system was still highly weighted in favor of the landowner it did not lock non landowners, the majority of the antelope tag applicants, out of possibly drawing a tag.

While landowner relations are extremely important, so is basic fairness in allocating a public resource. No one can look at the current system and believe it is a fair allocation. In some units, landowners can get a tag every year, gratis, and receive the bulk of the allocation. In western ND many of the antelope are on public land and the public cannot draw a tag to access that resource.

It has been over a decade since I was able to draw a tag as I have 11 points. Being 70 years old now, I hope it is not another decade before I am able to draw a tag.

The adoption of the provisions in this bill, will still weigh heavily in favor of the landowner and that is acceptable to the majority of non-landowner sportsmen. But it will at least give non-landowner applicants a more equitable chance at some of the tags. I hope you can see the unfairness of the present allocation and take some steps to reduce the inequity of the current allocation by passing this bill.

My name is Steve Goroski, and I am a long-time North Dakota resident, avid sportsman, bowhunter and conservationist of ND for almost 50 years. I am writing to express my strong support for Senate Bill 2155, which would restore equitable fairness of the pronghorn antelope lottery process by the ND Game and Fish.

Back around 2009 the bowhunters of North Dakota had to give up the opportunity at an archery only tag available each year after a serious decline in numbers across the state. We were accepting of this change due to the lower number of animals found on the landscape and remains the same 15 years later. The bowhunters ultimately had a much lower success and did not impact the overall harvest by rifle hunters.

The current lottery process for gratis applications has been around longer than anyone currently at the ND Game and Fish can remember why it was even set to the current format. While I respect the rights of landowners to receive tags, it is essential to ensure that public hunters have equitable access to pronghorn hunting opportunities.

By eliminating the preferential allocation of the first 50 tags to landowners and establishing a straight 50/50 split, this bill would return some fairness back to the lottery process. I believe this bill strikes a fair balance between landowner privileges and public hunting opportunities. While also allowing the ND Game and Fish to further open additional areas of opportunity that may have fewer than 50 licenses available allowing the public a chance at drawing a tag and not just for those eligible for a gratis opportunity.

I was able to draw my last tag after 16 years of applying and fully expect my next tag to take over 20 years if I am even still around or capable of enjoying the experience once again. I appreciate you taking the time to read this testimony and hope that you will consider 'change' for the future of SB 2155.

TESTIMONY OF BROCK WAHL NORTH DAKOTA BACKCOUNTRY HUNTERS AND ANGLERS SENATE BILL 2155 SENATE ENERGY AND NATURAL RESOURCE COMMITTEE January 23, 2025

Chairman Patten and members of the Senate Energy and Natural Resource Committee

The North Dakota Chapter of Backcountry Hunters and Anglers asks for a "Do Pass" recommendation on SB 2155.

Currently, North Dakota Century Code dictates that the first 50 tags in each unit are required to go to gratis tags, with remaining tags allocated as 50/50 split. In some units, this has resulted in 95% of the "any pronghorn" tags being allocated as gratis tags. Several other units can see 60-70% or more of those same tags go to gratis.

This is purely a function of the number of tags available. If pronghorn numbers were significantly higher, then this entire conversation would be irrelevant. However, pronghorn numbers are down significantly across the entire country due to many factors. With that being said, it is our stance that the current tag allocation system is not representative of a fair distribution of tags for North Dakota's pronghorn resource.

Senate Bill 2155 seeks to balance the scales of Pronghorn tag allocation by codifying a straight 50/50 split for the tag type "any pronghorn". In 2024, this bill would've meant that 172 "any pronghorn" tags went into the hands of the resident North Dakotans who have waited, in most cases, over a decade for that hunting opportunity. North Dakota resident hunters, who all own an equal share of North Dakota's wildlife, deserve a fair distribution of tags on a limited public resource.

After all, it is written in North Dakota Century code Section 20.1-03-03, "The ownership of and title to all wildlife within this state is in the state for the purpose of regulating the enjoyment, use, possession, disposition, and conservation thereof..." and "The state has a property interest in all protected wildlife."

We support the amendments and urge a "Do Pass" to the committee.



Weve seen in other states how emotional decisions have thrown wildlife management awry when popular vote overrides professional opinion (predators overpopulated ect.), I believe there is a better more common sense way forward here.

John Torfin Mandan, ND Senate Energy and Natural Resources Committee,

I am writing today to express my support for SB2155 and encourage you to give this bill a "Do Pass" recommendation.

Hunting pronghorn in North Dakota is a highly sought after experience with demand (unfortunately) outweighing supply. Many non-landowners will wait 10 years or more to draw a license allowing them to hunt a buck antelope while some landowners are able to draw one annually. With pronghorn populations low and license demand high, the current gratis system needs to be amended. SB2155 is a good start to that process.

The current system allows the first 50 buck licenses to be allocated to landowners owning land in the hunting unit. Due to consistently low pronghorn populations, several units see more licenses go to landowners than non-landowning applicants, despite a majority of applications coming from non-landowners. This bill will not eliminate opportunities for landowners to have licenses allocated to them. Rather, it will make the number of landowner tags equal to 50% of the total buck tags allocated in that unit.

Thank you for considering my testimony and please give SB2155 a "Do Pass" recommendation.

Joseph Doll Bismarck, ND Dear Members of the Energy and Natural Resources Committee,

I am writing in strong support of SB 2155 regarding pronghorn, or antelope, gratis tag allocations. The current allocation method is not an equitable distribution of a public resource, particularly due to the limited tags available. Both landowners and the public need to be considered when considering gratis tag distributions. Private landowners have to deal with wildlife year round at an expense to them. In addition, in most cases they are providing the access needed to allow the public to hunt. At the same time, wildlife are a public resource. The proper distribution of tags can be extremely subjective, but I do think the current antelope distribution needs adjustment.

The current allocation allows landowners to receive the first 50 tags and then 50 percent of the remaining. SB 2155 would result in the gratis allocation being capped at a straight 50 percent, which is in line with the deer gratis allocation. Due to antelope in North Dakota being on the edge of their range, we will never have huge populations and they will always be subject to population swings from harsh winters. Antelope fall well short of the tag availability of deer. Instead they lie somewhere between deer and the once in a lifetime tags of elk and moose. The latter only allow for 15 percent of the tags to be allocated to gratis. I do not see a reason why antelope would have the highest tag percentage of gratis tag allocation for any of the big game animals in the state.

Unit tag availability for antelope is often under 100 in most units of the state. Gratis tags frequently end up taking a large majority of the tags available. For example, in unit 8A and 9A last year, there were 55 tags available in each. Due to the current allocation, 52 of the 55 tags went to gratis. The remaining three tags had 259 and 446 North Dakota residents applying for them. High percentages of tags going to gratis occurred in multiple other units last year and happens every year. I believe most of the general public are unaware of how few tags they are really vying for.

Now is the time to adjust the antelope gratis tag allocation to bring it in line with the deer drawing and give the general public a better opportunity to hunt.

TESTIMONY OF JOHN BRADLEY NORTH DAKOTA WILDLIFE FEDERATION SENATE BILL 2155 SENATE ENERGY AND NATURAL RESOURCES COMMITTEE JANUARY 23, 2025

Chairman Patten and Members of the Senate Energy and Natural Resources Committee:

For the record, I am John Bradley, Executive Director of the North Dakota Wildlife Federation (NDWF). NDWF is supportive of SB 2155 and the amendment language that was introduced.

This bill would ensure a more equitable distribution of pronghorn hunting licenses between gratis hunters and general lottery hunters when antelope populations are low. Currently, the first 50 of any pronghorn tags in each unit are reserved exclusively for gratis, with the remaining licenses split evenly between gratis and the general lottery. For example, if a unit had 54 tags available, the current system would allocate 52 out of the 54 tags to gratis hunters. The results? A potentially decade-long wait for the general public hunter in that unit to be selected for a license.

This bill would establish a consistent 50/50 allocation of pronghorn licenses between landowner and non-landowner hunters. As there is a smaller pool of gratis hunters applying for licenses, they will still have a much higher likelihood of drawing a license relative to the general lottery hunter, but this change will result in a more even distribution. If populations of pronghorn rebound, the gratis holders would return to getting drawn almost every year, if not every year, and the public would also have an increased opportunity.

We respectfully ask for a Do-Pass recommendation.



House Energy and Natural Resources Committee - Testimony in support of SB2155 Relating to Gratis Antelope Licenses

Chairman Porter and members of the House Energy and Natural Resources Committee. My name is Steve Goroski, and I am a long-time North Dakota resident, avid sportsman, bowhunter and conservationist of ND for almost 50 years. I am writing to express my strong support for Senate Bill 2155, which would restore equitable fairness of the pronghorn antelope lottery process by the ND Game and Fish.

Back around 2009 the bowhunters of North Dakota had to give up the opportunity at an archery only tag available each year after a serious decline in numbers across the state. We were accepting of this change due to the lower number of animals found on the landscape and remains the same 15 years later. The bowhunters ultimately had a much lower success and did not impact the overall harvest by rifle hunters.

The current lottery process for gratis applications has been around longer than anyone currently at the ND Game and Fish can remember why it was even set to the current format. While I respect the rights of landowners to receive tags, it is essential to ensure that public hunters have equitable access to pronghorn hunting opportunities.

By eliminating the preferential allocation of the first 50 tags to landowners and establishing a straight 50/50 split, this bill would return some fairness back to the lottery process. I believe this bill strikes a fair balance between landowner privileges and public hunting opportunities. While also allowing the ND Game and Fish to further open additional areas of opportunity that may have fewer than 50 licenses available allowing the public a chance at drawing a tag and not just for those eligible for a gratis opportunity.

TESTIMONY OF BROCK WAHL NORTH DAKOTA BACKCOUNTRY HUNTERS AND ANGLERS SENATE BILL 2155 HOUSE ENERGY AND NATURAL RESOURCE COMMITTEE March 7, 2025

Chairman Porter and members of the House Energy and Natural Resource Committee

The North Dakota Chapter of Backcountry Hunters and Anglers asks for a "Do Pass" recommendation on SB 2155.

Currently, North Dakota Century Code dictates that the first 50 tags in each unit are required to go to gratis tags, with remaining tags allocated as 50/50 split. In some units, this has resulted in 95% of the "any pronghorn" tags being allocated as gratis tags. Several other units can see 60-70% or more of those same tags go to gratis.

This is purely a function of the number of tags available. If pronghorn numbers were significantly higher, then this entire conversation would be irrelevant. However, pronghorn numbers are down significantly across the entire country due to many factors. With that being said, it is our stance that the current tag allocation system is not representative of a fair distribution of tags for North Dakota's pronghorn resource.

Senate Bill 2155 seeks to balance the scales of Pronghorn tag allocation by codifying a straight 50/50 split for the tag type "any pronghorn". In 2024, this bill would've meant that 172 "any pronghorn" tags went into the hands of the resident North Dakotans who have waited, in most cases, over a decade for that hunting opportunity. North Dakota resident hunters, who all own an equal share of North Dakota's wildlife, deserve a fair distribution of tags on a limited public resource.

After all, it is written in North Dakota Century code Section 20.1-03-03, "The ownership of and title to all wildlife within this state is in the state for the purpose of regulating the enjoyment, use, possession, disposition, and conservation thereof..." and "The state has a property interest in all protected wildlife."

We support the amendment and urge a "Do Pass" to the committee.



Hunting pronghorn in North Dakota is a highly sought after experience with demand (unfortunately) outweighing supply. Many non-landowners will wait 10 years or more to draw a license allowing them to hunt a buck antelope while some landowners are able to draw one annually. With pronghorn populations low and license demand high, the current gratis system needs to be amended. SB2155 is a good start to that process.

The current system allows the first 50 buck licenses to be allocated to landowners owning land in the hunting unit. Due to consistently low pronghorn populations, several units see more licenses go to landowners than non-landowning applicants, despite a majority of applications coming from non-landowners. This bill will not eliminate opportunities for landowners to have licenses allocated to them. Rather, it will make the number of landowner tags equal to 50% of the total buck tags allocated in that unit.

TESTIMONY OF JOHN BRADLEY NORTH DAKOTA WILDLIFE FEDERATION SENATE BILL 2155 HOUSE ENERGY AND NATURAL RESOURCES COMMITTEE MARCH 7, 2025

Chairman Porter and Members of the Energy and Natural Resources Committee:

For the record, I am John Bradley, Executive Director of the North Dakota Wildlife Federation (NDWF). NDWF is supportive of SB 2155.

This bill would ensure a more equitable distribution of pronghorn hunting licenses between gratis hunters and general lottery hunters when antelope populations are low. Currently, the first 50 of any pronghorn tags in each unit are reserved exclusively for gratis, with the remaining licenses split evenly between gratis and the general lottery. For example, if a unit had 54 tags available, the current system would allocate 52 out of the 54 tags to gratis hunters. The results? A potentially decade-long wait for the general public hunter in that unit to be selected for a license.

This bill would establish a consistent 50/50 allocation of pronghorn licenses between landowner and non-landowner hunters. As there is a smaller pool of gratis hunters applying for licenses, they will still have a much higher likelihood of drawing a license relative to the general lottery hunter, but this change will result in a more even distribution. If populations of pronghorn rebound, the gratis holders would return to getting drawn almost every year, if not every year, and the public would also have an increased opportunity.

NDWF would like to see the amended language that was added from the Senate regarding landowners being automatically entered into the general pronghorn lottery removed. The way the amended language is written would force the Department to create a new system to hold the lottery. It would also be unclear if the bonus points from the gratis lottery would carry over to the general lottery and vice versa.

The "must" language in the bill could also create frustration with landowners who would now have to enter credit card information and potentially pay for the license if drawn. The simplest fix would be to remove the language (lines 26-29) from the amendment. At a minimum, changing "must" to "may" would give the landowner the option of entering the general lottery if not selected in the gratis lottery.

We respectfully ask for a Do-Pass recommendation after addressing lines 26-29.

This bill is not asking for anything dramatic; only to put a few more tags into your average hunters hands.

Landowners will still enjoy their more than fair share considering that THEY DO NOT OWN THE ANIMALS IN QUESTION.

Some are making this bill out to be infringing on landowners rights. I ask, which rights are those?

The animals subject to this bill ARE OWNED BY EVERYONE.

Landowners will still have first dibs on tags. I understand that landowners often have to "deal" with the wildlife on their property. They will still enjoy a great benefit.

Lastly, the attention seems to be on angering landowners; what about North Dakota hunters? Do no legislators here care about them or are willing to fight their rights? They have just as much of a right to harvest these animals as landowners do.

There's a reason we use the North American Model of Wildlife Management; because it works for EVERYONE. Striking out the relevant language in this bill is a step closer to that model, and AWAY from the European Model, where landowners own the wildlife, and access to these animals requires a fat stack of cash. We're better than that.

Support your average Joe North Dakota hunter by putting a few more pronghorn tags in their pockets.

- SECTION 1. AMENDMENT. Subsection 5 of section 20.1-03-11 of the North Dakota 4 Century Code is amended and reenacted as follows: 5
- 6 A resident that is an individual, corporation, limited liability company, limited 5. a. liability partnership, limited partnership, partnership, trust, or life estate, and has 7 executed a lease for at least one hundred fifty acres [60.70 hectares] of land that 8 9 the resident actively farms or ranches; or a resident that is an individual, corporation, limited liability company, limited liability partnership, limited 10 partnership, partnership, trust, or life estate, and holds title to at least one 11 hundred fifty acres [60.70 hectares] of land, is eligible to submit one application 12 for a license to hunt antelope without charge upon filing a signed application 13 describing that land. The land must be within a unit open for the hunting of 14 antelope. The license must include a legal description of the eligible land 15 described in the completed application and may be used to hunt antelope only 16 upon that land. Upon request, a lessee shall provide proof that the land described 17 in the completed application is leased for agricultural purposes. If not otherwise 18 specified in an agricultural lease, the landowner is entitled to receive the license. 19 An individual licensed under this subsection must be a resident. 20

- b. If the eligible applicant is a corporation, limited liability company, limited liability partnership, limited partnership, partnership, trust, or life estate, only one license may be issued, and the license must be issued in the name of an individual shareholder, member, partner, beneficiary, or holder of a life estate.
- c. A resident who is eligible for a license under this subsection may transfer that eligibility for the license to a spouse or legal dependent residing customarily with the resident, but no more than one license may be issued under this subsection for any qualifying land. A resident transferring eligibility under this subsection may not receive a license under this subsection for the season for which eligibility was transferred. If not otherwise specified in an agricultural lease, the landowner is entitled to receive the license.
- d. The Except as provided in paragraph 2, the number of licenses issued without charge under this subsection may not exceed the total number one-half of the number of licenses of any pronghorn license type prescribed for each district or unit in the governor's proclamation.
 - (1) If the number of eligible persons who apply for licenses issued without charge under this subsection exceeds the number of licenses prescribed for the district or unit in the governor's proclamation less any licenses that are otherwise designated to be issued with a charge under this subsection, the licenses to be issued without charge must be issued by lottery as prescribed in the governor's proclamation. If the number of licenses prescribed for the district or unit in the governor's proclamation exceeds fifty and if the number of applications for these licenses exceeds the number of licenses prescribed for the district or unit in the governor's proclamation, then one half of the licenses exceeding fifty must be issued by lottery as prescribed in the governor's proclamation and may not be issued to landowners without charge.
 - (2) If an eligible person is unsuccessful in receiving a license without charge under paragraph 1, the application for a license without charge must may be included in a lottery for remaining licenses issued for the district or unit as prescribed by the governor's proclamation.
