Chair Lee, and members of the Senate Human Services Committee, my name is Kim

Jacobson. I am the Director for the Agassiz Valley Human Service Zone, which includes the

counties of Traill and Steele. In addition, I serve as Vice-Chair of the North Dakota Children's

Cabinet. I am here today to provide testimony in support of SB 2176.

The North Dakota Children's Cabinet was first established during the 66th Legislative

Assembly (SB 2313). The Children's Cabinet consists of fourteen members. As an inaugural

member of the cabinet, I have served since inception with the first meeting being held in

November 2019.

The Children's Cabinet role is to assess, guide, and coordinate care across branches of

state government and tribal nations. This is a significant responsibility and one that the cabinet

has taken with great duty. The cabinet meets each month, and we learn about children's system

needs and trends. We have heard about service gaps, challenges, and innovations. In addition,

the Children's Cabinet has been diligently working on how to best employ the responsibility

provided and to make a difference.

Over the last several years, the Children's Cabinet has been focused on studying other

Children's Cabinet models in the United States to help guide our effectiveness and ability to

impact. In result, a charter and strategic plan was developed and finalized in 2024. This is the

road map to help guide the vision, mission, and goals of the Children's Cabinet. SB 2176 is a

critical piece to support the work of the cabinet.

SB 2176 offers stability by relocating the staffing and administrative services from the department of health and human services to the office of the governor. We learned through our work over the past several years that the most impactful Children's Cabinets in the United States are located within their respectful governor's office. This supports a multidisciplinary approach and insight with governor's office priority setting. I believe that this would be an impactful change for North Dakota.

Despite the North Dakota Children's Cabinet meeting each month, there is much work to be done. The addition of designated working groups is critical to supporting the efforts of the cabinet. Workgroups would allow for focused study of assigned topics, could engage a larger span of those with subject-matter expertise and lived life experience to bring workgroup findings and recommendations before the Children's Cabinet. This concept allows for more effective work, reduction of systems conflict, while increasing the probability of positive outcomes.

There has already been at least one example of how a topic could be brought forward to the Children's Cabinet through a workgroup concept this legislative session. The testimony of Lynn Flieth, RSR Service Zone Director on HB 1095 called for collaborative work related to child protective services. She states that "because Child Protection Service activities transcend any single entity, and rely upon a community response, the original intent of this bill (HB 1095) may be more comprehensively and appropriately addressed in a coordinated effort through a statewide approach, perhaps through the Children's Cabinet. It would be beneficial to be inclusive of other service providers, law enforcement and the legal community along with the Child Protection system and schools to enhance understanding, strengthen systems, and to optimally support children and their families." This is just one example of ways that the changes proposed in SB 2176 could bring systems together to help build stronger support, wise investments, and improve care to North Dakota children.

I respectfully ask the committee for consideration of amendment. I ask for consideration for the appointment of a human service zone director (legal custodian of foster children in the public child welfare system) to be a standing member appointee on the cabinet. This would ensure a voice for one of our most vulnerable groups of children on the cabinet. Furthermore, I recommend to the committee consideration that one of the appointees listed on Page 2, line 5 be dedicated to a parent. While many of the professionals appointed to the cabinet are parents, it is a dual role. It would be beneficial for the cabinet to have a member whose primary appointment role is to represent the perspective of a parent.

Good morning, Senator Lee and members of the Senate Human Services Committee. For the record, my name is Michelle Strinden, Lieutenant Governor for the State of North Dakota. I am here to provide our support for SB 2176, which proposes to move the administration of the Children's Cabinet into the Office of the Governor.

- I served as chair of the cabinet for nearly two years.
- During that time, I recognized the need for intentional focus and support to drive the cabinet to support children's systems.
- Moving the cabinet's administration within the Governor's Office will place additional focus on the cabinet and accelerate progress for children and families.
- We've partnered with an external consulting service that supported the development of a strategic plan and actionable goals.
- Working with the consultants, we'll continue to develop measures of success and working groups to dive deeper into issues across juvenile justice, child welfare, mental health continuum, education, early childhood and much more.
- Both the previous and current administrations have been engaged in supporting this effort. Both budget proposals included a line item that supports the cabinet with consultants and costs related to meetings, administration, document preparation, and other expenses.

• The Armstrong budget recommends \$100,000 dollars, including \$65,000 to support the cabinet's administration with facilitation consultants and \$35,000 in ongoing appropriations for supportive services to continue the cabinet's efforts.

I would like to introduce Meghan McCann and Dana Kunzman with The Forum of Youth Initiative to walk through the national landscape of state Children's Cabinets and walk through the North Dakota strategic plan.

Good morning, Chair Lee and members of the Senate Human Services Committee. For the record, my name is Michelle Axtman, Senator from District 7. As a member of the Children's Cabinet for two years and a recent appointment as Chair, I am here to provide supportive testimony for Senate Bill 2176.

For some history, the Children's Cabinet was established in 2019 by Senate Bill 2313. The intent of the cabinet is to support cross-agency collaboration and service delivery to improve outcomes for children and families. You will hear later from Forum for Youth Initiative on cabinets across various states and different structures and governance within government. The intent of this bill is to move the Children's Cabinet, which is currently administered within the Department of Health & Human Services, into the Office of the Governor. As you can see, the entire bill is underlined as it will be a new section to chapter 54-07 of North Dakota Century Code.

I am now going to walk through the changes noted in this bill by sections.

Section 1, Subsections 1 and 2: This language is consistent with what is currently in law regarding the membership, I believe Senator Hogan will be discussing some proposed amendments later.

Section 1, Subsection 2 g.: Clarifies that the commissioner is from the department of health and human services.

Section 1, Subsection 2 i.: Changes department to the governor's office.

Section 1, Subsection 3: Changes "chairman of legislative management" to "the governor, in collaboration with the chairman of legislative management"

Section 1, Subsection 5 a.: Adds "and families"

Section 1, Subsection 5 i.: Adds "Establish and oversee designated working groups to develop policies impacting children and families; and"

Section 1, Subsection 5 j, 1 and 2: Adds in "Other designated working groups on children and family issues"

Section 1, Subsection 6: Changes "department" to "office of the governor", "and coordinate with other designated working groups on children and family issues"

Section 1, Subsection 7 a.: Adds "The presiding officer of the children's cabinet may designate working groups and appoint or remove liaisons to serve on the working groups"

Section 2: This repeals the former section in code that had the children's cabinet in 50-06-43.1.

Section 3: Provides an appropriation to support the administration of the children's cabinet and coordinating designated working groups.

This covers the language changes and would like to now ask Lieutenant Governor Michelle Strinden to provide testimony related to her previous role as chair.





Testimony SB 2176 Senate Human Services Committee January 28, 2025

Chairman Lee, for the record, my name is Kathy Hogan. I represent District 21 which is central Fargo and a portion of West Fargo.

The Children's Cabinet is an exciting effort to strengthen collaboration and coordination across all systems to better support children and families. Breaking down silo's both at the state and local level by developing a common vision and values can be very important and can change systems to better serve and support families.

I was on the drafting committee for SB 2176 and regretfully, I forgot to include a change in selection process for the legislative membership, so I have drafted the attached amendment for your consideration. An additional amendment on page 2 was added regarding travel reimbursements because it was duplicative.

A second discussion that was held was regarding lines Section 1 #2 i, regarding the four community at large members. Currently we are blessed to have two people representing local schools, a private agency representative and a zone director. We may want to consider modifying this section to ensure a strong voice for people who interact with a range of children's issues and expertise from the local perspective.

Attached is a copy of the draft amendment. I am more than willing to answer any question.

Executive Summary

North Dakota's Children's Cabinet was created by 2019 Senate Bill No. 2313 to assess, guide and coordinate care for children across North Dakota branches of government and tribal nations. The Cabinet meets monthly to receive information and collaborate on strategies that address gaps and the full continuum of care and delivery of services regarding early care and education, medical and behavioral health, community, child welfare, and juvenile justice issues. This year's annual report describes that work and captures the progress and momentum towards improving outcomes for North Dakota's children and families.

In addition to the work of the North Dakota Children's Cabinet in meeting its statutory responsibilities and planning for the long-term future of our children, the Cabinet identified that a strategic plan and technical assistance was critical to its future success and sustainability. North Dakota became a member of the Forum for Youth Investment's Children's Cabinet Network in the fall of 2023 and the second portion of this report documents its 2024 planning work with the Forum for Youth Investment in helping to illuminate a path forward.

N.D. Cent. Code § 50-06-43.1. Children's cabinet - Membership - Duties - Report

- 1. The children's cabinet is created to assess, guide, and coordinate the care for children across the state's branches of government and the tribal nations.
- 2. The children's cabinet consists of the following members:
 - a. The governor, or the governor's designee;
 - b. The chief justice of the supreme court, or the chief justice's designee;
 - c. A member of the house of representatives from an even-numbered legislative district and a member of the house of representatives from an odd-numbered legislative district appointed by the majority leader of the house of representatives to serve two-year terms;
 - d. A member of the senate from an even-numbered legislative district and a member of the senate from an oddnumbered legislative district appointed by the majority leader of the senate to serve two-year terms;
 - e. The superintendent of public instruction, or the superintendent's designee;
 - f. The director of the committee on protection and advocacy, or the director's designee;
 - g. The commissioner of the department, or the commissioner's designee.
 - h. A representative of the tribal nations in the state, who is appointed by the governor; and
 - i. Four individuals representing parents, private service providers, or other community interests, who are appointed by the governor to serve a term of two years, at the pleasure of the governor, and who are entitled to reimbursement from the department for travel and lodging at the same rate as provided for state officers and employees.
- 3. The chairman of legislative management shall appoint one of the legislative members to serve as the presiding officer of the cabinet. The children's cabinet shall select one of its members to serve as the vice-presiding officer. The cabinet shall meet at least quarterly. Additional meetings may be held at the discretion of the presiding officer.
- 4. The children's cabinet shall:
 - a. Coordinate broad-based leadership across programs, agencies, branches of government, and tribal nations to meet the needs of children:
 - b. Develop strategies to address gaps or needs regarding early care and education, medical and behavioral health, community, child welfare, and juvenile justice;
 - c. Develop strategies to provide for the full continuum of care in the delivery of services, including promotion, prevention, early identification and intervention, service delivery, and recovery;
 - d. Seek to engage cooperation across public and private service providers;
 - e. Provide a comprehensive vision for how and where children are best served, attending to children in a respectful and relevant manner;
 - f. Seek strategies to provide services to children without consideration of prior engagement with juvenile services;
 - g. Provide for the active participation of consumers and providers statewide on advisory committees;
 - h. Receive information and recommendations from the department of health and human services, department of corrections and rehabilitation, and other state agencies; and
 - Provide an annual report to the legislative management and governor regarding the activities and findings of the cabinet.
- 5. The department shall provide the children's cabinet with staffing and administrative services.
- 6. A member of the cabinet who is not a state employee is entitled to reimbursement for mileage and expenses as provided by law for state officers and employees, to be paid by the department. A state employee who is a member of the cabinet is entitled to receive that employee's regular salary and is entitled to reimbursement for mileage and expenses to be paid by the employing agency.

A member of the cabinet who is a member of the legislative assembly is entitled to receive per diem compensation at the rate provided under section 54-35-10 for each day performing official duties of the cabinet. The legislative council shall pay the per diem compensation and reimbursement for travel and expenses as provided by law for any member of the cabinet who is a member of the legislative assembly.

Appendix B: The Forum for Youth Investment's Children's Cabinet Network

No single support or program is enough to ensure children and youth are on track developmentally, educationally, socially, and emotionally. Children's Cabinets are systematically changing the fragmented ways that state and local governments do business for children and youth. Since 2004, The Forum for Youth Investment has engaged with these coordinating bodies to support their operation and share lessons learned with the youth development field.

Unfortunately, the manner in which rules, regulations and government structures are crafted makes it difficult for leaders to create and implement coordinated programs and services that address the comprehensive needs of young people. But there is much that can be done to simplify and untangle the patchwork of polices and funding streams so they are more efficient and effective.

The Forum's policy staff support Children's Cabinets, also known as councils, commissions or P-20 councils. Children's Cabinets are typically made up of the heads of all government agencies with child- and youth-serving programs. They meet regularly to coordinate services, develop a common set of outcomes, and collaboratively decide upon and implement plans to foster the well-being of young people.

Members of this network receive technical assistance, share best practices and learn more about tools that bring efficiency and effectiveness to their efforts to improve outcomes for young people. Below are the states currently engaged in the Children's Cabinet Network.




Figure 1. States engaged in the Forum for Youth Investment's Children's Cabinet Network.





Testimony prepared for the House Education Committee SB 2176 – North Dakota Children's Cabinet Kim Jacobson, Agassiz Valley Human Service Zone Director March 11, 2025

Chair Heinert, and members of the House Education Committee, my name is Kim Jacobson. I am the Director for the Agassiz Valley Human Service Zone, which includes the counties of Traill and Steele. In addition, I currently serve as Vice-Chair of the North Dakota Children's Cabinet. I am here today to provide testimony in support of SB 2176.

The North Dakota Children's Cabinet was established during the 66th Legislative Assembly (SB 2313). As an inaugural member of the cabinet, I have served since the Cabinet's first meeting in November 2019.

The Children's Cabinet exists to assess, guide, and coordinate care for children across branches of state government and tribal nations. We monitor the needs and trends that arise within the system of children's care services that are available in North Dakota. We also network with community partners to learn about service gaps, challenges, and innovations. Our fourteen members meet monthly to share insights and strategize comprehensive service delivery for the children in our state.

For several years, a key focus of our approach to continuous quality improvement has been the study of other Children's Cabinet models in the United States. Learnings from other Cabinets helped us develop a charter and strategic plan, which was finalized in 2024. This is the roadmap that guides the vision, mission, and goals of the Children's Cabinet.

Senate Bill 2176 plays a pivotal role in that roadmap. One of our findings has been that the most impactful Children's Cabinets in the United States are located within their respective governor's offices. This positioning lays the foundation for a multidisciplinary Cabinet that can learn from, and collaborate with, the executive branch of state government. By relocating our staffing and administrative services from the Department of Health and Human Services to the Office of the Governor, SB 2176 offers the North Dakota Children's Cabinet that same stability.

Additionally, SB 2176 provides the critical addition of designated workgroups to support Cabinet efforts. This will allow for the focused study of assigned topics by a wider range of subject matter experts who can present their findings and recommendations to the Children's Cabinet. In fact, this legislative session has raised several topics that could benefit from focused workgroups overseen by the Children's Cabinet. Local stakeholders have diverse perspectives on the needs of children in our communities — and how to meet those needs. For example, HB 1562 strengthens local decision-making in the frequency of mandated reporter training. If passed, this bill will be easy to implement and allow school districts to streamline staff workload while staying current on child safety issues. On the other end of the spectrum, HB 1095 would substantially increase the role of government in North Dakota schools. More importantly, its narrow focus on the investigation of abuse and neglect may lead to missed service opportunities that local families need to thrive. Lynn Flieth, the Director of RSR Human Service Zone, explained it perfectly when she testified that "because Child Protection Service activities transcend any single entity, and rely upon a community response, the original intent of [House Bill 1095] may be more comprehensively and appropriately addressed in a coordinated effort through a statewide approach, perhaps through the Children's Cabinet. It would be beneficial to be inclusive of other service providers, law enforcement and the legal community along with the Child Protection system and schools to enhance understanding, strengthen systems, and to optimally support children and their families." Senate Bill 2176 provides the Children's Cabinet — and overall, the state — with the opportunity to respond holistically to the complex needs across our state. Focused workgroups will give us the opportunity to incorporate the perspectives of experts who serve children in a variety of ways: as educators, as parents, as health service providers, and more. These groups will also provide the Cabinet with greater capacity to incorporate evidence-based outcomes into recommendations. As a result, Senate Bill 2176 will reduce systems conflict and increase the probability of positive outcomes for the children and families we serve.

In conclusion, Senate Bill 2176 opens new doors for the Children's Cabinet. It gives us greater opportunity to hear from multi-disciplinary workgroups and supports a strategy-driven, solution-oriented, and collaborative approach to meeting needs. These strategic changes set the stage for service delivery improvements, prudent investments, and overall improved care for North Dakota children.

Good afternoon, Chair Heinert and members of the House Education Committee. For the record, my name is Michelle Strinden, Lieutenant Governor for the State of North Dakota. I am here to provide our support for SB 2176, which proposes to move the administration of the Children's Cabinet into the Office of the Governor.

- I served as chair of the cabinet for nearly two years.
- During that time, I recognized the need for intentional focus and support to drive the cabinet to support children's systems.
- Moving the cabinet's administration within the Governor's Office will place additional focus on the cabinet and accelerate progress for children and families.
- We've partnered with an external consulting service that supported the development of a strategic plan and actionable goals.
- Working with the consultants, we'll continue to develop measures of success and working groups to dive deeper into issues across juvenile justice, child welfare, mental health continuum, education, early childhood and much more.
- Both the previous and current administrations have been engaged in supporting this effort. Both budget proposals included a line item that supports the cabinet with consultants and costs related to meetings, administration, document preparation, and other expenses.

- Our office is supportive of the current line item of \$65,000 which is reflected in HB 1001. These funds will support the cabinet with \$30,000 for facilitation consultants and \$35,000 in ongoing appropriations for supportive services.
- We are in support of the amendments proposed by Senator Axtman and we are grateful for her leadership on this bill.

I would like to introduce Meghan McCann with The Forum of Youth Initiative to walk through the national landscape of state Children's Cabinets and walk through the North Dakota strategic plan.

Senate Bill 2176 Sen. Michelle Axtman House Education Committee March 11, 2025

Good morning, Chairman Heinert and members of the House Education Committee. For the record, my name is Michelle Axtman, Senator from District 7. As a member of the Children's Cabinet for two years and a recent appointment as Chair, I am here to provide supportive testimony for Senate Bill 2176.

For some history, the Children's Cabinet was established in 2019 by Senate Bill 2313. The intent of the cabinet is to support cross-agency collaboration and service delivery to improve outcomes for children and families. You will hear later from Forum for Youth Initiative on cabinets across various states and different structures and governance within government. The intent of this bill is to move the Children's Cabinet, which is currently administered within the Department of Health & Human Services, into the Office of the Governor. As you can see, the entire bill is underlined as it will be a new section to chapter 54-07 of North Dakota Century Code.

I am now going to walk through the changes noted in this bill by sections.

Section 1, Subsections 1 and 2: This language makes a few updates to the membership of the cabinet, to include the legislative members and increases the additional members from 4 to 5 to ensure representation from subgroups listed on page 2 lines 5-10.

Section 1, Subsection 2 g.: Clarifies that the commissioner is from the department of health and human services.

Section 1, Subsection 2 i.: Changes department to the governor's office.

Section 1, Subsection 3: Changes "chairman of legislative management" to "the governor, in collaboration with the chairman of legislative management"

Section 1, Subsection 5 a.: Adds "and families"

Section 1, Subsection 5 i.: Adds "Establish and oversee designated working groups to develop policies impacting children and families; and"

Section 1, Subsection 5 j, 1 and 2: Adds in "Other designated working groups on children and family issues"

Section 1, Subsection 6: Changes "department" to "office of the governor", "and coordinate with other designated working groups on children and family issues"

Section 1, Subsection 7 a.: Adds "The presiding officer of the children's cabinet may designate working groups and appoint or remove liaisons to serve on the working groups"

Section 2: This repeals the former section in code that had the children's cabinet in 50-06-43.1.

Section 3: Amendment to remove.

This covers the language changes and would like to now ask Lieutenant Governor Michelle Strinden to provide testimony related to her previous role as chair.



Executive Summary

North Dakota's Children's Cabinet was created by 2019 Senate Bill No. 2313 to assess, guide and coordinate care for children across North Dakota branches of government and tribal nations. The Cabinet meets monthly to receive information and collaborate on strategies that address gaps and the full continuum of care and delivery of services regarding early care and education, medical and behavioral health, community, child welfare, and juvenile justice issues. This year's annual report describes that work and captures the progress and momentum towards improving outcomes for North Dakota's children and families.

In addition to the work of the North Dakota Children's Cabinet in meeting its statutory responsibilities and planning for the long-term future of our children, the Cabinet identified that a strategic plan and technical assistance was critical to its future success and sustainability. North Dakota became a member of the Forum for Youth Investment's Children's Cabinet Network in the fall of 2023 and the second portion of this report documents its 2024 planning work with the Forum for Youth Investment in helping to illuminate a path forward.

- 1. The children's cabinet is created to assess, guide, and coordinate the care for children across the state's branches of government and the tribal nations.
- 2. The children's cabinet consists of the following members:
 - a. The governor, or the governor's designee;
 - b. The chief justice of the supreme court, or the chief justice's designee;
 - c. A member of the house of representatives from an even-numbered legislative district and a member of the house of representatives from an odd-numbered legislative district appointed by the majority leader of the house of representatives to serve two-year terms;
 - d. A member of the senate from an even-numbered legislative district and a member of the senate from an oddnumbered legislative district appointed by the majority leader of the senate to serve two-year terms;
 - e. The superintendent of public instruction, or the superintendent's designee;
 - f. The director of the committee on protection and advocacy, or the director's designee;
 - g. The commissioner of the department, or the commissioner's designee.
 - h. A representative of the tribal nations in the state, who is appointed by the governor; and
 - i. Four individuals representing parents, private service providers, or other community interests, who are appointed by the governor to serve a term of two years, at the pleasure of the governor, and who are entitled to reimbursement from the department for travel and lodging at the same rate as provided for state officers and employees.
- 3. The chairman of legislative management shall appoint one of the legislative members to serve as the presiding officer of the cabinet. The children's cabinet shall select one of its members to serve as the vice-presiding officer. The cabinet shall meet at least quarterly. Additional meetings may be held at the discretion of the presiding officer.
- 4. The children's cabinet shall:
 - a. Coordinate broad-based leadership across programs, agencies, branches of government, and tribal nations to meet the needs of children;
 - b. Develop strategies to address gaps or needs regarding early care and education, medical and behavioral health, community, child welfare, and juvenile justice;
 - c. Develop strategies to provide for the full continuum of care in the delivery of services, including promotion, prevention, early identification and intervention, service delivery, and recovery;
 - d. Seek to engage cooperation across public and private service providers;
 - e. Provide a comprehensive vision for how and where children are best served, attending to children in a respectful and relevant manner;
 - f. Seek strategies to provide services to children without consideration of prior engagement with juvenile services;
 - g. Provide for the active participation of consumers and providers statewide on advisory committees;
 - h. Receive information and recommendations from the department of health and human services, department of corrections and rehabilitation, and other state agencies; and
 - i. Provide an annual report to the legislative management and governor regarding the activities and findings of the cabinet.
- 5. The department shall provide the children's cabinet with staffing and administrative services.
- 6. A member of the cabinet who is not a state employee is entitled to reimbursement for mileage and expenses as provided by law for state officers and employees, to be paid by the department. A state employee who is a member of the cabinet is entitled to receive that employee's regular salary and is entitled to reimbursement for mileage and expenses to be paid by the employing agency.

A member of the cabinet who is a member of the legislative assembly is entitled to receive per diem compensation at the rate provided under section 54-35-10 for each day performing official duties of the cabinet. The legislative council shall pay the per diem compensation and reimbursement for travel and expenses as provided by law for any member of the cabinet who is a member of the legislative assembly.

Appendix B: The Forum for Youth Investment's Children's Cabinet Network

No single support or program is enough to ensure children and youth are on track developmentally, educationally, socially, and emotionally. Children's Cabinets are systematically changing the fragmented ways that state and local governments do business for children and youth. Since 2004, The Forum for Youth Investment has engaged with these coordinating bodies to support their operation and share lessons learned with the youth development field.

Unfortunately, the manner in which rules, regulations and government structures are crafted makes it difficult for leaders to create and implement coordinated programs and services that address the comprehensive needs of young people. But there is much that can be done to simplify and untangle the patchwork of polices and funding streams so they are more efficient and effective.

The Forum's policy staff support Children's Cabinets, also known as councils, commissions or P-20 councils. Children's Cabinets are typically made up of the heads of all government agencies with child- and youth-serving programs. They meet regularly to coordinate services, develop a common set of outcomes, and collaboratively decide upon and implement plans to foster the well-being of young people.

Members of this network receive technical assistance, share best practices and learn more about tools that bring efficiency and effectiveness to their efforts to improve outcomes for young people. Below are the states currently engaged in the Children's Cabinet Network.




Figure 1. States engaged in the Forum for Youth Investment's Children's Cabinet Network.

SECTION 3. APPROPRIATION - OFFICE OF THE GOVERNOR - CHILDREN'S CABINET.

the governor, for the purpose of administering the children's cabinet and coordinating
