TESTIMONY OF JOHN BRADLEY NORTH DAKOTA WILDLIFE FEDERATION SENATE BILL 2199 SENATE ENERGY AND NATURAL RESOURCES COMMITTEE JANUARY 23, 2025

Chairman Patten and Members of the Senate Energy and Natural Resources Committee:

For the record, I am John Bradley, Executive Director of the North Dakota Wildlife Federation (NDWF). We are opposed to SB 2199. NDWF believes our service members and veterans deserve the utmost respect, we are put in a hard position to testify against this bill. We struggle with opening up the deer lottery to recognize service. With potentially thousands of North Dakota veterans who would be eligible for this tag, we feel that the pressure that this would put on the resource would be significant. Additionally, there are no restrictions on what type of deer license they could select, meaning units where it could take anywhere from 5-15 years for the general lottery hunter to draw a tag, could be given out year after year to a disabled veteran.

Currently there are options for disabled veterans to participate in hunts, including the Camp Grafton Annual Disabled Veteran Deer Hunt and the Theodore Roosevelt National Park cow elk cull.

We believe there are other ways outside of weakening the deer lottery to recognize the sacrifice that veterans have made. We urge a Do Not Pass on SB 2199.

Good morning, Chairman Patten, members of the Energy and Natural Resources Committee. I am Senator Mike Wobbema, District 24. In the interest of transparency, I am a veteran with a 90 percent disability rating by the Veterans Administration. Senate Bill 2099 is intended to provide a special privilege to those military veterans who have paid a significant physical toll in the service to our great country. It provides for the North Dakota Department of Game and Fish to provide to veterans who are rated 100 percent disabled by the Veterans Administration a deer license upon request, without regard to the lottery system. This Bill came about as a result of a conversation with a constituent during this last campaign season. His comments to me were based upon a frustration of waiting several years to obtain a deer license, mentioning his service and disability. I thought he had a point and hence this legislation request. Incidentally, he had been shot in the leg, stabbed in the shoulder, and had an eye knocked out of its socket during combat operations, though you wouldn't know it to look at him. His love for hunting though, was very clearly evident in our conversation.

Those who have been rated 100 percent disabled by the Veterans Administration have been so rated because they have been physically or psychologically injured through combat action, accident, or just through the wear and tear of a career of service. Whatever the reason for this level of disability rating, they have paid a price to which this country, and the state of North Dakota owe a debt of gratitude. I believe this request is a reasonable consideration and demonstrates our gratitude for their service and sacrifice.

To put some numbers to this discussion, there were 341 veterans rated 100 percent disabled who utilized the veteran combined hunting license in 2023. As an aside, there were 326 veterans rated 50 percent or more disabled who obtained fishing licenses. I believe the numbers of those who would use this benefit are low in comparison to the approximately 50,000 deer licenses available by the North Dakota Department of Game and Fish.

TESTIMONY OF JOHN BRADLEY NORTH DAKOTA WILDLIFE FEDERATION SENATE BILL 2199 HOUSE ENERGY AND NATURAL RESOURCES COMMITTEE MARCH 7, 2025

Chairman Porter and Members of the Senate Energy and Natural Resources Committee:

For the record, I am John Bradley, Executive Director of the North Dakota Wildlife Federation (NDWF). We are opposed to SB 2199. NDWF believes our service members and veterans deserve the utmost respect, we are put in a hard position to testify against this bill. We struggle with opening up the deer lottery to recognize service, whether that's veterans, active service members, EMTs, police officers, firefighters or anyone else who is deserving. With potentially thousands of North Dakota veterans who would be eligible for a bonus point in the lottery, units where it could take anywhere from 5-10 years for the general lottery hunter to draw a tag, could take even longer.

There is also confusion with the current language on whether the added points accumulate over time or if an additional point is added for that individual year. Does the added point go away after that year's lottery or does it stay and another point is added again next year?

Currently there are other options for disabled veterans to participate in hunts, including the Camp Grafton Annual Disabled Veteran Deer Hunt and the Theodore Roosevelt National Park cow elk cull. Additionally, there are numerous pheasant, waterfowl and other hunts offered for veterans from local on the ground clubs.

We believe there are other ways outside of watering down the deer lottery to recognize the sacrifice that disabled veterans have made. We urge a Do Not Pass on SB 2199.

Good morning, Chairman Porter and members of the House Energy and Natural Resources Committee. I am Senator Mike Wobbema, District 24. In the interest of transparency, I am a veteran with a 90 percent disability rating by the Veterans Administration.

Senate Bill 2099 is intended to provide a special privilege to those military veterans who have paid a significant physical toll in the service to our great country. As originally written, it provided for the North Dakota Department of Game and Fish to provide to veterans who are rated 100 percent disabled by the Veterans Administration a deer license upon request, without regard to the lottery system. As amended, it retains the requirement to apply for a license through the lottery system but provides for an accelerated accumulation of "points" to allow for the possibility of obtaining a deer license on a more frequent basis. I think the amendment is a reasonable accommodation in considering this bill. This Bill came about as a result of a conversation with a constituent during this last campaign season. His comments to me were based upon a frustration of waiting several years to obtain a deer license, mentioning his service and disability (He is rated at 100 percent by the VA). I thought he had a point and hence this legislation request. Incidentally, and to make the point of the cost of service, on separate occasions he had been shot in the leg, stabbed in the shoulder, and had an eye knocked out of its socket during combat operations, though you wouldn't know it to look at him. His love for hunting though, was very clearly evident in our conversation.

Those who have been rated 100 percent disabled by the Veterans Administration have been so rated because they have been physically or psychologically injured through combat action, accident, or just through the wear and tear of a career of military service. Whatever the reason for this level of disability rating, they have paid a price to which this country, and the state of North Dakota owe a debt of gratitude.
