#### **TESTIMONY IN SUPPORT OF SB 2212**

Senate Appropriations Committee - Education & Environment Division

January 22, 2025

SB 2212 builds off legislative efforts over the past decade to better manage the capital building assets of our public colleges and universities by providing a more stable and consistent source of state funds to maintain existing facilities and build capital projects. This bill, which works within the existing three tier system of our university system capital building fund, would also allow the campuses greater flexibility to manage deferred maintenance, ongoing maintenance, and to fundraise in support of new construction.

In short, each institution would be allocated a certain amount of funds to be determined each biennium to use for capital building projects. The intent is that these allocations would reduce or eliminate the need to fund specific capital projects in a single biennium. Instead, campus leadership would have the flexibility to spend or save biennial fund allocations at a pace that is most appropriate for the long-term facility plans of their institution. Legislative authorization would still be required for specific projects once a campus is ready to move forward on any given project.

The bill also alters the matching requirements. To access Tier II funds, which are used for extraordinary repairs and deferred maintenance projects, all institutions other than UND and NDSU would continue to be required to provide one dollar in local funds for every one dollar from the capital building fund. This bill would increase the match requirement for UND and NDSU to two dollars of local funds for every one dollar from the capital building fund. This recognizes the larger donor bases and other sources of local funds available to our two research institutions.

Tier III funds, used for certain new facilities, would require that all institutions, except UND and NDSU, provide one dollar in local funds for every nine dollars from the capital building fund. UND and NDSU would be required to provide one dollar for every two dollars from the state. Again, this difference recognizes the additional resources available to our two largest campuses.

The proposed fund amounts in both Tier II and Tier III are allocated among the institutions using factors such as existing square footage and enrollment, consistent with past capital building fund allocations.

Chair Sorvaag and Committee Members,

Thank you, Senators Sorvaag, and Sickler, and Representatives Sanford and Swiontek for introducing and sponsoring HB 2212. Mayville State University is in support of HB 2212.

The use of Tier II funds for bond payments would be a significant benefit to Mayville State as it continues to implement plans to improve and better maintain its aging facilities. The ability to match funds at a 1:1 ratio would result in Mayville being able to access the funding and keep up with its aging infrastructure.

The increase in Tier III by \$2M is highly supported and would be of great benefit to Mayville, bringing this funding to \$2.5M. The reduction in match to 1:9 would also increase the ability of Mayville State to raise matching funds to access these funds and make significant improvements to its facilities as they are needed.

The elimination of the pooling of carryover funds would also enable MSU to accumulate for larger projects in the future. Mayville is currently carrying over the maximum biennia of Tier II and III funds as it has not been able to reach the 2:1 or matching levels required. We are grateful to be able to use that on the Old Main Project.

Chair Sorvaag and Committee members, on behalf of Lake Region State College, I am expressing my support for SB2212 regarding the capital funding for the NDUS.

Lake Region State College especially appreciates the increased amount for Tier III funding along with the 1 to 9 matching requirements. This will assist us in the larger projects which are very hard to fund. It also alleviates the burden of obtaining such large matching funds.

I also support the removal of the 75% requirement on Tier I prior to accessing Tier II and Tier III. We understand that Tier III can be used prior to Tier I or Tier II.

Lake Region State College would support an amendment to expand the uses of Tier III capital building funds to the same uses as the Tier II capital building funds.

Chair Sorvaag and Committee members, I am here to provide testimony in support of SB2212 on the university system capital building fund and request one amendment.

The State Board of Higher Education (SBHE) has not taken an official position on SB2212 but does support the capital building fund program with increased funding and reduced matching requirements as this aligns with our mission to enhance our institution's facilities. SB2212 includes additional funding, a reduced matching requirement for tier III capital building funds and limits tier III capital building fund uses to legislatively approved capital projects.

SB2212 provides structured matching fund requirements, encourages our universities to seek additional funding sources and ensures fiscal responsibility. The tier III reduction in required matching funds for the smaller institutions is a great benefit as they find it harder to access matching funds at the same rate as the larger institutions. We do suggest an amendment to expand the uses of Tier III capital building funds to the same uses as the Tier II capital building funds. Some of the NDUS institutions in the current biennium are utilizing the full Tier II allocation and some portion of the Tier III on deferred maintenance projects.

The capital building fund changes in the bill include:

**Section 1** directs interest earned by the capital building fund to Tier II, including the required match.

**Section 2** modifies the uses of the capital building funds:

- Removes the requirement that institutions match & commit 75% of Tier I dollars prior to accessing Tier II and III.
- Allows Tier II funds to make bond payments for Tier II projects

**Section 3** defines the matching requirements for the Tier II Capital Building Funds:

- \$1 of matching funds for \$1 of capital building funds for all institutions except for NDSU and UND. This is the same matching requirement as the current biennium.
- \$2 of matching funds for \$1 of capital building funds for NDSU and UND. This is an increase in the matching requirement for NDSU and UND from the current biennium matching requirement of \$1:\$1.



**Section 4** defines the matching requirements for the Tier III Capital Building Funds:

- \$1 of matching funds for \$9 of capital building funds for all institutions except for NDSU and UND.
- \$1 of matching funds for \$2 of capital building funds for NDSU and UND.

This is a much-appreciated reduction in matching requirements for all institutions with increased distributions of capital building funds versus the current biennium's \$2 match with a \$1 capital building fund distribution.

**Section 5** repeals current century code 15-54.1-05 related to the capital building fund pool for redistribution of unallocated funds from an institution after three biennia.

**Section 6** provides a \$65 million transfer from the strategic investment and improvements fund to the university system capital building fund. This section also delineates the distributions to the institutions of tier II and tier III capital building funds.

**Section 7** provides legislative intent that the 70<sup>th</sup> Legislative Assembly (2027) appropriate \$80 million for Tier III projects.

In conclusion, we respectfully request a Do Pass recommendation on Senate Bill 2212, with an amendment, to allow for the continued advancement of our state's educational facilities.

This written testimony is to express Williston State College's support of SB2212 and to request an amendment. WSC especially appreciates this bill's proposed changes for reduced matching funds, higher overall funding, and the ability to use funds for bond payments. These are of great benefit to WSC.

WSC has a number of significant projects underway or in planning utilizing tiered funds. Many of these are "Phase I" initiatives that will require additional efforts in the next biennium. WSC will be fully utilizing Tier I and Tier II allocations along with a portion of Tier III on these projects.

WSC requests that the use of Tier III funds be expanded to include purposes covered in Tiers I and II. This will enable WSC to continue to address extraordinary repairs and deferred maintenance on a timely and cost-efficient basis. The proposed changes to Tier III funds reduces the amount of tiered funding available to WSC and would cause some projects to be further deferred.

Chair Sorvaag and members of the Senate Appropriations Education and Environment Committee. My name is Mike Ellingson and I serve as the Facilities Director at North Dakota State University. I am here today on behalf of North Dakota State University to provide testimony in support of SB 2212.

NDSU would like to thank you for SB 2212. When I started at NDSU in 2010 our original general fund budget for deferred maintenance was \$2,732,244 for the biennium. In 2014 the University System hired a third party to review the deferred maintenance backlog. Of which NDSU had the highest total of \$243 million. That was just buildings. It excluded sewer, water, steam and the heating plant. Our current general fund budget of \$9,331,638 for tier funding has allowed NDSU to reduce the rapid increase of our deferred maintenance to an estimate of \$323 million. With this proposed general fund increase of \$10 million-dollars we believe it will help NDSU turn the corner on our outstanding deferred maintenance on the campus.
