Testimony of Brenda Ruehl, P&A Director Program Services

Greetings Chairwoman Roers and members of the State and Local Government Committee. My name is Brenda Ruehl and I'm a Director of Program Services at the North Dakota Protection and Advocacy Project (P&A). P&A is an independent state agency established in 1977 to assert and advance the human, civil, and legal rights of people with disabilities. The agency's programs and services seek to make positive changes for people with disabilities where we live, learn, work and play.

P&A is in favor of a Do Pass on this bill.

Many voters including voters with disabilities often find proposed measures difficult to understand and are not always sure if they are voting in favor of or opposition of the measure. It is not always clear who is behind the measure, the impact on voting for or in opposition of, and what the financial impact the measure would or would not have on the state and local community.

P&A supports an objective analysis of a vote in favor of or opposition of, as well as the other requirements and language in the bill.

## SB 2230 - Testimony by Dustin Gawrylow, ND Watchdog Network (#266)

Madam Chair,

I would like to show my support for the concept of generating unbiased materials explaining ballot measures, with a few caveats and amendments:

- 1. Define "objective" in law so that it is not at the discretion of the Secretary of State.
  - a. Require the Attorney General to sign off on any legal analysis.
- 2. Consider moving this process to the beginning of the petition approval process so that the sponsoring committee knows what to expect.
- Once approved, add the description to the petition packet during the circulation approval
  process so that petition signers see the same analysis as the overall voting population
  will.
- 4. Once applied to the beginning of the process, bind the Secretary of State to the "objective summary" so that the language does not appear different to voters as it did to petition signers. This will prevent surprise claims at the last minute.
- 5. Create a mechanism to allow for the sponsoring committee to appeal the description OR allow the sponsoring committee to offer an "unverified rebuttal" in addition to the Secretary of State's description.
  - a. This would prevent or limit arguments over "fact-checking".

Fiscal Note: Also, the \$250,000 allocated in the bill likely won't cover the cost of developing, printing, and mailing these materials to all voters. Even if all measures on a particular ballot are rolled into one document and sent out, my estimate for the cost would be between \$1m to \$1.5m, depending on inflation and postal rates changes.

# Senate State and Local Government Committee February 13, 2025 SB 2230 Testimony In Support, but Recommending Amendments

Chairwoman Roers and Sens. Castaneda, Barta, Braunberger, Lee, and Walen:

I am Dr. Ellie Shockley, and I am a social scientist. While earning my Ph.D. at the University of Chicago and completing a post-doctoral fellowship with the University of Nebraska Public Policy Center, the psychology of ballot measure voters was one of my areas of research that I ultimately published in a peer-reviewed journal. Having lived in North Dakota over the last decade, I have maintained an interest in the topic within North Dakota's elections.

What I have found in my research is that ballot language is often confusing, especially for the many voters who have not encountered enough information about a measure prior to completing their ballot. Such confusion nudges people toward a higher likelihood of abstaining from a measure, or toward voting 'No', than if they were less confused. Voters who are less confused can confidently vote on more ballot measures, and they can better align a 'Yes' or 'No' vote with their actual policy preferences. Thus, voter education makes election outcomes better reflect the will of the people.

This bill is a starting point for offering ballot measure voter education, but has room for improvement. In the bill, the "objectivity" of the ballot measure summary/analysis is ill-defined. I suggest focusing instead on accuracy, fairness, and readability/reading ease. And with initiated measures, sponsoring committees should be involved in the process of drafting the educational materials.

First, the summary/analysis could be established prior to the signature gathering process and be included with the petition, as Dustin Gawrylow's testimony describes. This would build voters' understanding from the start. There should also be a process for a sponsoring committee to appeal or rebut the summary/analysis if the sponsoring committee members feel it is inaccurate or unfair.

Closer to the election, sponsoring committees of initiatives and legislative sponsors of concurrent resolutions going to the ballot could be allowed a set word/character count in which to summarize their arguments in favor of the measure. Opponents registered with the secretary of state could similarly summarize their arguments against the measure. Some other states do this well.

Finally, the educational materials should be restricted to certain Flesch-Kincaid Reading Level Scores. These materials will best serve voters if written at a grade level that most understand. The ballot language for the last election's measures ranged from an 11th-grade level to a graduate-student level, demonstrating the need for easy-to-read educational materials. Brenda Ruehl of the Protection & Advocacy Project has also submitted testimony for this bill. I encourage you to seek her feedback on what reading level would be ideal for making educational materials that are inclusive.

#### **TESTIMONY PRESENTED BY**

#### **MICHAEL HOWE, SECRETARY OF STATE**

Chairman Roers and members of the committee, I'm Michael Howe, North Dakota Secretary of State. I'm here to provide supporting testimony for SB 2230. This bill seeks to have the Secretary of State create and distribute information to voters by mail related to statewide ballot measures and the impacts of their yes or no vote.

SB 2230 would have our office send information regarding any statewide ballot measures to eligible voters prior to statewide elections that include ballot measures. Our office currently provides the ballot title, official ballot summary and fiscal impact for statewide measures on our website, however this would expand that information to include where the measure originated from – legislative action, initiated, or referred measure – as well as an objective analysis of what a vote in favor or opposition means. Most states provide information on ballot measures to their voters. About half of the states do this through online sources with varied information provided, the other half practice what this bill requires in mailing a "voter guide" to either households or individual voters.

Our office often receives calls during the election season from members of the public wanting more detail about specific ballot measures. We often point them to our website for the full ballot initiative text.

The bill sponsor consulted with our agency and we have offered her proposed amendments to ensure we have the resources needed, and that the bill is inclusive of the individuals the sponsor intended.

#### These amendments include:

• Page 1, line 12: Replacement of "secured active" with "active voter." Secured active is a status used to protect the records of law enforcement, judges, etc., so the original language excluded all other qualified voters which was not the intent of the sponsor. Active voter would include those who voted in a statewide election in the last 4 years, and those who have received and maintained a North Dakota driver's or North Dakota non-driver's ID, are United States citizens, and are 18 years of age by the date of the election.

- Page 1, line 23: Replacement of "\$250,000" with "\$600,000." If we had a single ballot measure on both the primary and general ballot, we believe this is a minimum of what we would need to provide distribution of information on a measure or two to roughly 450,000 active voters in North Dakota.
  - Estimated Numbers X 2 elections This number is based on 2 elections in a biennial cycle and would not include any statewide special elections.

Active Voters – 450,000 (we have 594,140 eligible, but not all are considered "active voter" as described above)

Postage – \$400,000 (bulk rates range from .38 - .50 per piece)

Printing - \$200,000 (envelopes/mailer)

#### **TESTIMONY PRESENTED BY**

#### **MICHAEL HOWE, SECRETARY OF STATE**

Chairman Schauer and members of the committee, I'm Michael Howe, North Dakota Secretary of State. I'm here to provide supporting testimony for SB 2230. This bill seeks to have the Secretary of State create and distribute information to voters by mail related to statewide ballot measures and the impacts of their yes or no vote.

SB 2230 would have our office send information regarding any statewide ballot measures to eligible voters prior to statewide elections that include ballot measures. Our office currently provides the ballot title, official ballot summary and fiscal impact for statewide measures on our website, however this would expand that information to include where the measure originated from – legislative action, initiated, or referred measure – as well as an objective analysis of what a vote in favor or opposition means. Most states provide information on ballot measures to their voters. About half of the states do this through online sources with varied information provided, the other half practice what this bill requires in mailing a "voter guide" to either households or individual voters.

Our office often receives calls during the election season from members of the public wanting more detail about specific ballot measures. We often point them to our website for the full ballot initiative text.

We do have one proposed amendment that was missed on the senate side that would make sure this bill is inclusive of the individuals the sponsor intended.

• Page 1, line 12: Replacement of "secured active" with "active voter." Secured active is a status used to protect the records of law enforcement, judges, etc., so the original language excluded all other qualified voters which was not the intent of the sponsor. Active voter would include those who voted in a statewide election in the last 4 years, and those who have received and maintained a North Dakota driver's or North Dakota non-driver's ID, are United States citizens, and are 18 years of age by the date of the election.

This bill has a \$600,000 appropriation, which is our estimate related to printing and mailing costs for a piece that may provide information for possibly 1 or 2 measures to voters. If we would have 5 ballot measures as we did in the past election cycle, our office would need to seek greater funding through the Emergency Commission.

Chairman Schauer and members of the committee that concludes my testimony and I'll stand for any questions.

Fiscal note breakdown:

Estimated Numbers X 2 elections - This number is based on 2 elections in a biennial cycle and would not include any statewide special elections.

Active Voters – 450,000 (we have 594,140 eligible, but not all are considered "active voter" as described above)

Postage – \$400,000 (bulk rates range from .38 - .50 per piece) Printing - \$200,000 (envelopes/mailer)



My name is Austen Schauer, District 13, West Fargo.

**SB 2230** seeks to have the Secretary of State office create and distribute by mail voter information on ballot measures.

In the past, there have been many complaints from voters who find ballot language unclear and confusing.

**Voter guides** would be sent at least 45 days prior to the election (and prior to absentee ballots) to all **active voters**.

**Active voters** include those who have voted in a statewide election in the last four years.

The Voter Guides would include: (page 1 lines 16-20).

- > An objective summary of the measure.
- > The anticipated fiscal impact of the measure.
- > Whether the measure was approved by the legislative assembly or originated as an initiative or referred petition.
- > An objective analysis of a vote in favor and a vote opposed.

**SB 2230** has a **\$600k** appropriation. That includes:

Postage - \$400k. (Bulk rates range from .38 - .50 per piece).

Printing - \$200k. (envelopes/mailer).

This would cover two elections in a biennium.

This is a one-time appropriation. If this is something the legislature feels is worthwhile in the future, it could be added to the Secretary of State budget in 2027, or another one-time bill would need to be drafted.

The intent of **SB 2230** is to provide clear and concise ballot measure information to **active voters** as the decisions made by them **will have** and **have had** significant impact on State Government.
