The Hemjokost Center hosted the exhibit <u>At Last: The 10th Anniversary of Marriage Equality</u>. This ran from August of 2023 to August of 2024. It also hosted a celebration night that I both attended and spoke at, with many other speakers giving passionate testimony to the struggle of their life. Many were elders who never thought they'd be able to get married.

I'm not sure there is much data I can provide to show this century's code change will drastically improve lives, but it will have an impact on minority stress. I've seen the relief in a room full of elders who fought their whole life to prove love is love.

I know the purview of many of our lawmakers, so I ask, when do we get to heal? When is it enough? When can we build trust back and start to live together in peace. Celebrate with each other the beauty of our own ideas and convictions? Show kids today that we can grow beyond the hate of yesterday. I urge a "do pass" on this bill, so when I'm old, I can share joy with young adults who are my age now.

My name is Lisa Michels, I am a resident of Minot, and I am writing in support of SB 2264 relating to the definition of marriage in North Dakota. By expanding the definition of marriage to include all "spouses" and "individuals married to each other," SB 2264 provides these protections for us and all married couples. I urge this Senate to support SB 2264.

Chairwoman Diane Larson and members of the Senate Judiciary Committee, I am Linda Thorson, State Director for Concerned Women for America (CWA) of North Dakota, testifying in opposition to <u>SB 2264</u>. As our state's largest public policy women's organization, we strongly oppose the bill's provisions regarding the redefinition of marriage.

North Dakota Century Code defines marriage in section <u>14-03-01</u>:

"What constitutes marriage – Spouse defined. Marriage is a personal relation arising out of a civil contract between one man and one woman to which the consent of the parties is essential. The marriage relation may be entered into, maintained, annulled, or dissolved only as provided by law. A spouse refers only to a person of the opposite sex who is a husband, or a wife married to each other."

SB 2264 contains amendments in thirty-five different sections of the of the 14-03-01 Marriage Contract, with changes made to remove the words, "wife, husband, man, or woman" and replace them with "spouse" or "individual." This bill is harmful to promoting healthy family units and a waste of taxpayer dollars.

Concerned Women for America of North Dakota, testifying for Concerned Women for America Legislative Action Committee, defends marriage as God intended, as we know this leads to healthy family units. Marriage sanctifies those in the union in a unique way that God has intentionally and purposefully created, through the commitment of one woman and one man.

- Redefining marriage rejects the truth that men and women are complementary and that reproduction depends on both a woman and a man.
- Children have a right to both a mother and a father, as God intended. It is important that government policies support and encourage the norms of marriage – monogamy and permanence.

Although God can restore and redeem all situations, it is not hard to see the problems that often arise in homes that lack a mother or father. Each provides an irreplaceable and important role in a child's life to have the optimal environment to flourish.

Former U.S. Sen. Barack Obama (D-Illinois) acknowledged the harms that befall not only children but society when fathers are missing from the home in an address given to the Apostolic Church

of God in Chicago on Father's Day in 2008, saying, "We know the statistics — that children who grow up without a father are five times more likely to live in poverty and commit crime; nine times more likely to drop out of schools and 20 times more likely to end up in prison. They are more likely to have behavioral problems or run away from home or become teenage parents themselves. And the foundations of our community are weaker because of it."

In an essay, 'We Need Fathers to Step Up', dated June 16, 2011, President Barack Obama recognized the importance of fathers and the effects of growing up without one in his life. See the *Parade* magazine excerpt below:

"In many ways, I came to understand the importance of fatherhood through its absence — both in my life and in the lives of others. I came to understand that the hole a man leaves when he abandons his responsibility to his children is one that no government can fill. We can do everything possible to provide good jobs and good schools and safe streets for our kids, but it will never be enough to fully make up the difference." iii

Promoting marriage as defined in our state century code does not ban any type of relationship: Adults are free to make choices about their relationships, and they do not need government sanction or license to do so. North Dakota citizens have the freedom to live as they choose, but no one has a right to redefine marriage for everyone else.

Vote "Do Not Pass" on SB 2264.

Dear Madam Chair Larson and honorable members of the Senate Judiciary Committee,

My name is Mark Jorritsma, and I am the Executive Director of North Dakota Family Alliance Legislative Action. I am testifying on behalf of our organization in opposition to Senate Bill 2264 and respectfully request that you render a "DO NOT PASS" on this bill.

This bill essentially seeks to do one thing: change language throughout the Century Code so that marriage is defined not only as a husband and wife who are biologically different, but also as two individuals who are of the same sex. In June of 2015, SCOTUS rendered a 5-4 decision that the Fourteenth Amendment requires all states to grant same-sex marriages. There have been numerous challenges to this decision since that time, and given the current composition of SCOTUS, reversal of this decision is certainly not outside the realm of possibility. However, I will not go into the legal aspects of same-sex marriage public policy, since I am not a lawyer and there are individuals far better qualified to address these issues.

I would like to speak about North Dakota and our deeply held values. The family was God-ordained at the creation of the world, and it forms the foundation of our society. From families come communities, from communities come societies, and from societies come nations and their governmental structures. It has been shown over the centuries and within a multitude of civilizations that family is the basis for a flourishing culture and society.

I believe it's safe to say that the vast majority of North Dakotans see the marriage of a husband and wife as the hub of the family wheel. This was certainly the case when our country and state were founded upon Judeo-Christian beliefs. These beliefs hold that marriage was created by God and is the basis for our society. We believe human sexuality was designed and intended for our good within the bond of a committed, lifelong marriage between a man and woman.
