To the Honorable Chairman and the members of the Committee. We submit these remarks on behalf of DRC.

Mr Chairman,

We haven't been able to completely understand the intentions of this bill but we believe that there could be some positive aspects of this bill. In a sellers market opening up to new customers can be beneficial for raising prices. But we also remember the Agridime scandal that has recently left North Dakota investors owed around 40 million dollars in a ponzi scheme that had investors buying cattle that didn't exist.

The biggest problem is the loss of licensing. Unless we are mistaken, this bill opens the doors to allowing anyone not licensed within the state to sell cattle, opening the door for more cattle to be bought or sold by out-of-state by corporate entities. This could have unforeseen consequences.

If it could be shown how this could open up markets and benefit producers we might be willing to change our stance. But we may want to look a little more closely at what the consequences of these actions might be.

Opening up online auctions could make fraud easier to commit in our state when it comes to cattle.

Looking at the fiscal side of this bill it seems that there won't be much change in any licensing fees or significant loss or gain of revenue.

Ultimately, this is an imperfect bill that will have a small impact but the positives could likely outweigh most of the negatives as long as other regulations are still in place to prevent fraud.

Video Auction license repeal talking points.

Sen Erbele

- Video auction license is duplicative as law requires representatives to also hold either an auction market license or livestock dealer license.
- License provided no protections to livestock industry, all protections of bond fall under auction market or livestock dealer license.
- No surrounding states have a video auction license requirement.
- Currently only 10 licenses, all have a current auction market or livestock dealer license.
- License fee is \$100
- All other sections of NDCC 4.1-28 will remain in law regards to inspection of livestock requirements, payment in US currency requirements and livestock sold by weight must be weighed on certified scale.
