Testimony in Support of SCR 4009 Workforce Development Committee February 20, 2025

Chair Wobbema and Members of the Senate Workforce Development Committee,my name is Carol Sawicki, and I am a board member and representative of the League of Women Voters of North Dakota. Thank you for the opportunity to submit testimony in support of the resolution.

SCR 4009 urges the US Congress to support admitting Washington, D.C. into the Union as a state of the United States. The League of Women Voters of North Dakota supports SCR 4009 for the following reasons:

- Citizens of the District of Columbia (DC) should be afforded the same rights of self-government and full voting representation in Congress as all other citizens of the United States.
- Lack of representation for the 700,000 people who call the nation's capital home—the
 majority of whom are Black or brown—gives the US the unfortunate distinction of being
 the only democracy in the world that denies the residents of its capital city the full rights
 of citizenship.¹
- Lack of representation in Congress has resulted in Congress blocking policies voted on by the people of DC, nullifying legislation passed by the district's local government, preventing the district from receiving its fair share of federal resources, and Congress exercising extensive authority over DC's budget.²
- DC residents pay more federal taxes than 23 states and more in federal taxes per capita than any other state, and yet they do not live with the benefit of one of the founding principles of our country: "no taxation without representation."³
- DC residents want statehood, which they made clear during a 2016 referendum where 86% of residents voted in favor of DC becoming the 51st state.⁴

The League of Women Voters of North Dakota urges the North Dakota Legislature to support the fundamental right of representation for the people of Washington, D.C. and asks the Senate Workforce Development Committee to give SCR 4009 a Do Pass recommendation.

Dear Committee members:


I write in profound gratitude that you are considering this resolution supporting DC statehood which would give your fellow Americans who live in DC their full rights as citizens.

As you know, I and my nearly 700,000 neighbors have all the responsibilities of American citizens - paying federal taxes, serving on juries and in the military - yet have no voting representation in Congress and therefore no say on national legislation that affects us. The very definition of taxation with representation and contrary to the values this country is founded on.

Thank you for also opposing efforts to interfere with our home rule. As your resolution recognizes, Congress – in which we have no voting representation - can overturn our laws and direct how our own taxes are spent contrary to our needs and values. This profoundly undermines our country's principle of self-governance.

We came here for many reasons: some already lived here when DC was created (and before 37 other states were admitted to the union); many to escape slavery, others to serve our government; others for private sector jobs. My parents lived and died here, my sister lives here, my nephew was born here.

As you know, we have a plan to preserve the federal district as required in the Constitution, while making the residential and commercial part of DC into a state. We want the same rights all other Americans enjoy: control over our local government and a say in Congress. Thank you so much for supporting us.

Dear North Dakota Legislative Council:

On behalf of District of Columbia residents, as U.S. Senator for the District of Columbia (non-voting), I am writing to express my strong support for SCR-4009, a concurrent resolution urging Congress to support the admission of Washington, D.C., into the Union as a state. I urge you to support and vote in favor of this legislation. D.C. statehood is a matter of great importance to D.C. residents, but also for all citizens of the nation, including those in North Dakota.

D.C. statehood is an issue of ensuring full rights and privileges to all U.S. citizens. It is an issue of striving to live up to the ideals of our founding creed and the Declaration of Independence. D.C. is home to over 700,000 residents who contribute to the well-being of country just as much as residents of any other jurisdiction. D.C. residents serve in the military, serve on juries, are subject to the Selective Service, contribute to the nation's economy, and pay federal taxes. However, D.C. residents do not have the same rights and privileges as citizens of the 50 states, including representation in the U.S. Congress.

The phrase "no taxation without representation" is a founding phrase of our country. It is one of the core grievances our Founding Fathers listed in the Declaration of Independence: "For imposing Taxes on us without our Consent." Nearly 250 years later, it is still valid for residents of D.C. Washingtonians pay more federal taxes per capita than *any* state in the nation and pay more in total taxes than 19 other states. Yet D.C. residents have no voting representation in the House of Representatives or Senate who have a say in how this tax money is spent.

D.C. statehood is not only an abstract concern of democracy; it has real consequences that impact the lives of D.C. residents. The most tangible of these is D.C.'s crime rate. In the District, the two most prominent forces in the criminal justice system answer to different executives. The Metropolitan Police Department answers to the D.C. Mayor, and the U.S. Attorney for the District of Columbia answers to the President of the United States. This results in poor coordination between the offices. In addition, all judges for the District must be confirmed by the U.S. Senate. These judges are usually the last priority for the Senate, and the result is many vacancies, causing trials to take longer to complete in D.C. than in any other jurisdiction in the country. This system means that many criminals believe they are unlikely to be prosecuted and, therefore, are more brazen in committing crimes in the District, leading to higher crime rates. When we become a state, D.C. can take control of this system and fix the inefficiencies to reduce the crime rate and improve the lives of residents.

Since D.C. is not a state, Congress can also impose any requirement it wants on D.C. This hinders the District's autonomy and creates serious safety concerns for residents. For example, in 2014 Congress prevented the implementation of a local ballot measure that legalized the sale and use of marijuana, by using the federal budget to veto the provision allowing for the sale of marijuana but not touching the provision dealing with its use. This congressional action has led to an unregulated gray market of marijuana "gifting" shops in which customers are "gifted" marijuana after buying another item. The lack of regulation creates safety concerns as customers cannot be sure what product they will receive after purchasing it. The Metropolitan Police Department has found multiple "gifting" shops which have laced cannabis with amphetamines.¹ In addition, marijuana cannot be taxed and is instead treated as a free

commodity. Therefore, the District government loses millions of dollars that could come from taxing sales.

Statehood for D.C. is not only something that benefits the residents of D.C. It benefits residents of all states, as it would improve the image of the United States in the world. The United States is the only representative democracy in the world that does not give voting representation in the national legislature to citizens of its capital city. Instead, citizens in D.C. are treated more like second-class citizens or citizens of a colony. Residents of D.C. bear the responsibilities of citizenship but do not get to enjoy the rights and privileges of citizenship. D.C. residents have no voting representation in either house of Congress. D.C. does have a local government, but Congress gets to dictate every law that the local government passes. And, most egregiously, on a whim, Congress has the power to remove the local government altogether. DC residents deserve the same representation as any American.

D.C. Statehood is also not a partisan issue. Across the history of the United States, both Democratic and Republican lawmakers have endorsed and advocated for statehood and voting representation for D.C. residents. Republican Delegate William Corlett of Wyoming introduced the first-ever congressional joint resolution (H.R. 57) to give D.C. voting representation in the House of Representatives.² 70 years later, in 1960, Republican Senator Kenneth Keating of New York introduced what became the 23rd Amendment to the U.S. Constitution, which gave D.C. residents the right to vote for President. In 1973, Republican President Richard Nixon signed the District Home Rule Act into law, creating the local government that D.C. has today. In addition, the Republican Party Platform of 1960, 1968, 1972, and 1976 included support for congressional representation for D.C. residents. SCR 4009: A concurrent resolution urging Congress to support admitting Washington, D.C. into the Union as a state of the United States.

As the United States Representative in Washington, D.C., I serve as a chief legislative lobbyist in support of D.C. statehood – inside the District of Columbia, across the United States of America, as well as around the world.

Our fight for D.C. statehood is the greatest example of voter suppression in the United States of America. D.C. residents pay federal taxes without having any voting representation in either the United States House of Representatives or the United States Senate.

Nearly 700,000 residents of the District of Columbia have absolutely no say on important matters such as the appointment of U.S. Supreme Court Justices, federal tax cuts or increases, impeachment hearings and votes, and involvement in wars – to name just a few.

We lack full control over our own resources. We lose out on federal monies and programs that residents of the 50 states receive. Congressional review periods on Capitol Hill ensure that we do not have the final word on annual budgets assembled by D.C.'s Mayor and the laws created by members of the Council of the District of Columbia. Our criminal justice system is completely controlled by the federal government. Our mayor is not permitted to act as the commander-inchief of our National Guard. We lack full autonomy. Each and every day, we have to mitigate what we lose in D.C. by not being the 51st state in the Union.

The lack of D.C. statehood impacts Education and Youth Services, the Environment, Healthcare, Human Rights, and Public Safety in the District of Columbia. As the U.S. Representative, I address these matters as focal points along with my official duties.

Education and Youth Services

I have collaborated with RESET, which places volunteer engineers, mathematicians, scientists, and technicians in elementary school classrooms and pre-Kindergarten centers in the Washington, D.C. metropolitan area. This program leads children to hands-on STEM learning. RESET'S goal is to get children excited about STEM and to consider education and career pathways in related fields. In addition, I have provided free in-classroom science enrichment to elementary students; promoted U.S. State Department internships for high school and college students; collaborated with local sports teams and fitness groups to conduct an annual youth fitness day; created internships for high school and college students to get first-hand experience in my office; and partnered with schools to provide dynamic career days. I also helped organize and participated in the 2021 "March On For Voting Rights" on the 58th anniversary of the 1963 March On Washington when the Reverend Martin Luther King, Jr. delivered his "I Have A Dream" speech and served on virtual panels with members of the organization, Students for D.C. Statehood.

Environmental Justice

D.C.'s federal parks often fall between the cracks of the local and federal government. I have participated in wooded area cleanups; spoken with the Office of Congressman James E. Clyburn (D-SC-06) regarding resources for forest areas in D.C.; helped remove more than 51 pounds of trash in federal parks every month; collaborated with D.C. Voters for Animals - Education Fund to make D.C. a cruelty-free jurisdiction; challenged the National Park Services' decision to shoot deer for population control; and helped to ban all fur sales in D.C.

Healthcare

Because D.C. is not a state, we were denied half of the financial resources from the Coronavirus Aid, Relief, and Economic Security (CARES) Act to fight COVID-19 in 2020. As a licensed pharmacist, I make an impact on the frontlines of healthcare. I created a Healthcare Providers in Policy Coalition to address the latest news and legislation; helped to increase vaccine access for D.C. residents during a shortage; vaccinated more than 10,000 D.C. residents since 2021; participated with Howard University's School of Pharmacy to conduct health fairs; and, alongside Oxford House, passed out and demonstrated the use of hundreds of Narcan.

Human Rights

Without D.C. statehood, we are unable to have a say in today's most pressing human rights issues. D.C. cannot help codify women's reproductive rights and are at risk of federal government overreach into current procedures in D.C. We are unable to vote for the Equality Act. My office has hosted the Equality Panel to discuss the importance of passing laws to protect the LGBTQ+ community. I have also collaborated with Planned Parenthood of Metropolitan Washington, D.C. and SMYAL (Supporting and Mentoring Youth Advocates and

Leaders) to write an opinion piece discussing the need to protect gender-affirming care for trans teens. I have worked with the Tenants Advocacy Coalition (TENAC) and local tenant associations to fight displacement and ensure dignity for our senior neighbors. In addition, I am working to increase the political engagement of our African, Caribbean and Latino communities.

Public Safety

D.C. lacks control over our own criminal justice system. Our local judges and prosecutors are all federally appointed. With the advice and consent of the U.S. Senate, the President of the United States nominates and appoints all judges in the District of Columbia courts. Lacking a prison in the District of Columbia, incarcerated D.C. residents are housed all over the country. With assistance from the D.C. Caucus for Returning Citizens, I successfully submitted a resolution to the U.S. Department of Justice to revise COVID-19 compassionate releases to allow released offenders to finish their sentences at home. I have also participated in and moderated four panels for the D.C. Mayor's Office on Returning Citizen Affairs and partnered with various organizations to conduct expungement clinics for returning citizens who qualify for record sealing.

Self-determination is the right to representative government with full suffrage. The people's right to form its own political entity in the District of Columbia cannot be fulfilled without the help of the state and local governments in these 50 states.

Following a trip in 2022 to the State Capitol Building in Charleston, I led an effort with Minority Leaders Doug Skaff, Jr. and Sean Hornbuckle to introduce **West Virginia House Concurrent Resolution 86** in support for admitting Washington, D.C. into the Union as a state of the United States of America. With an historic resolution, Members of the West Virginia House of Delegates acknowledged the importance of Washington, D.C. becoming the 51st state.

Today, I respectfully request that this legislative body – the NORTH DAKOTA LEGISLATIVE COUNCIL – vote in favor of SCR 4009, a concurrent resolution urging Congress to support admitting Washington, D.C. into the Union as a state of the United States.

Washingtonians may lack a congressional vote and a seat in our federal government, but we still have our voices. I continue to defend and support D.C.'s fight for statehood, and implore you to do the same. On behalf of my nearly 700,000 constituents in our nation's capital, I hope that you will join us in the fight for D.C. statehood, Senators.

I thank you for your time and your consideration of this most important civil rights matter.

Born in Boston, Massachusetts, in 1989, Representative Owolewa is the first Nigerian-American to serve on the New Columbia Statehood Commission. Rep. Owolewa attended the prestigious Boston Latin School, graduating in 2008. He earned a doctorate degree in pharmacy from Boston's Northeastern University in 2014 and is a licensed pharmacist currently working as a Pharmacy Manager for Safeway. Prior to becoming a U.S. Representative, Dr. Owolewa served one term as an Advisory Neighborhood Commissioner in ANC 8E, representing Single Member District 8E-01. As an Advisory Neighborhood Commissioner, he worked to increase science enrichment programs in Southeast area elementary schools, added traffic safety measures, and helped bring a Senior Day Center to his neighborhood. He also volunteered at his neighborhood elementary school to encourage students to become more interested in science and mathematics.

ABOUT MY OFFICE

Pursuant to the Code of the District of Columbia (§ 1–123), the duties of a Representative are to inform the Congress and individual members of Congress that the District of Columbia residents meet the standards traditionally required by Congress for the admission of a United States territory as a state of the United States; to monitor the progress of the petition for admission of New Columbia to statehood pending before the Congress and report on the progress to the District of Columbia residents; and to advise the District of Columbia on matters of public policy that bear on the achievement of statehood.
