## Testimony in Opposition to SCR 4013 Senate State and Local Government Committee February 21, 2025

Chair Roers and Members of the Senate State and Local Government Committee, my name is Carol Sawicki, and I am a board member and representative of the League of Women Voters of North Dakota.

SCR 4013 is a resolution that supports the electoral college, denounces the National Popular Vote Interstate Compact, and invites interested states to form the Electoral College Interstate Compact. The League of Women Voters of North Dakota opposes SCR 4013 for the following reasons:

- In the Electoral College system, the president and vice president of the United States are
  not elected based on the people's majority vote but rather on a convoluted system of
  electors. The Electoral College allows someone to become president by having the right
  combination of states, even without a majority of the popular vote.
- The Electoral College distorts the democratic promise of "one person, one vote" by awarding electoral votes from each state in support of a candidate instead of simply counting the total number of votes nationwide. The League of Women Voters does not support the Electoral College system and launched its <u>One Person One Vote campaign</u> in 2024 to abolish the Electoral College.
- Voters in some states may be disinclined to cast their vote for president since they feel
  that their vote will not matter under the Electoral College system. The League of Women
  Voters supports policies that encourage all citizens to participate as voters, not policies
  that tend to discourage voting.
- The National Popular Vote Interstate Compact would ensure that every vote cast in a
  presidential election holds equal weight, no matter the state in which it is cast. The
  League of Women voters supports the National Popular Vote Interstate Compact, since it
  would create a more representative democracy.
- The League of Women Voters of North Dakota cannot support an "Electoral College Interstate Compact" which would be in direct opposition to the National Popular Vote Interstate Compact.

The League of Women Voters supports the direct popular vote of the US President, and we urge the State and Local Government Committee to **give SCR 4013 a Do Not Pass recommendation**. Thank you for your consideration of our testimony.

I stand in opposition to SCR 4013, a resolution that supports the Electoral College, denounces the National Popular Vote Interstate Compact, and proposes the creation of an Electoral College Interstate Compact.

The Electoral College undermines the principle of "one person, one vote" by allowing a candidate to win the presidency without securing the majority of the popular vote. This system discourages voter participation, as many feel their votes do not matter in states where the outcome is perceived as predetermined. In contrast, the National Popular Vote Interstate Compact ensures every vote carries equal weight, creating a more representative and inclusive democracy.

SCR 4013's proposal for an Electoral College Interstate Compact would further entrench an outdated system that distorts the will of the people and makes it more corrupt than it already is.

I urge the committee to issue a Do Not Pass recommendation for this resolution. Thank you for your time and consideration.

I am writing to express my opposition to SCR 4013. First of all, the Electoral College was useful when we were still a much simpler, smaller country of only 13 states all with substantial rural populations. We now cover much of an entire continent with 50 states, including noncontiguous Alaska and Hawaii, and we are a much more complex, integrated, and denser populated nation. In some cases, more than half the population of a state can be found in its cities. This means that the 2nd "Whereas" of the Resolution is incorrect. The Electoral College now is causing an extreme representation imbalance between urban and rural areas. I would argue that the first "Whereas" is also incorrect: The Electoral College does not just "respect states as the essential units in our federal republic" but it actually has been seen to place the states' power above that of the federal republic. This is destructive not just to individuals' civil rights which are supposed to be guaranteed by portions of the Bill of Rights and other Amendments but also to the financial and social integration of the United States of America. Degrading or eliminating the concept of Interstate Commerce is not a step forward in my opinion. As to the other major subject of the SCR that opposes the National Popular Vote Compact, I disagree with the assertion that it "opens the door to greater federal control of elections." In fact, it is based on two clear powers given to the states under the Constitution: the power under Article 2 Section 1 to choose how to allocate its presidential electors, and the power under Article 1 Section 10 to enter into interstate compacts. Therefore, it supports rather than degrades states' powers. Because of all of this, I hope you will also oppose SCR 4013. Thank you.

SCR 4013 invites other states to join North Dakota in forming an interstate compact to oppose the National Popular Vote Interstate Compact (NPVIC). The NPVIC is an attempt to nullify the Electoral College via an indirect method instead of using the required amendment procedures laid out in the Constitution.

As stated in the resolution North Dakota proposes an interstate compact wherein the member states agree to challenge the NPVIC should it ever become active. The NPVIC would become active when the NPVIC member states encompass 270 Electoral College votes. The NPVIC currently has 209 Electoral College votes among the member states.

This resolution specifies that the proposed opposition compact would become active when four other states join North Dakota and agree to pursue a legal claim challenging the constitutionality of the NVPIC.<sup>1</sup> If the NPVIC never goes active there would be no legal challenge, and no action would be required by the member states of this opposition compact.

The purpose of this opposition compact would, in part, be to deter any additional states from joining the NPVIC knowing that multiple states have taken action to oppose them in a legal action that the NPVIC compact is likely to lose. It might also cause current member states to withdraw from the NPVIC, which is an option available to them under the terms of their compact.

The Electoral College is an important institution that ensures successful presidential candidates gain support from numerous geographic regions of the United States rather than focusing solely on the most heavily populated cities and coastal areas. As a result, the Electoral College tends to encourage more moderate candidates with broader voter appeal while simultaneously amplifying popular vote totals to produce a clear winner.

As Alexander Hamiliton wrote of the Electoral College in Federalist 68, "If the manner of it be not perfect, it is at least excellent."
