¹North Dakota Century Code Chapter 54-27.2 provides that any amount in the General Fund at the end of a biennium in excess of \$65 million must be transferred to the Budget Stabilization Fund except that the balance in the Budget Stabilization Fund may not exceed 15 percent of the General Fund budget approved by the most recently adjourned Legislative Assembly. As a result, the statutory limit for the Budget Stabilization Fund increases by an amount equal to 15 percent of any General Fund appropriations approved during the 2026 special session.
