

STATE AID DISTRIBUTION PERCENTAGES

This memorandum provides information on the state aid distribution fund formula for distribution of a portion of sales, use, and motor vehicle excise tax collections to counties and cities.

North Dakota Century Code Section 57-39.2-26.1 provides that a portion of sales, use, and motor vehicle excise tax collections equal to 40 percent of an equivalent one-cent sales tax be deposited in the state aid distribution fund and distributed 53.7 percent to counties and 46.3 percent to cities. The allocation formula for specific counties and cities is:
