

## HIGHER EDUCATION FUNDING

This memorandum provides information regarding general fund support for higher education in North Dakota and other selected states.

### STATE GENERAL FUND SUPPORT FOR HIGHER EDUCATION

The table below details funding provided for higher education from the general fund of selected states, including a percentage comparison to each state's total general fund budget.
