

# SALARY AND OTHER REIMBURSEMENT LEGISLATORS RECEIVE UNDER THE PROVISIONS OF LAW - IN EFFECT AS OF JULY 1, 2026

Reimbursement for lodging expenses (NDCC § 54-03-20)  
 Actual expenses not to exceed the estimated GSA rate (**\$110.00 as of 10/1/26**) per day plus any additional applicable state or local taxes in state, subject to the maximum monthly session reimbursement of \$2,475 per month (30 times 75 percent of the estimated daily lodging rate of \$110.00 as determined by OMB as of 8/1/26).

Mileage - GSA rate as determined by OMB (72.5 cents per mile as of 1/1/26) per mile for one round trip each calendar week going to and from the meeting of the Legislative Assembly during a regular session and one trip going to and from the organizational session. If travel is by common carrier, reimbursement may not exceed the cost of coach fare and may not exceed one and one-half times reimbursement for travel by motor vehicle.

**NOTE:** Legislators who live in districts outside Bismarck are allowed daily round trip mileage reimbursement of the GSA rate as determined by OMB (72.5 cents per mile as of 1/1/26) or lodging reimbursement of up to a maximum of GSA rate as determined by OMB (\$110.00 per night) plus any additional applicable state or local taxes on lodging when mileage is not claimed up to the estimated maximum monthly reimbursement of \$2,475. (NDCC §§ 54-03-20 and 54-06-09).

Lodging - Actual expenses not to exceed the GSA rate (**\$110.00 as of 10/1/26**) per day plus any additional applicable state or local taxes in state; actual expenses out of state (NDCC § 44-08-04).

Mileage - GSA rate as determined by OMB (72.5 cents per mile as of 1/1/26); 18 cents per mile by motor vehicle 300 miles beyond state border; and one and one-half times actual air mileage at the GSA rate (\$1.09 as of 1/1/26) by private airplane (NDCC § 54-06-09).
