NOTICE OF INTENT TO AMEND  
ADMINISTRATIVE RULES RELATING TO  
N.D. ADMIN. CODE CHAPTER 33-44-01  
MEDICAL MARIJUANA

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 33-44-01 at 1:00 p.m. on Thursday, June 12, 2025, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 33-44-01, Medical Marijuana, are necessary to implement 2025 House Bill No. 1203 and Senate Bill No. 2294 pertaining to cannabinoid edible products, nonresident qualifying patient qualifications, and application fees.

The proposed changes are as follows:

**Section 33-44-01-03.2** is amended to modify the resident qualifying patient application fee from twenty-five dollars to forty dollars and to include an application fee amount of forty dollars for nonresident qualifying patient applications.

**Section 33-44-01-03.3** is amended to provide a fee waiver for the first time a registry identification card is lost and to eliminate the fee for a replacement card due to a name change.

**Section 33-44-01-20** is amended to eliminate requirements regarding who is to conduct inventories at manufacturing facilities and dispensaries.

**Section 33-44-01-23** is amended to prohibit marketing to a minor.

**Section 33-44-01-24.1** is amended to add requirements related to ingredients used in products intended for ingestion.

**Section 33-44-01-24.2** is created to establish manufacturing facility requirements related to a cannabinoid edible product.

**Section 33-44-01-25** is amended to include requirements related to packaging of usable marijuana.

**Section 33-44-01-51** is amended to modify concentration homogeneity testing requirements due to the addition of a cannabinoid edible product.

**Section 33-44-01-55** is amended to modify requirements related to reserve samples.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
