NOTICE OF INTENT TO CREATE ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTER 33-03-38 COMMUNITY HEALTH WORKERS

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed creation of N.D. Admin. Code chapter 33-03-38 at 9:30 a.m. on Tuesday, June 17, 2025, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed creation of N.D. Admin. Code chapter 33-03-38, Community Health Workers, is made at the request of the Department of Health and Human Services and the Community Health Worker Task Force pursuant to 2023 House Bill No. 1028 pertaining to the regulation of community health workers and the work of the community health worker task force.

The proposed changes are as follows:

Section 33-03-38-01 is created to define terms related community health workers.

Section 33-03-38-02 is created to describe the scope of practice of community health workers.

Section 33-03-38-03 is created to represent the required competencies.

Section 33-03-38-04 is created to outline the requirements for community health worker certification.

Section 33-03-38-05 is created to identify the qualifications of an individual supervising a student or intern community health worker.

Section 33-03-38-06 is created to provide community health worker certification by reciprocity.

Section 33-03-38-07 is created to outline the recertification process for community health workers.

Section 33-03-38-08 is created to identify conditions for denial of community health worker certification or recertification.

Section 33-03-38-09 is created to describe the conditions and process of community health worker discipline.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
