NOTICE OF INTENT TO CREATE ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTER 75-03-23.2 COMMUNITY TRANSITION AND DIVERSION PROGRAM

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address the proposed creation of N.D. Admin. Code chapter 75-03-23.2 at 10:30 a.m. on Monday, September 15, 2025, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed creation of N.D. Admin. Code chapter 75-03-23.2, Community Transition and Diversion Program, is necessary to comply with the provisions of 2025 House Bill No. 1012. The proposed creation is as follows:

Section 75-03-23.2-01 is created to provide definitions for "community residence", "diversion", "most integrated setting", provider-operated residential facilities", "significant disability", and "community transition".

Section 75-03-23.2-02 is created to outline the eligibility criteria for participation in the community transition program, including current and planned residence, application, qualification for other programs, and past participation in the program.

Section 75-03-23.2-03 is created to outline the eligibility criteria for participation in the diversion program, including other program participation, risk of placement in a provider-operated residential facility, and application requirements.

Section 75-03-23.2-04 is created to outline the services covered under the community transition and diversion program, including transitioning from a provider-operated living facility to a community residence and preventing placement in a provider operated living facility.

Section 75-03-23.2-05 is created to outline the expenses the department is permitted to pay as part of the community transition or diversion program.

LEGAL

Section 75-03-23.2-06 is created to provide for an appeal process when there is a denial, termination, or reduction of benefits for a community transition or diversion program.

The proposed rule is anticipated to have a positive impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.

Copies of the proposed rules are available for review at human service zones and at human service centers/state-operated behavioral health clinics.
