## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTERS 75-02-02 AND 75-02-02.1 MEDICAL SERVICES AND ELIGIBILITY FOR MEDICAID

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapters 75-02-02 and 75-02-02.1 at 9:00 a.m. on Tuesday, September 16, 2025, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapters 75-02-02 and 75-02-02.1, Medical Services and Eligibility for Medicaid, are necessary to incorporate updates pursuant to 2025 Senate Bill No. 2076 and 2025 House Bill Nos. 1067 and 1485. The proposed changes are as follows:

**Section 75-02-02-27** is amended to implement 2025 Senate Bill No. 2076, regarding annual certification of the medical necessity for each medication in the medication regiment that contains five or more concurrent prescriptions for certain medications and prior authorizations.

**Section 75-02-02.1-01** is amended to amend Medicaid eligibility definitions for "blind", "children's health insurance program", "disabled", "good-faith effort to sell", "regulation", "supplemental security income", and to add definitions for "individual on conditional release", "inmate", "institution", "institution for mental diseases", "public institution", and "unconditionally released" that had previously been located elsewhere in the chapter .

**Section 75-02-02.1-03** is amended to clarify application processing timeframes.

**Section 75-02-02.1-11** is amended to clarify need and utilization for Medically Needy members.

**Section 75-02-02.1-19** is amended to remove definitions relating to inmates of public institutions as they have been relocated to section 75-02-02.1-01 for clarity, to clarify the rules regarding inmates of public institutions, and to remove language regarding institutions for mental diseases due to the fact that a new

section is created at section 75-02-02.1-19.2 to address institutions for mental diseases.

**Section 75-02-02.1-19.2** is created to provide standards for institutions for mental diseases, since the language that had previously implemented those standards was removed from section 75-02-02.1-19. The section establishes eligibility requirements for federal financial participation for institutions for mental diseases.

**Subsection 1 of Section 75-02-02.1-24** is amended to update the definition of "monthly maintenance needs allowance" to reflect that the minimum amount used is what is federally mandated.

**Section 75-02-02.1-38.2** is amended to update the disregarded income for non-MAGI individuals based on the Department's current practice. The section also reflects changes approved by 2025 House Bill No. 1067 that become effective July 1, 2026, which treat as disregarded income Social Security Survivor Benefits and child support for children under age eighteen years and enrolled in a Medicaid waiver under section 1915(c) of the Social Security Act.

**Section 75-02-02.1-38.3** is amended to update the disregarded income for MAGI individuals based on the Department's current practices.

**Section 75-02-02.1-40** is amended to update the ineligible community spouse income level to reflect that the minimum amount used is what is federally mandated, and to increase income level for personal needs based on 2025 House Bill No. 1485.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
