TAKE NOTICE that the North Dakota Department of Public Instruction (NDDPI) will hold a public hearing to address proposed changes of N.D. Admin. Code 67-19, Accreditation: Procedures, Standards, and Criteria; and 67-23, Special Education; at 9:30 AM on Thursday, May 22, 2025, in the Peace Garden Room at the State Capitol, 600 E. Boulevard Ave., Bismarck, ND 58505.

The purpose of the proposed changes is to amend 67-19-01, Accreditation: Procedures, Standards, and Criteria, to implement changes made to NDCC 15.1-02-11 by SB 2362 of the 69th Legislative Assembly; and to amend 67-23-01, Comprehensive General Plan Requirements for Special Education Programs, to align with changes made to NDCC 15.1-32-01 by HB 1164 of the 69th Legislative Assembly. The proposed rules are not expected to have an impact on the regulated community in excess of \$50,000.
