

FULL NOTICE OF INTENT TO ADOPT, AMEND, AND REPEAL ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Department of Water Resources will hold two public hearings to address proposed amendments to N.D. Admin. Code chapters 89-01-01 (Organization of Water Commission and Department of Water Resources), 89-03-01 (Water Permits), 89-03-02 (Water Permit Modification), 89-07-02 (Weather Modification Operations), 89-10-01 (State Sovereign Lands), 89-11-01 (Drought Disaster Livestock Water Assistance Program), 89-15-01 (Watercourse Determination Review), and article 90 (Board of Water Well Contractors) and proposed repealing of N.D. Admin. Code chapter 90-01-01 (Board Organization).

The purpose of the proposed rulemaking is to implement SB 2044, SB 2141, SB 2308, and HB 1040, enacted during the most recent legislative session concerning watercourse determinations by the Department; the change in the purpose of use of a conditional or perfected water permit; duties transitioned to the Department from the Atmospheric Resources Board and the State Board of Water Well Contractors; and the Drought Disaster Livestock Water Assistance Program. Additional changes are proposed to clarify existing code provisions and update the fee structure for sovereign lands violations.

The hearings will be held at 9 am on Thursday, August 28, 2025, at 225 4th Street N., Fargo, ND 58102, and at 1 pm on Tuesday, September 2, 2025, at 1200 Memorial Highway, Bismarck, ND 58504. The hearings will also be available to be streamed online. The links for virtual attendance are available at dwr.nd.gov.

The proposed rulemaking is not expected to have an impact on the regulated community in excess of \$50,000.
