The Notice of Intent to Amend/Repeal Administrative Rules and a copy of the proposed rules related to Article 10-16 (Multi-State Lottery) of the N.D.A.C. are enclosed as required by N.D.C.C. § 28-32-10(1).

The proposed amendments with an effective date of September 28, 2025 are emergency rules that are required in support of our system conversion that is being implemented on September 28, 2025. N.D.C.C. § 53-12.1-13 allows the North Dakota Lottery to adopt emergency rules as necessary without the grounds otherwise required under N.D.C.C. § 28-32-03.

The proposed amendments with an effective date of January 1, 2026 are miscellaneous rule changes that adopt clarifying language in support of the general updating of rules as things change.

The proposed amendments/repeals with an effective date of February 22, 2026 are miscellaneous rule changes that support the repeal of the Lucky for Life® game and the addition of the Millionaire for Life game and other general updating of rules.

FULL NOTICE OF INTENT TO  
ADOPT/AMEND/REPEAL ADMINISTRATIVE RULES

TAKE NOTICE that the Office of Attorney General will hold a public hearing to address proposed amendments/repeals to N.D. Admin. Code article 10-16 related to the multi-state lottery at 10:00 a.m. on Wednesday, September 17, 2025, at the North Dakota Lottery Office, 1720 Burlington Drive - Suite C, in Bismarck.

The proposed amendments declared as emergency rules with an effective date of September 28, 2025, are as follows:

**Section 10-16-01-01** is amended to update definitions.

**Section 10-16-02-06** is amended to adopt clarifying language throughout in support of the system conversion, remove language requiring retailer to post winning numbers and estimated grand prizes, and remove language requiring the retailer to have a copy of the lottery law and rules on site, near the terminal.

**Section 10-16-02-07** is amended to remove language requiring a five percent sales commission of the amount of an online play that is transacted through the North Dakota Lottery Players Club®, repeal of the Lucky for Life® game, and adopt game rules and establish retailer bonuses for the Millionaire for Life game.

**Section 10-16-03-05** is amended to adopt clarifying language in support of the system conversion.

**Section 10-16-03-07** is amended to meet Multi-State Lottery Association requirement to pass a confidential security check of a winning ticket of fifty thousand dollars or more.

**Section 10-16-03-08.1** is amended to update terminology, adopt clarifying language in support of the system conversion, allowing a player to purchase an iLottery play for up to 28 days, and clarifying that an iLottery play winner of \$600 or greater must claim the prize within 180 days of the draw date.

**Section 10-16-08-05** is amended to meet the change for the removal of the random multiplier required by the system conversion.

**Section 10-16-09-02** is amended to adopt clarifying language in support of the system conversion, provide clarifying language regarding exchange tickets, and increase the amount of points a player can earn per week.

**Section 10-16-09-03** is amended to update change to business name for Scientific Games LLC and add the achievement reward program.

**Section 10-16-10-01** is amended to update change to business name for Scientific Games LLC and add the achievement reward program.

The proposed amendments with an effective date of January 1, 2026, are as follows:

**Chapter 10-16-01** is amended to remove language related to offset and adopt with language related to setoff.

**Section 10-16-01-05** is amended to remove language referencing gift certificates as the Lottery no longer sells them, and update terminology.

**Section 10-16-02-01** is amended to remove language related to the notification of retailer applicant when applicant is denied.

**Section 10-16-02-02** is amended to remove language related to the type and volume of state government services available at a business as criteria for selecting an applicant.

**Section 10-16-03-02** is amended to update terminology.

**Section 10-16-03-08** is amended to update terminology.

**Section 10-16-03-10** is amended to remove language referencing gift certificates as the Lottery no longer sells them.

**Section 10-16-04-01** is amended to capitalize Powerball.

**Section 10-16-04-06** is amended to capitalize Power Play.

**Section 10-16-09-01** is amended to update change to business name for Scientific Games LLC.

**Section 10-16-09-06** is amended to remove language referencing the website URL store.lottery.nd.gov which is no longer valid and replacing with the North Dakota Lottery Players Club® website.

**Section 10-16-09-08** is amended to update change to business name for Scientific Games LLC.

**Section 10-16-10-02** is amended to remove language related to Points for Prizes® program to provide clarification.

**Section 10-16-10-04** is amended to update change to business name for Scientific Games LLC., and update terminology.

The proposed amendments/repeals with an effective date of February 22, 2026, are as follows:

**Article 10-16** is amended to repeal the Lucky for Life® game (Chapter 10-16-11) and adopt the Millionaire for Life game (Chapter 10-16-13).

**Section 10-16-03-01** is amended to remove language related to the repeal of the Lucky for Life® game and adopt language related to the Millionaire for Life game.

**Section 10-16-03-08** is amended to add language related to the Millionaire for Life game.

**Section 10-16-03-08.1** is amended to change the purchase time required to be considered for a draw and add the Millionaire for Life game.

The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.
