## ***FULL NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES***

TAKE NOTICE that the North Dakota Real Estate Appraiser Qualifications and Ethics Board will hold a public hearing to address proposed amendments to N.D. Admin. Code Title 101, at 8:00 Central a.m. on September 23, 2026, State Capitol, 600 East Boulevard Avenue, Bismarck, ND 58505-0040 in the Fort Union Room.

The purpose of the proposed amendments is to comply with federal standards. They address changes to renewal application deadlines and fees, and education approval fees, incorporate by reference the Real Property Appraiser Qualifications Criteria and Interpretations of the Criteria, and update the effective dates of those Criteria as issued by the Appraiser Qualifications Board of the Appraisal Foundation and of the Uniform Standards of Professional Appraisal Practice issued by the Appraisal Standards Board of the Appraisal Foundation.

The proposed amendments are expected to have an impact on the regulated community in excess of \$50,000.
